



## **Family Violence Unit Deputy District Attorney / Senior Deputy District Attorney (depending upon experience)**

The mission of the Denver District Attorney's office is to prosecute crimes professionally and competently, investigate criminal behavior on behalf of the people of the State of Colorado and seek equal justice for all in the criminal justice system. Our mission includes the prevention and deterrence of crimes, support of the well-being of victims, participation in the community, commitment to transparency and accountability and reform of the criminal justice system to provide fair alternatives to incarceration in appropriate cases as well as fair and equal justice for all.

The office employs approximately 100 attorneys and 150 support staff, who are responsible for more than 5,000 felony and 7,000 misdemeanor prosecutions annually.

The Denver District Attorney's Office is looking for an experienced prosecutor to join the Family Violence Unit prosecuting felony domestic violence cases and crimes against children in the City and County of Denver. Duties include:

Assisting victims of crime through the criminal justice system.

Maintaining a felony caseload, including making appropriate plea offers, litigating motions and preparing cases for trial.

Conducting jury trials on complex felony cases including homicides, burglaries, aggravated assaults, sexual assaults, sexual assaults against children and child physical abuse.

Partnering with and mentoring less experienced deputies on cases.

Working collaboratively with Senior DV Specialist at Rose Amond Center, a multi-agency family justice center serving victims of domestic violence.

Working collaboratively with partners at Platte Street, a multi-agency center serving child victims of sexual assault and physical abuse.

Partnering with members of Denver Police Department and other community agencies.

Periodically serving on call to provide legal advice to Denver Police Department's homicide unit.

Performing other duties as assigned or requested by the Assistant District Attorneys and District Attorney.

### **Qualifications:**

Must possess a law degree from accredited law school

Admission by the Supreme Court of Colorado to practice law (or licensure in progress)

Experience managing a felony caseload and trying felony cases involving DV, crimes against

children and/or sexual assault
