



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT  
AND THE ARREST WARRANT FOR THE PERSON OF:**

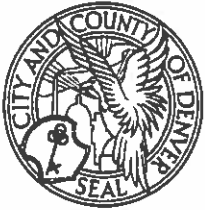
Robert Earl Hawkins, Date of birth 09/05/1979, DPD# 524817, Colorado SID# 906524, FBI# 682457CB7, a black male, approximately five foot ten inches tall, weighing approximately 190 pounds, with black hair possibly shaved head and brown eyes, for: 18-4-302 Aggravated Robbery, Class 3 Felony, 18-3-202 Assault in the First Degree, Class 3 Felony

I, Detective, Jeff M. Baran Badge #93010, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person, are the following:

Your Affiant informs the court that on 01/09/2019 at approximately 0120 hours in the 1500 block of North Xanthia Street located in the city and county of Denver, Colorado the Victim was shot in the leg and robbed by an unknown black male.

On 01/10/2019 Your Affiant was assigned this case for investigation. Your Affiant interviewed the Victim [REDACTED] who stated on 01/09/2019 he picked up a female (escort/prostitute) in the area of where he was shot, (1500 block North Xanthia Street) and took her to his home. Once there he agreed to pay the female for sex (\$40.00). [REDACTED] stated that it was not going well during the sexual act, and the female was even on her phone talking with someone during the sexual encounter. [REDACTED] stated that he did use a condom and that he put it in the kitchen trash can before taking the female back to where he picked her up as they drove back the Female was again on her phone but [REDACTED] could not tell what she was saying. When [REDACTED] got to the 1500 block of Xanthia Street he pulled over facing Colfax Avenue and told the female to get out of the vehicle, but she would not get out. The female stated she would not get out until her ride got there. [REDACTED] saw a vehicle pull behind him and the female then opened the door as she got out of the vehicle a black male dressed in all black got in his vehicle and told [REDACTED] to give him all his money. [REDACTED] told the male to get out of the vehicle. The male pulled out a handgun and again told [REDACTED] to give him all his stuff. [REDACTED] took out his bb gun and told the male to get out of his car. The Male stated, "You don't want me to shoot you". [REDACTED] stated that he started fighting with the male and the male stated that he would shoot [REDACTED] and fired the gun one time. [REDACTED] stated that he continued to fight with the male and then was shot in the leg, so he gave the male his money (Approximately \$150.00). The male then got out of the vehicle and went to a maroon or red vehicle that contained other, unidentified parties and the vehicle drove away.

[REDACTED] stated that he drove away Northbound and called 911. Your Affiant asked [REDACTED] if the female saw all his money when he paid her the forty dollars. [REDACTED] stated, "Yes she did", and that is why he believed she set him up to be robbed. Your Affiant asked [REDACTED] if he believed the condom was still in his apartment. [REDACTED] stated that he was the only person that lived there and yes it would be on top of the kitchen trash can. Your Affiant asked for permission to go to the apartment and recover any possible evidence. [REDACTED] told your Affiant that was okay.

On 01/16/2019 your Affiant responded to the Denver Sheriff's impound lot and completed a search of Mr. Drewitt's vehicle with Denver Police Crime Lab Technician Skye McGlawn. Recovered from the vehicle was a bb gun magazine, and a watch, which were taken by Technician McGlawn and placed into the Denver Police Department Property Bureau.

On 01/17/2019 your Affiant responded to [REDACTED] Denver, Colorado. Once inside the location your Affiant found a used condom on the top of the trash can in the kitchen. Your Affiant recovered the condom as evidence along with the bedding from the bedroom. Your Affiant transported these items to the Denver Police Department Property Bureau and placed them in under invoice number 1025458-1&2. Your Affiant then requested DNA analysis be done on the condom. Your Affiant later received the CODIS hit results for item 1025458-1 (The recovered condom from [REDACTED] apartment).

### RESULTS:

1. The DNA profile from the inside surface of the condom epithelial fraction (1025458-1-2) resulted in a CODIS hit to Colorado offender [REDACTED]. The CODIS hit was a match at 13 or more genetic loci.
2. The information in this report is provided only as an investigative lead and any possible connection or involvement of the individual(s) listed must be determined through further investigation. It is required that you obtain an additional DNA sample(s) from the subject(s) for testing and comparison to the forensic unknown profile(s) and completion of a final DNA report.
3. Additional information is contained in the previous forensic biology and DNA reports for the DPD case(s).

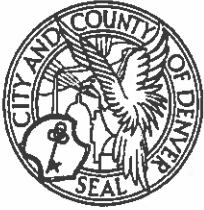

Your Affiant informs the court that this case was discussed with Denver Chief Deputy District Attorney Victoria Sharp on 05/21/2021 and she told your Affiant this case would be filed by her office for charges on 18-4-302 Aggravated Robbery, Class three felony for the suspect [REDACTED].

On 05/21/2021 Your Affiant authored and received the approved arrest warrant for [REDACTED] date of birth 10/04/1997. On 05/27/2021 [REDACTED] was arrested by members of the Denver Police Department's Fugitive Unit. [REDACTED] was transported to the District Two Station by your Affiant and interviewed with Detective Kevin Beasley present. Your Affiant advised [REDACTED] of her rights per Miranda which she stated she understood and then agreed to speak with us.

[REDACTED] told us that she did remember getting picked up off Colfax Ave and going to a man's apartment. She stated that she was asking the man to help her and that she does not really do this. Once at the apartment [REDACTED] stated that the male [REDACTED] wanted to have sex but she did not want to she stated

that she just wanted help out of her situation. She stated that she was being forced by a man she knows as "Miget" to turn tricks. She stated that she was on her phone texting other tricks (Street slang for people that pay for sex), she also said that she did not take any money from the man she just wanted help, but when she did not want to have sex the male pulled a gun on her. She stated she did not know if it was real but was scared so she gave the male a condom. [REDACTED] told us that she did not remember the male penetrating her. I asked her how her DNA would have gotten on the condom I found at the apartment. She stated her memory is not the best so he might have but she did not remember. She stated after a short time the male got upset and left the room, when he came back, he told her he would take her back. [REDACTED] stated that she did not make calls while in the car going back but that "Miget" hung out by the food truck in the parking lot where she was dropped off. I asked again if she was paid and that the male said he paid her \$40. She stated that she did not take his money, but she could have taken it all, she just wanted help. When the male parked at the curb, she started to plead with him to help her and that is why she did not want to get out of the car. I asked who the male was that got into the man's car when she got out. [REDACTED] stated she only knows him as "Miget", and that he is the man that was forcing her to turn tricks. [REDACTED] told us that she did not know "Miget" had a gun or had taken anything from the Black male. She was asked if she heard any gun shots and she stated that she may have but the it was Colfax and there were always gun shots. I asked [REDACTED] if "Miget" told her anything about what happened when he got in the car with the male. She stated that they argued but she did not know "Miget" shot him or even had a gun.

Detective Beasley checked Denver Police records and found a party that has used the name Miget in the past. This party's name is Robert Earl Hawkins Date of birth 09/05/1979, DPD# 524817. His picture link photo was printed out Photo# 11057912. I asked [REDACTED] during the interview how long she had been with "Miget" and she stated over six months. I then showed her the photo of Hawkins with all the identifying information folded over. [REDACTED] told me that the person in the photo was the person she knows as "Miget" and that he was the person that got into the man's car after she got out. I asked [REDACTED] if she was willing to testify in court and she stated she would and that "Miget" had beaten her and made her turn tricks. She stated that she tried to get away from him but that she couldn't for a long time. I had [REDACTED] signed the photo and wrote the name she knows the person to be.

On 06/01/2021 Your Affiant was able to contact [REDACTED] (The Victim) and arranged for him to come to the District Two Station to view a photo array. Your Affiant then build the array consisting of six photos using the Denver Police picture link system. The suspect Robert Earl Hawkins Date of birth 09/05/1979, DPD# 524817, picture link photo # 11008233 was placed in spot #2.

Your Affiant asked Detective William Bohm badge# 13070 to show the array to [REDACTED] Detective Bohm told your Affiant that he read [REDACTED] the photographic lineup admonition form which [REDACTED] stated he understood and signed. Detective Bohm showed [REDACTED] the photos

one at a time when Detective Bohm finished [REDACTED] stated that #2 looks similar to the person who he believes may have been the shooter.

This assault happened over two years ago and the picture used in this array was taken on 09/25/2018 three months before the assault.
