I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 04/05/2019 at 8:33 pm at or near the location of 15TH ST / BLAKE ST in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:
[On 04-05-19 at approximately 2033hrs, a red Toyota truck bearing Colorado license plate #BRI869 and being driven by Jerek Fabjancic (020890) was traveling SB on Blake St and ran the red light at 15th St, striking a pedestrian who was legally in the north crosswalk of the intersection. This vehicle fled the scene SB Blake St without stopping to check on injuries, exchange required information, or notify authorities of the collision. The pedestrian, was pronounced deceased at DHMC.

Detective Grein contacted the defendant, Fabjancic, who admitted to driving the suspect vehicle at the time of the collision.

On 04-06-2019 at approximately 0945 hours, the defendant was taken into custody by Denver Police at 13525 W. 21st Pl. in Golden, Colorado after being detained by members of the Jefferson County Sheriff's Department. The defendant was positively identified by his photo Colorado Driver License ([REDACTED]).
