



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

Dawaune I. Ellis dob: 01/23/1994, black male, 5'6, 135 lbs, DPD #793443, black hair, brown eyes, for 18-3-102 First Degree Murder a Class One Felony.

I, Detective Bruce Gibbs 95047, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

On April 5, 2018 at approximately 9:34 p.m. members of the Denver Police Department responded to 5000 North Beeler Street, Sysco of Denver a food distribution warehouse on a report of a male stabbed in the neck. This location is in the City and County of Denver, State of Colorado. Upon arrival officers located the victim who was identified as Mr. Anthony Miles-Hollis dob: 07/02/1989 who had sustained multiple stab wounds. The victim was transported to Denver Health Medical Center and was pronounced deceased at 10:13 p.m. by Doctor Adler. Officers secured the scene and numerous witnesses were interview.

During the course of the interviews your affiant conducted a videotaped interview with Mr. [REDACTED] dob: [REDACTED] 1987 at Denver Police Department Headquarters. Mr. [REDACTED] related to your affiant that while working as a [REDACTED] he was walking downstairs from the upstairs offices. He said that as he approached the downstairs offices he saw an employee that he identified as Mr. Anthony Miles-Hollis standing at a cubicle. He related that Mr. Miles-Hollis as wearing a brown hoodie. He related that at about 50 feet away he sees Mr. Ellis come up behind Mr. Miles-Hollis and start striking him from behind. Mr. [REDACTED] related that he observes at least two strikes to the neck and three towards the body. Mr. [REDACTED] relates that he goes to Mr. Miles-Hollis and observes blood exiting the neck and wounds to the body. Mr. [REDACTED] observed that Mr. Ellis flees. Mr. [REDACTED] calls 911.

Your affiant presented that a photographic array to Mr. [REDACTED]. The array contained six photographs with a photograph of Mr. Ellis in the number five position. Upon review of the array Mr. [REDACTED] positively identified the photograph of Mr. Ellis in the number five position as the person he observed attacking Mr. Miles-Hollis.

Detective Jon Joyce 04081 conducted interviews with employees Mr. [REDACTED] dob: [REDACTED] 1985 and Mr. [REDACTED] dob: [REDACTED] 1979. Both of them related that prior to the stabbing Mr. Miles-Hollis related to them that Mr. Ellis had punched him in the face and that they observed blood coming from the nose of Mr. Miles Hollis. Employee Ms. [REDACTED] dob: [REDACTED] 1995 related to Detective Joyce that just prior to the stabbing she observed Mr. Ellis retrieve a knife from his waist area and lunged towards Mr. Miles-Hollis.

Your affiant was contacted by Detective Eric Bueno 00037 who was at the scene of the incident. Detective Bueno related to your affiant that another employee who was identified as Mr. [REDACTED] dob: [REDACTED] 1981 had related in his statement that prior to the stabbing he had observed the suspect punching and coking the victim just prior to the stabbing also.

Based upon the aforementioned information your affiant respectfully request that an Arrest Warrant be issued for Dawaune Eliis dob: 01/23/1994.
