



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

Bustaman Kartabrata, 08/05/1959, White Male, 5'7", 195 lbs, brown eyes, black hair, who resides at 4359 Andes Street, Denver CO 80249.

I, Detective Jami Sisneros, 00073, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person(s), are the following:

On May 23, 2019 at approximately 9:33 p.m. the Denver Combined Communications Center received a 911 call from [REDACTED] Avenue, Building [REDACTED]. The reporting party stated an 8 year old boy told him his mom, dad and sister have been shot. Officers responded and learned the address of the 8 year old boy and the address of the shooting was [REDACTED] in the City and County of Denver. Officers went to the house and located three victims with multiple gunshot wounds. Denver Paramedics and Denver Fire EMS responded and an adult female in the house was pronounced dead at the scene. Two other victims were transported to hospitals where they were later pronounced dead. The Denver Police Homicide Unit was notified.

Your Affiant, Detective Jami Sisneros 00073 and Detective John Meoni 94005 were assigned the case. Detective Meoni went to the scene and learned that the family living at [REDACTED] had recently sold their home and were packing up belongings. An unknown suspect entered the home and began shooting. An 8 year old boy managed to run out of the house and ran to [REDACTED] where the 911 call was made. The 8 year old boy told officers about the shooting at his house at [REDACTED] and officers went to the house. When officers entered the home, they found an adult female in the front living room who had been shot several times. EMS responded and the adult female was pronounced dead at the scene 10:02 pm by Denver Health Medical Center (DHMC) Doctor Shy.

An adult male was in the house with multiple gunshot wounds and was transported to Swedish Medical Center where he was pronounced dead at 10:11 pm by Doctor Scott. An 11 year old female was found in an upstairs bedroom who had also been shot multiple times. She was transported to the DHMC where she was pronounced dead at 10:02 pm by Doctor Platnic.

The boy, later identified as [REDACTED] [REDACTED]/2009 was transported to Denver Police Headquarters for a Forensic Interview.

AFFIDAVIT AND APPLICATION FOR ARREST WARRANT

On May 24, 2019 at approximately 1:15 a.m., Forensic Interviewer, Dulce Solis interviewed [REDACTED] [REDACTED] 2009. [REDACTED] lives at [REDACTED] with his parents, sister [REDACTED] and his grandma, (later identified as [REDACTED]). [REDACTED] stated that his grandma [REDACTED] (his dad's mom) is married to a man named Bustaman. [REDACTED] stated that Bustaman came to their house earlier today but his parents weren't home so he left. [REDACTED] stated that Bustaman came back later with his grandma [REDACTED] and this time his parents were at home so they came in. [REDACTED] stated that his parents, Bustaman and his grandma [REDACTED] were sitting in the living room talking. He stated that he was by the fireplace and his sister and grandma were in their rooms. [REDACTED] stated that his dad was telling Bustaman that they were going to sell the house and stay in a hotel. [REDACTED] stated that when they were done talking, Bustaman and his grandma [REDACTED] left the house but were sitting in their car outside. [REDACTED] stated that he and his family continued to pack his dad's jeep. When they were finished, they went inside the house and locked the door. [REDACTED] stated that Bustaman knocked at the door and his mom asked what he needed and he said that grandma [REDACTED] left her purse inside the house. [REDACTED] stated that he told Bustaman "let's look for it" and then Bustaman pulled out a gun and started shooting. [REDACTED] stated that Bustaman shot his dad first, then his mom, and then chased his sister upstairs. [REDACTED] stated that he ran out of the house through the kitchen door and his grandma [REDACTED] jumped off the roof. [REDACTED] stated that when he ran away, he saw his grandma [REDACTED] sitting in the car. [REDACTED] described the car as light blue in color. [REDACTED] stated that he ran to some apartments and knocked on the door and asked them to call 911.

Detective Jami Sisneros, 00073 showed [REDACTED] a single photo of Bustaman Kartabrata, dob: 08/05/1959 and he positively identified him as "Bustaman" the person who tried to shoot him and shot his family.

Based on the above stated information your Affiant respectfully requests that this probable cause arrest warrant be approved for the charge of 3 counts of C.R.S., 18-3-102 (1)(a), First Degree Murder (Class 1 Felony) and 1 count of C.R.S., 18-3-206, Felony Menacing (1)(a) (Class 5 Felony) for the suspect identified as Bustaman Kartabrata.

Further, pursuant to Rule 41 of the Colorado Revised Statutes, your Affiant is respectfully requesting the approval to have this Affidavit sealed from public release of the information herein contained. Your Affiant is also respectfully requesting the approval to have this Affidavit sealed from public release of the information herein contained due to media coverage of this case, to assure that this case is not compromised, and/or so that witnesses mentioned in this warrant can be protected from any type of early reprisals, so that this investigation can continue.


