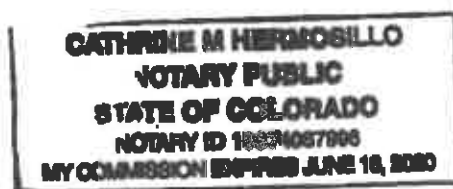

COUNT ONE

HUMAN TRAFFICKING OF A MINOR FOR SEXUAL SERVITUDE, C.R.S. 18-3-504(2) (F2) <03085>

Between and including June 1, 2016 and October 30, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, knowingly and feloniously sold, recruited, harbored, transported, transferred, isolated, enticed, provided, received, obtained by any means, maintained, or made available a minor, namely "A.S.", for the purpose of commercial sexual activity; in violation of section 18-3-504(2), C.R.S.

COUNT TWO

DISTRIBUTION OF A CONTROLLED SUBSTANCE TO A MINOR - SCHEDULE I OR II, 18-18-405(1),(2)(a)(II) C.R.S. (DF1) <§102E>

Between and including June 1, 2016 and October 30, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, feloniously, and knowingly sold or distributed **METHAMPHETAMINE**, a schedule I or II controlled substance.

Further, the defendant, an adult, sold or distributed the controlled substance or a material compound, mixture, or preparation that contained any amount of the controlled substance, to a minor, namely "A.S.", and the defendant was at least two years older than the minor, in violation of section 18-18-405(1),(2)(a)(II), C.R.S.

COUNT THREE

CONTRIBUTING TO THE DELINQUENCY OF A MINOR, 18-6-701 C.R.S. (F4) <18051>

Between and including June 1, 2016 and October 30, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully and feloniously induced, aided, or encouraged "A.S.", a child, to violate any state law namely: **POSSESSION OF A CONTROLLED SUBSTANCE (18-18-403.5)**; in violation of section 18-6-701, C.R.S.

COUNT FOUR

PIMPING OF A CHILD, 18-7-405 C.R.S. (F3) <20051>

Between and including June 1, 2016 and October 30, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, feloniously, and knowingly lived on, was supported, or was maintained in whole or in part by money or other thing of value earned, received, procured, or realized by a child, "A.S.", through prostitution; in violation of section 18-7-405, C.R.S.

COUNT FIVE

PANDERING OF A CHILD, 18-7-403(1)(b) C.R.S. (F3) <20022>

Between and including June 1, 2016 and October 30, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS**, for money or other thing of value, unlawfully and feloniously arranged or offered to arrange a situation in which "A.S.", a child, could practice prostitution; in violation of section 18-7-403(1)(b), C.R.S.

COUNT SIX

PROCUREMENT OF A CHILD, 18-7-403.5 C.R.S. (F3) <20031>

Between and including June 1, 2016 and October 30, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, feloniously, and intentionally gave, transported, provided, made available, or offered to give, transport, provide, or make available "A.S.", a child, to another person for the purpose of prostitution of the child; in violation of section 18-7-403.5, C.R.S.

The facts supporting Counts 1 through 6 are as follows:

1. The facts supporting all other counts in this Indictment are incorporated herein by reference.
2. In June 2016 "A.S." (D.O.B. 8/15/2000), a minor, was provided methamphetamine, cocaine, crack cocaine and alcohol from **ORLANDO L JOHNS "OJ" (JOHNS)** (D.O.B. 9/30/1991).
3. During the Summer of 2016, **JOHNS** then created and managed advertisements online for "A.S.", who went by the name "Lexi Staxx" and "Candy Staxx" to engage in sex with men, which involved oral, anal, and vaginal sex (hereafter sexual intercourse) in exchange for money eight to ten times per day.
4. **JOHNS** managed all of the Backpage.com advertisements for sexual intercourse with "Lexi Staxx" and "Candy Staxx", and then facilitated the meeting between "A.S." with the men.
5. **JOHNS** rented rooms at the Rodeway Inn, which is located at 3975 Peoria Way, which is within the City and County of Denver, State of Colorado, at least 20 times as noted by the receipts from the Rodeway Inn. The [REDACTED] at the Rodeway Inn, [REDACTED] knew **JOHNS** rented the rooms and that different men came and went from the rooms rented by **JOHNS**.
6. After the men had sexual intercourse with "A.S." and paid "A.S." cash, **JOHNS** would take the money from "A.S.", providing only a small portion of the money for "A.S." to use for food, clothing, condoms, or other personal items.

7. **Methamphetamine is defined as a Schedule I controlled substance under the Controlled Substance Act.**

COUNT SEVEN

HUMAN TRAFFICKING OF A MINOR FOR SEXUAL SERVITUDE, C.R.S. 18-3-504(2) (F2) <03085>

Between and including May 16, 2015 and May 15, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, knowingly and feloniously sold, recruited, harbored, transported, transferred, isolated, enticed, provided, received, obtained by any means, maintained, or made available a minor, namely "K.G.", for the purpose of commercial sexual activity; in violation of section 18-3-504(2), C.R.S.

COUNT EIGHT

CONTRIBUTING TO THE DELINQUENCY OF A MINOR, 18-6-701 C.R.S. (F4) <18051>

Between and including May 16, 2015 and May 15, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully and feloniously induced, aided, or encouraged "K.G.", a child, to violate any state law namely: **POSSESSION OF ALCOHOL BY A MINOR (18-13-122)**; in violation of section 18-6-701, C.R.S.

COUNT NINE

PIMPING OF A CHILD, 18-7-405 C.R.S. (F3) <20051>

Between and including May 16, 2015 and May 15, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, feloniously, and knowingly lived on, was supported, or was maintained in whole or in part by money or other thing of value earned, received, procured, or realized by a child, "K.G.", through prostitution; in violation of section 18-7-405, C.R.S.

COUNT TEN

PANDERING OF A CHILD, 18-7-403(1)(b) C.R.S. (F3) <20022>

Between and including May 16, 2015 and May 15, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS**, for money or other thing of value, unlawfully and feloniously arranged or offered to arrange a situation in which "K.G.", a child, could practice prostitution; in violation of section 18-7-403(1)(b), C.R.S.

COUNT ELEVEN

PROCUREMENT OF A CHILD, 18-7-403.5 C.R.S. (F3) <20031>

Between and including May 16, 2015 and May 15, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, feloniously, and intentionally gave, transported, provided, made available, or offered to give, transport, provide, or make available "K.G.", a child, to another person for the purpose of prostitution of the child; in violation of section 18-7-403.5, C.R.S.

The facts supporting Counts 7 through 11 are as follows:

1. The facts supporting all other counts in this Indictment are incorporated herein by reference.
2. "K.G.", D.O.B. 5/16/1998, a minor, is the [REDACTED] of [REDACTED] and was living with Ms. [REDACTED] when they met JOHNS in 2014.
3. Between and including May 16, 2015 and May 15, 2016, when "K.G." was 17 years old, JOHNS provided alcohol to "K.G." and suggested that she should make money by prostituting herself.
4. JOHNS created and posted advertisements for the sexual services of "K.G." and handled all of the calls from the men who were interested in seeing "K.G."
5. "K.G." engaged in sexual intercourse with numerous men for money and JOHNS took all of the proceeds she earned.
6. "K.G." was prostituted by JOHNS out of the Timbers Hotel, located at 4411 Peoria Street, in the City and County of Denver, State of Colorado, because of its proximity to her home at the time.

COUNT TWELVE

HUMAN TRAFFICKING FOR SEXUAL SERVITUDE, C.R.S. 18-3-504 (F3) <03084>

Between and including April 1, 2015 and January 1, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, knowingly and feloniously sold, recruited, harbored, transported, transferred, isolated, enticed, provided, received, obtained by any means, another person for the purpose of coercing the person, namely [REDACTED], to engage in commercial sexual activity; in violation of section 18-3-504, C.R.S.

COUNT THIRTEEN

PIMPING, 18-7-206 C.R.S. (F3) <19061>

Between and including April 1, 2015 and January 1, 2016, at and triable in the City and County of Denver, State of Colorado, **ORLANDO L JOHNS** unlawfully, feloniously, and knowingly lived on, was supported, or was maintained in whole or in part by money or other thing of value earned, received, procured or realized by another person [REDACTED] through prostitution; in violation of section 18-7-206, C.R.S.

COUNT FOURTEEN

PIMPING, 18-7-206 C.R.S. (F3) <19061>

Between and including January 1, 2015 and October 30, 2016, at and triable in the City and County of Denver, State of Colorado, **BLAIR STINSON** unlawfully, feloniously, and knowingly lived on, was supported, or was maintained in whole or in part by money or other thing of value earned, received, procured or realized by another person [REDACTED] through prostitution; in violation of section 18-7-206, C.R.S.

The facts supporting Counts 12 through 14 are as follows:

1. The facts supporting all other counts in this Indictment are incorporated herein by reference.
2. Between and including April 1, 2015 and January 1, 2016, **JOHNS** forced [REDACTED] to engage in sexual intercourse for money under the listed name of "Sophia."
3. **JOHNS** created the language of all of the advertisements posted on Backpage.com and set the prices for various sexual "services."
4. [REDACTED] engaged in oral, anal and vaginal sex with 7-8 men a night in hotels in the City and County of Denver, State of Colorado, including the Motel 6, 12020 E. 39th Avenue; the Rodeway Inn, 3975 Peoria Way; and the Timbers Hotel, 4411 Peoria Street.

5. **JOHNS took all of the money that [REDACTED] earned from the sexual acts and controlled when she worked, how many "dates" she had, and what she was allowed to do.**
6. **JOHNS was physically violent and threatened [REDACTED] when she did not make enough money or did not want to prostitute herself anymore.**
7. **JOHNS required [REDACTED] to make at least \$1000 per week.**
8. **A photograph of JOHNS holding up numerous hundred dollar bills was found on a search of both his Facebook and HashTagTeamOJ@gmail.com Gmail account.**
9. **JOHNS lived off of the money earned through the prostitution of [REDACTED] and others, and reported only \$9130.21 in earnings from 2014 until the third quarter of 2016.**
10. **[REDACTED] met Blair Stinson through JOHNS in January of 2016 and he immediately began to work together with JOHNS to prostitute [REDACTED] as well as other women.**
11. **From January 2016 until October 2016, Blair Stinson would create and post advertisements for [REDACTED] and collect all of the money from her sexual acts.**
12. **Blair Stinson would also drive [REDACTED] to and from dates when she did "outcalls."**
13. **Blair Stinson had \$65.84 in reported income in Colorado from 2015 to 2017.**

COUNT FIFTEEN

HUMAN TRAFFICKING FOR SEXUAL SERVITUDE, C.R.S. 18-3-504 (F3) <03084>

Between and including January 1, 2016 and December 31, 2016, at and triable in the City and County of Denver, State of Colorado, ORLANDO L JOHNS unlawfully, knowingly and feloniously sold, recruited, harbored, transported, transferred, isolated, enticed, provided, received, obtained by any means, another person for the purpose of coercing the person, namely [REDACTED], to engage in commercial sexual activity; in violation of section 18-3-504, C.R.S.

COUNT SIXTEEN

PIMPING, 18-7-206 C.R.S. (F3) <19061>

Between and including January 1, 2016 and December 31, 2016, at and triable in the City and County of Denver, State of Colorado, ORLANDO L JOHNS unlawfully, feloniously, and knowingly lived on, was supported, or was maintained in whole or in part by money or other thing of value earned, received, procured or realized by another person [REDACTED] through prostitution; in violation of section 18-7-206, C.R.S.

The facts supporting Counts 15 through 16 are as follows:

- 1. The facts supporting all other counts in this Indictment are incorporated herein by reference.**
- 2. In early 2016, JOHNS purchased a plane ticket for [REDACTED] to travel to Denver to begin to work for him.**
- 3. For the duration of 2016, JOHNS forced [REDACTED], using the name Diamond, to engage in sexual intercourse with as many as 7-8 men per night.**
- 4. JOHNS kept all of the money earned by [REDACTED] and would beat and threaten her if she did not earn enough money for him or want to work.**
- 5. The sexual acts performed by [REDACTED] were done in several hotels in the City and County of Denver, State of Colorado, including the Motel 6, 12020 E. 39th Avenue and the Rodeway Inn, 3975 Peoria Way.**
- 6. A total of 1,776 advertisements for prostitution were posted on Backpage.com using a phone number known to be used by JOHNS.**
