



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT  
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

**Joshua David Hensley, Date of Birth 10-25-80, White Male, 5 feet 11 inches tall, 250 pounds, brown eyes, brown hair, (Social Security # [REDACTED]) for C.R.S. 18-7-205 (1) Patronizing a Prostitute, a class 1 Misdemeanor, and C.R.S. 18-7-206 Attempt Pimping, a class 4 Felony (2 counts).**

I, Detective Timothy Goss, 05118, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

Your Affiant, Timothy Goss #05118, has been a Police Officer for over 13 years. Your Affiant is currently assigned to the Denver Police Department Human Trafficking Unit as a detective and has been in that assignment since March 25, 2019. Your Affiant was previously assigned to the Denver Police Department District Six Narcotics Unit as a detective from November, 2012, through March, 2019. Your Affiant was also assigned to the Denver Police Department Vice & Drug Control Unit from February 2011 through August 2011.

On 04/19/19, a female by the name of [REDACTED] (DOB [REDACTED]) was arrested at 2601 N. Zuni St., Unit # [REDACTED], which is the Rodeway Inn hotel in Denver, Colorado. Officers were called to that location on a call of a disturbance, and the officers were advised by the reporting party that one of the involved parties was [REDACTED], and that she had an outstanding warrant for her arrest. The officers contacted [REDACTED] and they determined that the disturbance which had been reported was unfounded. They then conducted an NCIC/CCIC clearance on [REDACTED], and she was found to have two warrants for her arrest. [REDACTED] was arrested on those outstanding warrants, and while searching [REDACTED]'s purse incident to the arrest, the officers located a small plastic baggie which contained a small amount of methamphetamine. [REDACTED] was charged with possession of a controlled substance (Denver Case # [REDACTED]).

While the officers were transporting [REDACTED] to the Denver Detention Center for this arrest, [REDACTED] asks the officers if they would stop the vehicle so that she could speak with them. The officers stopped and spoke with [REDACTED], and during that conversation [REDACTED] mentioned that there was a Colorado Department of Corrections employee named "Hensley", who was pimping woman. [REDACTED] stated that "Hensley" worked as an officer at Denver Women's Correctional Facility, which is located at 3600 Havana St., Denver, Colorado, 80239. [REDACTED] was then booked in to the Denver Detention Center on her warrants and for the possession of a controlled substance charge. Based on the conversation which they had with [REDACTED], the officers took her cell phone with her permission, and it was placed into the Denver Police Department property bureau to be held as evidence.

On 04/22/19, Your Affiant was contacted regarding the information which was given to the officers by [REDACTED]. Your Affiant responded to the Denver County Jail, and at 1600 hours, he met with [REDACTED] in visiting room number 5. Your Affiant spoke with [REDACTED] about her allegations, and she stated that she had been in prison in the Denver Women's Correctional Facility for three months back in 2015, and for approximately 1 month in 2017. [REDACTED] stated that while in

custody she knew a male corrections officer named "Hensley", who worked in the "med line" area of the facility. [REDACTED] stated that the "med line" is the area where inmates go to get their medication administered. [REDACTED] stated that during her first time at the facility, "Hensley" was very mean to the girls, made them write essays, and was not friendly with the girls in the facility. [REDACTED] stated that when she went back to the facility in 2017, "Hensley" had changed, and he seemed much more confident in himself, and friendly with the girls. [REDACTED] did not claim to have any out of the ordinary interactions with the male she knows as "Hensley" while in the jail. [REDACTED] described "Hensley" as a white male, around 40 years of age, and stated that he wears glasses looks like an older Harry Potter.

[REDACTED] stated that in late January or early February of 2019, she began to post herself on websites and to work as a prostitute based on advice she had received from a female friend. [REDACTED] stated that she was staying in hotel rooms around the Denver metro area, and that customers would call her based on her ad postings, and they would come to her hotel room to receive sexual acts of prostitution from her. [REDACTED] stated that she only did "In Calls", which means that the customers would always come to her.

[REDACTED] stated that in early March, she was staying in a hotel near Hampden and Wadsworth in Lakewood, Colorado, when a customer arranged to come to her room for an act of prostitution. When [REDACTED] opened her hotel room door, she immediately recognized the male customer as the person who she knew from the Denver Women's Correctional Facility as "Hensley". [REDACTED] stated that she was surprised, and that she immediately called the male "Hensley", and they talked about him being an employee at the jail facility. [REDACTED] stated that she then gave "Hensley" oral sex at that time, and that he left her \$40 on the counter in the room, although she was upset because he had agreed to pay her \$60 for the sex act. [REDACTED] stated that she continued to have a relationship with "Hensley" over the phone, but that the only time she saw him in person outside of the jail was this described time in early March. [REDACTED] also stated that another female prostitute who she knows as "[REDACTED]" or "[REDACTED]", had talked about having a sexual relationship with "Hensley" from the jail.

[REDACTED] stated that while "Hensley" and her continued to communicate over the phone, "Hensley" indicated that he wanted [REDACTED] to work for him, in a sense that he wanted to be her pimp. [REDACTED] stated that he told her that she needed to post on a specific website, and he told her that she needed to call him "Daddy", and that she needed to make money for him. [REDACTED] stated that she ended up getting very irritated and scared of "Hensley", and that she told him to leave her alone on multiple occasions. [REDACTED] stated that "Hensley" referred to himself as "Mr. Wolfe" while communicating with her and with "[REDACTED]". Your Affiant then concluded that interview.

Your Affiant and Detective Thomas then conducted further investigation about a possible employee at Denver Women's Correctional Facility named "Hensley". Your Affiant discovered that there is an employee at that location named Joshua Hensley, date of birth 10/25/80. Joshua Hensley has been employed at that facility since 2012, and the detectives were also given a photograph of Hensley at that time.

Your Affiant and Detective Thomas returned to the Denver County Jail on 04/23/19, at approximately 1330 hours. They went into visiting room #2, and they again met with [REDACTED]

At that time, [REDACTED] consented to the detectives that they could access her cell phone, and she signed a consent form at that time. [REDACTED] stated that her phone number was (720) [REDACTED], and that it was a dark blue Cricket phone, and she gave Your Affiant the pattern to unlock the phone. [REDACTED] stated that she has "Hensley" in her phone under three different contacts, "Hensley", "Mr. Wolff", and "Fuckin Hensley".

Your Affiant then showed [REDACTED] a photograph which he had obtained of Joshua Hensley, date of birth 10/25/80, and at that time [REDACTED] positively identified the person in that photograph as the person who she knows as "Hensley", who works at the Denver Women's Correctional Facility.

Your Affiant then returned to Denver Police Department headquarters, and he took [REDACTED]'s cell phone out of the property bureau, from invoice number 1042908. Your Affiant observed that the phone was a blue Cricket phone, and he was able to turn the phone on and access the phone based on the pattern code which [REDACTED] had given him.

Your Affiant found a string of texts from the contact "Mr. Wolfe...DWCF..Omg", which is the contact name for the phone number (303) [REDACTED]. That string of texts is from March 1, 2019 at 8:21pm to March 18, 2019 at 12:26pm. That string of texts has multiple texts regarding acts of prostitution and the texter sending multiple messages about wanting to pimp [REDACTED].

Also in that string of texts, [REDACTED] asks that contact for a photo, and on March 2, 2019 at 5:35am, a picture is sent from that contact, and that picture appears to be Joshua Hensley. Your Affiant compared that picture to the picture of Hensley received from the Denver Women's Correctional Facility, and also a photograph which Your Affiant obtained from the Colorado Department of Motor Vehicles of Hensley, and he confirmed that the photograph sent by that contact to [REDACTED] appears to be Hensley. That text string also indicates a meeting for prostitution at the Best Western at 3440 S. Vance St., in which the customer agrees to pay [REDACTED] \$60, but only left \$40, which is what [REDACTED] had described. There are also multiple photographs in that string of a male penis which were sent to [REDACTED]. That string of texts also includes [REDACTED] calling the contact "Hensley" multiple times, and the contact tells her not to use his last name.

Based on the contents of all of those text messages, it is clear that on 03/02/19, the correctional officer who [REDACTED] knows to be "Hensley" (Joshua Hensley), went to her hotel, Best Western, at 3440 Vance St., in Lakewood, Colorado, room [REDACTED], and for a period between the times of 06:31 (UTC-7) and 06:59 (UTC-7), "Hensley" went to [REDACTED]'s room and paid \$40 for oral sex, even though he had earlier agreed to pay \$60.

Your Affiant discovered that the phone number which was used by Hensley to send this text exchange, (303) [REDACTED], was a Bandwidth, Inc., phone number, which was being utilized by a third party provider named Pinger, Inc. Detective Goss drafted a search warrant for the call detail records and subscriber information on that and other Pinger, Inc. phone numbers, which were being utilized by Hensley.

On 05/03/19, Your Affiant received the records from Pinger, Inc. which had been requested by the search warrant. To activate phone numbers with Pinger, Inc, the customer has to provide an e-mail address and they will capture the IP address of the person opening the account. Detective Goss

observed that the Pinger, Inc. account for the phone numbers (303) [REDACTED] and (307) [REDACTED] were created by Pinger Username [REDACTED] with the e-mail address [REDACTED]@gmail.com. The account was created on 02/28/19 at 05:34:40 (UTC) and the IP address which was captured at that time was 75. [REDACTED]. Your Affiant also found while reviewing those records that Hensley had contacted hundreds of other women with the same type of propositions, creating the possibility that many more female victims of Hensley may exist.

Your Affiant found that the IP address which was used by the person who created the Pinger, Inc. account for the phone number (303) [REDACTED], was an IP address which was operated by Comcast.

Your Affiant drafted a search warrant to Comcast, Inc., for the subscriber information on the IP address 75. [REDACTED]. The following information was obtained from Comcast regarding the subscriber information on the IP address:

[REDACTED] is the [REDACTED] of Joshua Hensley, and [REDACTED] E. Jamison Ave., Centennial, Colorado 80122-3043, is Joshua Hensley's home address.

Based on the above facts, it is clear that Joshua Hensley (10/25/80) while utilizing a device at the IP address 75. [REDACTED], created a Pinger, Inc. account, which created the phone number (303) [REDACTED], and Hensley utilized that phone number to send text messages and photos to [REDACTED]. Among those text messages are messages indicating that Hensley met with [REDACTED] at the Best Western hotel in Lakewood, at which time Hensley patronized [REDACTED] for an act of prostitution.

It is also clear based on Hensley's phone records which were received from Pinger, Inc., and from the dump of [REDACTED]'s cell phone, that Hensley was clearly recruiting [REDACTED] to work as a prostitute with him being her pimp. On several occasions Hensley gives [REDACTED] instruction on how to conduct deals of prostitution, including sending her links to websites and telling her to post advertisements for her to make money as a prostitute. Hensley also instructs [REDACTED] to call him "Daddy", which is common in a prostitute to pimp relationship.

While reviewing Hensley's Pinger, Inc. phone records, Your Affiant discovered four text messages which Hensley sent from phone number (303) [REDACTED] to [REDACTED] on 03/12/19 between 2:07:37 and 2:13:09. Those texts were as follows:  
"I need you get my money back from one of my ex whore"  
"U may know her"

"She live near where you are"

██████████ did not respond to any of those texts, however Your Affiant researched ██████████ and was able to speak to her on multiple occasions in late April, 2019 through June 12, 2019. On 05/14/19, ██████████ sent Your Affiant a string of texts from Hensley's phone number (303) ██████████, which were sent to ██████████ between the dates of 04/11/19 and 04/16/19. In those texts Hensley again refers to himself as "daddy" on multiple occasions, and is clearly asking her to work for him, as far as him being her pimp. Hensley offers her money to pay for her hotel room and for her to get clothing. During those texts Hensley also tells ██████████ that "██████████ is looking for you", "for your daddy", and he then asks where she is. He then says "This your daddy". He later sends a text to ██████████ saying "I have bad week", "I had to punish on of my girl for stealing money from me". It is clear that these texts are intended to be threatening and cause ██████████ fear of Hensley.

On 06/11/19, ██████████ sent Your Affiant another string of texts in which she received from someone who she believes to be Hensley. The phone number is (307) ██████████, and from that number he refers to himself as "Roland", which is what Hensley has commonly referred to himself while texting women. Hensley also sends a "selfie" picture of his face to ██████████ and that picture is Joshua Hensley. Those texts were sent between 06/08/19 and 06/11/19. In those texts Hensley again refers to her making money for him, sending a picture of U.S. currency and saying "I want to make good money with you", "are you serious about getting into this business", and "If not done with your lying ass". Hensley also sends threatening texts to ██████████ such as "I'm sent my guys to bring you to me", and "I'm done playing". Hensley also sends a text message saying "If u been fucking black dude I'm going whip your ass!!" Hensley also sends ██████████ texts messages saying "Bitch answer your phone" and "please don't make me sad or mad".

On 06/27/19, Your Affiant was sent additional screen shots from ██████████ of messages which were sent to her by Joshua Hensley within a week of that date. The messages were from the phone numbers (303) ██████████ and (303) ██████████, which Your Affiant verified were Pinger, Inc. phone numbers. Those text messages were again sexual and threatening in nature, and they were also again trying to recruit her to work as a prostitute for Hensley. Those messages also contained a "selfie" photograph of Joshua Hensley's face.

It is clear that Johsua Hensley continues to send ██████████ ext messages with the intention of scaring her into meeting with him, and to work as a prostitute with him being her pimp. He has found her new phone numbers several times after she has blocked his numbers from contacting her, and he has continued to harass her and try to coerce her to work for him.

Joshua Hensley has contacted these two female victims along with numerous other females, with the intentions of meeting them for acts of prostitution, and also to coerce them in to working for him, with him being their pimp. At least one of these victims has been an inmate at Hensley's place of employment, Denver Women's Correctional Facility, so it is possible that Hensley is using his position and his employment to recruit or identify the women that he is targeting for these acts.

Based on the above facts and information, Your Affiant requests an Arrest Warrant be issued for the person identified as Joshua David Hensley, Date of Birth 10-25-80, White Male, 5 feet 11 inches tall, 250 pounds, brown eyes, brown hair, (Social Security # ██████████) for C.R.S. 18-7-205 (1)
