The probable cause of the arrest of the above-named individual is as follows:  
[On the above date and time the Defendant, Crawley, Ernie Jr, was contacted by Bartholomew of the Denver Police Department at the location of I70 Hwy\_Eb/ I225 Hwy\_Sb, City and County of Denver, State of Colorado, for fatal accident. Upon contact, the Defendant exhibited the listed indicia of impairment: SPEECH WAS SLURRED, BREATH HAD A STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE, BALANCE WAS NOT OBSERVED, EYES WERE BLOODSHOT/WATERY. He NotFound and was arrested. He was advised of Colorado Express Consent and requested a blood test. The Defendant was transported to University Hospital where a blood draw was conducted. After obtaining a search warrant a blood sample with results pending. Subsequent investigation revealed Defendant to be the at-fault driver and the collision resulted in the death of Victim, Brandi Wilson no DOB, Sean Moler 07/02/99 [REDACTED], from I70 Hwy\_Eb / I225 Hwy\_Sb.]
