



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT  
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

**Bradley Joseph Marcotte dob: 04/14/62. White Male, 5' 7", 182 pounds, Brown Hair, Green Eyes. SS # [REDACTED], for Sexual Assault on a Child by a Person in a Position of Trust, CRS#, [REDACTED] (2)(b), Pattern of Abuse, Class 3 Felony (3 Counts).**



I, Detective Neil Baker 04026, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

On 06/26/2018, your Affiant (A police officer for 27 years and currently assigned to Sex Crimes Unit), was assigned follow up investigation on Denver Police Offence Report # 2018-5003011 completed by the victim, [REDACTED]

Your Affiant met with the victim, [REDACTED] at Denver Police Headquarters. [REDACTED] came in to report that she was possibly sexually assaulted, and he needed to speak with a detective.

[REDACTED] stated that she had met the suspect, Bradley Marcotte (Brad) when she was 14 to 15 years old. She stated that she was dating a boy who she identified as [REDACTED] at that time. She stated that [REDACTED]'s mother had met Brad on-line and Brad had befriended [REDACTED]. She stated that she is Catholic, and Brad was also Catholic, and she considered him to be a Spiritual Advisor and friend. She stated that they started to meet privately and talked privately together about different things. She confided in him about her family problems and stated that he had counseled her about it.

[REDACTED] stated that Brad started giving her long hugs and when she would pull away, he would convince her to trust him. She stated that she remembers one time they were on the playground. She stated that he had her sit on his lap while he was caressing her face. She stated that she remembers him telling her that this was true love and that she needed to trust him because he was there for her.

[REDACTED] stated that she would talk to Brad multiple times a day and she would see him 4 to 5 times a week. She stated that she defended Brad to her parents because he was there for her and she trusted him with her faith and looked up to him as a mentor.

█████ stated that during her sophomore year of high school, Brad would take her to the Southmoor light rail station, located at 3701 S Monaco Pkwy in the City and County of Denver, and kissed her. She stated that they would start by kissing and then he would often tell her to lean back in her seat. She stated that she would put her seat down that he would put his hand inside of her underwear and caress and finger her vagina. She stated that his hand was underneath her underwear and would go in and out of her vagina. █████ stated that she was 15 years old when this happened. She stated that he would also pull up her shirt and caress her breasts. She stated that they went to the light rail station many times in his car. She stated that he would kiss her and when she told him to stop, he would "shhh" her.

█████ stated that during her junior year of high school he would touch her at his house. (1765 S Oneida St) She stated that she was very tense when this happened. She stated that they would play games that he would run his hand up and down her leg and then put his hand in her pants touching her vagina. She stated that he would usually give her a change of clothes so that she did not get the ones that she had on wet. She stated that he would kiss her on the neck when it was her turn during the game. She stated that when it was his turn, she would reciprocate and touch his "dick". She stated that she put her hands inside of his pants and kissed him on the neck.

█████ stated that during her junior year of high school, he had told her that Heaven was okay with what they were doing as long as they didn't have sex. She stated that she would give him oral sex but they never had actual sex at that time. She stated that she remembers having to get one of her dresses cleaned because he ejaculated all over it while she was giving him oral sex. She stated that she remembers him licking her vagina while she was standing on his couch. She stated that he would sometimes spit on her vagina and have her in different positions to where he could touch her better. She stated that she remembers him pushing her head towards his Dick while they were driving down Monaco Street in his car and telling her to unzip his pants. She stated that he tried to get her to stay in a hotel with him but she was too scared. She stated that he would tell her that he would have dreams of them having sex in Heaven and prays that Heaven would allow them to be together intimately. He talked about a mountain cabin and them having sex. █████ stated that she thought she was truly in love and told him that she loved him and wanted to have a future with him.

█████ stated that he would take her to the park behind the "pot" shops off of Hampden, in the parking lot of Goodwill. She stated that it was behind work buildings off of Evans by Monaco. She stated that this would happen 1 to 4 times a week. She stated that he would do sexual things with her from kissing to taking off her clothes. She stated that he would rub and suck her breasts and finger her vagina. She stated that she would then kiss him, touch his leg and penis, unzipped his pants, lick his penis and balls and sometimes give him oral sex.

█████ stated that he would "69" with her at his house and she told him that she felt ashamed and dirty afterwards. She stated that he told her that she shouldn't and that she must not love him as deeply as he loved her and that she should not fight it. She stated that she was scared to lose him or hurt him because he was the closest person to her and knew everything about her. She stated that he also led her to her faith and told her he was dying.

█████ stated that during her senior or junior year, he bought her sex toys. She stated that he bought a vibrator to use on her during her junior year and a dildo during her senior year she stated that she was in the car when he went to the store to buy them.

█████ described another incident that happened during her junior or senior year of high school. She stated that he had her across the pool table in his basement and took her pants off and laid her down with the lights on. She stated that she told him no but he told her to lie down. She stated that he fingered her and told her to close her eyes and he cupped her breasts.

She stated that she was at his house during the summertime and while he was touching her in the living room she had her back towards him. She stated that he was fingering her with his pants down and he slid his penis around her butt and slightly in her butt. She stated that he slid his penis between the lips of her vagina and then into her vagina and lunged into her.

█████ stated that during her senior year, she would periodically tell Brad that she wanted to stop and did not want to do this anymore. She stated that he would always talk her out of it and tell her that she was playing games with him and that it was love.

Your Affiant confirmed with █████ that Brad had penetrated her vagina with his fingers when she was 15 years old. She stated that she does not remember exactly how old she was when he penetrated her vagina with his penis. She thinks she was 16 or 17 years old.

Your Affiant checked NCIC and found Bradley Marcotte. The photograph was obtained from his driver's license and shown to █████. █████ positively identified the photograph as Bradley.

On June 27, 2018, Your Affiant met with victim, █████ at Denver Police Headquarters.

█████ stated that she was friends with █████ but did not know her that well. She stated that her sister, █████ was friends with █████ and she just tagged along.

█████ stated that █████ introduced her and her sister to Brad. She stated that she lives in Strasburg Colorado and her mother had driven her and █████ to a Starbucks in Denver to meet with Brad. She stated that Brad was her Spiritual Advisor. She stated that Brad would meet with a group of kids and help them with their problems. She stated that her mother was skeptic at first because Brad was an older man.

█████ stated that she met Brett when she was 15 years old. She stated that she would go to see him with other kids and sometimes by herself. She stated that they would always meet at a Starbucks or some type of public place. She stated that he would also drive them around in his car. She stated that he would drive her by herself sometimes in her car and they were talking. █████ stated that Brad would make comments to her about how pretty she was. She stated that Brad would also make sexual comments about things he's done with other people and that he would like to do those things with her. She stated that he progressed with her. She stated that he would talk to her and put his hand on her leg and moved it to the inside of her thigh. She stated that he would reach over and graze her breasts and pretend it was an accident. █████ stated that he would hug her and put his hands on her lower back and eventually would put his hands on her buttocks. █████ stated that when she was approximately

16 years old, Brad would hug her and put his hand down the back of her pants. She stated that his hand would slide down to the inside of her underwear and would touch her buttocks skin to skin. She described him holding her buttocks. She stated that Brad kissed her on the mouth while his hand was inside of her pants touching her buttocks.

Your Affiant showed [REDACTED] a single photograph which she identified as Brad.

On July 3, 2018, Your Affiant met with victim, [REDACTED] at Denver Police Headquarters.

[REDACTED] stated that she had recently received a phone call from victim [REDACTED]. She stated that she lives in Oregon and goes to medical school there. She stated that she has known [REDACTED] for a while and she was friends with her along with a mutual friend, Brad Marcotte. [REDACTED] stated that [REDACTED] had opened up to her about a sexual relationship that she was having with Brad. [REDACTED] stated that she was shocked because she had also had a sexual relationship with Brad.

[REDACTED] stated that she had met Brad through a friend and their family. She stated that she was in the sixth or seventh grade when she met him. She stated that she would meet with him with a group of kids for guidance and counseling. She stated that a lot of the kids called him "Father Brad". [REDACTED] stated that he used religion a lot in their conversations and they thought of him as a Spiritual Mentor. She stated that she eventually started meeting with him alone. She stated that they would usually go somewhere in his car. She stated that they would talk about their religion and things like that. She stated that when she was in the seventh grade, he actually baptized her in the backseat of his car.

[REDACTED] stated that when she was 16 1/2 years old she was sitting with Brad in his car. She stated that he exposed his penis to her while explaining what his penis was. She stated that he was explaining the anatomy of his penis to her.

[REDACTED] stated that while she was 17 years old, she met with Brad at a hotel in Cherry Creek. She stated that she does not remember how she got there but thinks that he picked her up and brought her there. She stated that she remembers him buying some alcohol but does not remember drinking any. She stated that while she was at the hotel, he performed oral sex on her. She stated that she remembers standing up by the couch and the window while he was performing oral sex on her. She stated that he made a statement something like "this is not how it works and that she has to reciprocate". She stated that she performed oral sex on him as well.

[REDACTED] stated that while she was 17 years old, they took a trip to Estes Park with her friend [REDACTED] and his mother [REDACTED]. She stated that this happened on March 29, 2008 while she was still 17 years old. She stated that during that trip, she remembers Brad laying on the couch because he had to sit up to sleep due to his medical condition. She stated that she remembers his pants down and she remembers straddling him while he rubbed his penis on her vagina. She stated that her pants were probably down or off because his penis touched her vagina skin to skin. She stated that she remembers expressing her concern to Brad about becoming pregnant by doing this. She stated that she remembers Brad telling her to keep quiet because [REDACTED] could hear her.

[REDACTED] stated that she continued to see Brad almost every weekend after that while she was 17 years old. She stated that they spend a majority of the time in his car. She stated that while in his car, she

would give him oral sex while he would put his fingers inside of her vagina. She stated that she remembers this well because he would also push her face toward his anus as she was performing oral sex. She stated that he would tell her to lick his anus which she did. She stated that they were in Bible Park (6802 E Yale Ave) quite often. She stated that she would perform oral sex on him during these occasions and he would put his fingers in her vagina.

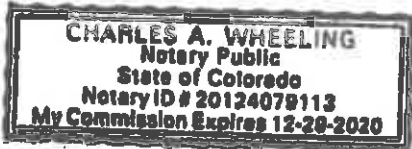
