When Joshua HUGHES and 1 suspect are out of view, the video then shows "he second suspect walking in the direction of where HUGHES and 1 suspect had walked out of view. . he second suspect is seen raising an arm and pointing what appears to be a handgun. The video did not capture the victim's van or the shooting of the victim.

Joshua HUGHES came to Denver with the intention of purchasing marijuana and taking it back to
Montana. Mr. related Joshua wanted to buy 2 pounds of marijuana with the \$3,000.00. Mr.
related this deal was set up on a website called Commerce City Kush Club, a website where
it was posted on the website, 2P for 3K. Mr.
related on Saturday night (August 19th) someone with a Facebook user name of "Marcus
BILES", answered the add and wanted to make the deal. Mr. related he agreed to go with
Joshua. Mr. related they were using scomputer at the time. Mr.
related they communicated back and forth with seller "Marcus BILES", via Facebook messenger. Mr.
related they were given the address of Titan Court. Mr. related when they

On August 21st, 2017, Detective TREGEMBO began searching Facebook for the name "Marcus Biles". No account was located under "Marcus Biles", but an account under the profile name "Biles Marcus" was located.

n August 29th, 2017, Detective TREGEMBO obtained a Search Warrant for Facebook Inc. to identify the Facebook user "Biles Marcus". It was also requested that all communication of Facebook user "Biles Marcus" from January 1st, 2017 thru August 29th, 2017.

A review of Internal Denver Police Department records identified Armani PIERRE 03/22/1999, living at 4764 Blackhawk Way, In Denver. Colorado Department of Motor Vehicle also listed Armani PIERRE's address as 4764 Blackhawk Way.

On September 26th, 2017, Detective TREGEMBO received the requested information back from Facebook on the "Biles Marcus" account. Included in this information were messages from Facebook user account to "Biles Marcus" dated August 20th, 2017, at 03:10:54 UTC (which converts to August 19th, 2017, at 9:10:54 p.m. MST). Messages confirm that Facebook user posted a message about wanting to purchase two pounds of marijuana, which was consistent with the information obtained from the Facebook records also confirmed the "Biles Marcus" account was used as a means of communication with Joshua and and to meet to purchase the marijuana, which ended up with the homicide death of Joshua HUGHES.

On Wednesday, February 14th, 2018, at approximately 1:57 pm, Detective MARTINEZ interviewed Armani PIERRE 03/22/1999, at Denver Police Headquarters. PIERRE had been arrested by Denver Police on another matter. PIERRE was advised of his rights and agreed to talk. PIERRE admitted he had set up this marijuana deal under the name Biles Marcus with the Commerce City Kush Club. PIERRE admitted he only set up the deal and that Kylevito GARRETTE and Quincy WILKERSON carried it out. PIERRE admitted that Kylevito and Quincy later told him that the deal went bad, that the victim tried to rob them and that both of them (Kylevito and Quincy) shot the victim in self defense. PIERRE admitted he was supposed to get 100 or 200 dollars for setting up
