I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 03/03/2018 at 11:51 pm at or near the location of I70 EB / N BRIGHTON BLVD in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:  
[On the above date and time the Defendant, IVAN GERARDO ZAMARRIPA-CASTANEDA, was contacted by Officer K Campbell of the Denver Police Department for a fatal traffic accident at the location of I70 EB / N Brighton Blvd , City and County of Denver, State of Colorado. The Defendant was found to be the at-fault driver and resulted in the death of the victim, [REDACTED] (DOB [REDACTED] 1961). The defendant fled the scene prior to police arrival and without providing aid or information.

The defendant was later contacted at his residence. Upon contact, the Defendant exhibited the listed indicia of Impairment: SPEECH WAS SLURRED, BREATH HAD A MODERATE ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE, BALANCE WAS SURE, EYES WERE WATERY. He agreed to perform voluntary roadside maneuvers which he was not able to complete compared to a sober person and was arrested. He was advised of Colorado Express Consent and agreed to a blood test. The Defendant was transported to DHMC where three blood draws were conducted. He provided blood samples with results pending.

The defendant was held at the DDC.]
