**All Charges Domestic Violence Related**

I, Detective Brian Humm, #07049, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person(s), are the following:

On May 18<sup>th</sup>, 2018, your Affiant (A Police Officer for 17 years and currently assigned to the Denver Police Department Major Crimes Bureau, Domestic Violence Unit), was assigned the follow-up investigation of Denver Police Offense Report #2018-332595 completed by Officer Mucci #17047 and Corporal J. Waldrop #08042.

Your Affiant learned on May 17<sup>th</sup>, 2018 the victim, identified as [REDACTED] reported in person to Corporal Waldrop and Officer Mucci at the Denver Police District 5 Station, 4685 N Peoria St.

Your Affiant learned [REDACTED] filed reported she has been the victim of Domestic Violence by [REDACTED] the suspect Robert Marsden (07/07/83). The couple have been in an intimate relationship for about 11 years. Although they [REDACTED] they have continued to live together and have 2 children. [REDACTED] has another child from a previous relationship. The children are [REDACTED] and the [REDACTED] ( [REDACTED] ). [REDACTED] reported a pattern of abuse which has been occurring at [REDACTED] N. Malta St., in the City and County of Denver, State of Colorado. The incidents [REDACTED] is reporting began on December 24<sup>th</sup>, 2017 and have continued until recently.

Your Affiant learned [REDACTED] indicated on December 24<sup>th</sup>, 2017 the suspect was mad at her for an unknown reason and was threatening her with a wooden stool. [REDACTED] was on the ground begging him not to hurt her, but the suspect struck the victim on her neck. [REDACTED] went to Rose Hospital for treatment and was released the same day and went home. [REDACTED] did not report the incident to police in fear of retaliation from the suspect.

Your Affiant learned, on December 26<sup>th</sup>, 2017, the suspect was mad at [REDACTED] and began to grab her and beat her in the head with a closed fist. [REDACTED] stated she was covering her head with her hands in order to protect herself. [REDACTED] was able to get away and the suspect grabbed her at the bottom of the stairs pulled her down and ripped off her clothing. This entire fight was in front of their [REDACTED] [REDACTED] later explained to your Affiant she went to Rose Medical Center for treatment and she described her injuries as [REDACTED] and [REDACTED] to her [REDACTED] Rose Medical Hospital Staff suspected she was the victim of Domestic Abuse and called the Police, but [REDACTED] left before speaking with officers, again in fear of retaliation.

Your Affiant learned the victim was informed she was pregnant and she explained this information to the suspect during the first week of January 2018.

Your Affiant learned [REDACTED] reported on April 20th, 2018 the suspect pushed her into the wall causing [REDACTED] Robert also kicked her in the stomach and groin area knowing that she was pregnant. The suspect kicked her hard enough to lift her off the floor. [REDACTED] later reported she went to Denver Health Medical Center for [REDACTED] and [REDACTED], but she checked ok. [REDACTED] related she and the suspect are going to name the baby [REDACTED]. The suspect told her according to the Bible Kain and Abel was the first murder and that he would murder their unborn child and that would be his first murder just like in the Bible.

Your Affiant learned sometime between April 20<sup>th</sup>, 2018 and May 9<sup>th</sup>, 2018 the suspect grabbed a blow torch and hit her in the back of the arm causing [REDACTED] The last incident occurred on May 9th, 2018. She stated the suspect was mad at her and pushed her into the wall. The suspect stood over top of [REDACTED] and pushed her to the ground. While she was being pushed it caused a very [REDACTED] to her [REDACTED] from the wall affixed door stop.

Your Affiant learned [REDACTED] was afraid to call for help because she believed the suspect would retaliate and continue to harm her or harm the children. [REDACTED] reported the suspect would often take her cell phone away during or after the assaults preventing her from calling for help. [REDACTED] related a pattern of emotional abuse as well. The suspect would strip [REDACTED] of her clothes in an effort to berate and belittle her. The suspect continued to display aggressive power and control behavior by threatening to kill her and the children. [REDACTED] explained the suspect did not physically harm the children, but the assaults and verbal abuse did occur in their presence.

Your Affiant met with [REDACTED] in person on May 18th, 2018. [REDACTED] confirmed the facts of the case. [REDACTED] still had [REDACTED] which had been previously documented by the reporting officers. [REDACTED] had provided the officers with a photograph of the suspect. Your Affiant completed a query search of CCIC and found the most recent DMV file photo of the suspect. The photograph was compared as being the same person as the photograph provided by [REDACTED] Your Affiant presented [REDACTED] with the single DMV photograph which she positively identified as both the suspect and as Robert Marsden.

Based on the aforementioned information, your Affiant respectfully requests that a probable cause arrest warrant be approved for the suspect, ROBERT ALEXANDER MARSDEN, (07/07/1983), FOR: Assault in The Third Degree, Pregnant Victim, § 18-3-204(1)(a) & § 18-1.3-501(6), A Class 1 Misdemeanor and Child Abuse, § 18-6-401, A Class 2 Misdemeanor.
