I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 06/14/2019 at 1:14 pm at or near the location of I70 HWY_EB / N HAVANA ST in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:

[On the above date and time the Defendant, Rome, Maynard (07/23/59), who was identified by his Colorado Driver's License, was contacted by Officer M. MALLO #15003 of the Denver Police Department at the location of I70 HWY_EB / N. HAVANA ST., City and County of Denver, State of Colorado, for CRASH-OCCUPIED VEHICLE. The defendant was going e/b in lane #1, and drifted into lane #2 and struck another vehicle, front to rear. Upon contact, the Defendant exhibited the listed indicia of impairment: SPEECH WAS SLURRED, BREATH HAD A STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE, BALANCE WAS SWAYING, EYES WERE BLOODSHOT/WATERY. He was offered voluntary Standardized Field Sobriety Tests, but was not following directions on Horizontal Gaze Nystagmus, he stated he had back issues and due to safety concerns the Walk and Turn and One Leg Stand were not completed and he was arrested. He was advised of Colorado Express Consent and elected to take a blood test on scene. At the hospital he signed giving consent to the blood draw, then refused a chemical test when the blood was going to be drawn. A check via NCIC/CCIC and Master Files revealed Defendant to be under LICENSE SUSPENSION/REVOICATION for SUSPENDED - NO INTERLOCK LEASE Case # 19-122972 with an active date of 04/29/2019. Defendant operated a motor vehicle without a functioning Ignition Interlock Device as required by law. There was no interlock located in the vehicle. The defendant also did not have any valid proof of insurance in his vehicle.
