I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 12/11/2019 at 12:25 pm at or near the location of 1900 BLK W JEWELL AVE in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:
 [On 12/11/2019 at 12:25 hours, the defendant, positively identified by his Colorado Identification Card as Cribbs, Roosevelt Jr (04/03/1952) (CO-PIN [REDACTED]) was traveling Eastbound in the 1900 Block of W Jewell Ave (Located in the City and County of Denver / State of Colorado) in his Winnebago Motorhome (CO TMP [REDACTED]) (VIN [REDACTED]) when he veered into Westbound traffic and then went onto the North end curb onto the sidewalk, striking the victim, identified as Abdalla-Suleiman, Sallha Abdalla (DOB [REDACTED]), who was walking Eastbound on the North sidewalk. The defendant continued traveling Eastbound and failed to stop to render aid, provide information and report the accident. The victim was transported for medical treatment but was later pronounced deceased. The defendant was later contacted at [REDACTED] W Mississippi Ave and transported to TIU to be interviewed by TIU Detectives where he confessed to being the driver after Miranda Advisement. The defendant was later transported to the DDC for processing.]
