 I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 12/17/19 at 1655 am pm at or near the location of W. Colfax Ave. & N. Zenobia St. in the City and County of Denver, State of Colorado.

Statement of Probable Cause Affidavit for Arrest Warrant

On 12/17/19 at approximately 1655 hours, a traffic collision occurred at the intersection of W. Colfax Ave. & N. Zenobia St.

This location was there and is now in the City and County of Denver, State of Colorado.

Denver Police Officers responded to the location and learned the crash occurred in the following manner: Vehicle #1, a white pickup, was traveling eastbound in the #1 lane of W. Colfax Ave. at a high rate of speed when it struck Pedestrian #2, identified as [REDACTED] (DOB [REDACTED]) who was crossing W. Colfax Ave. in a southbound direction on the east side of Zenobia St. Vehicle #1 fled the scene without stopping. An AMR ambulance passing the scene was flagged down and completed a medical assessment on the pedestrian. The victim was pronounced deceased at the scene by DHMC Dr. J. Nacht at 1702 hours.

The suspect vehicle was located at approximately 1810 hours on the southwest corner of W. Colfax Ave. & N. King St. unoccupied. The vehicle is a white 2007 GMC Sierra pickup bearing Colorado license plate# [REDACTED]; VIN# [REDACTED] that was observed to have heavy front-end damage consistent with this collision. The registered owner is [REDACTED] with an address of [REDACTED] Colorado Blvd. Idaho Springs, CO 80452.

Your affiant located a phone number for [REDACTED] ([REDACTED]). Your affiant contacted Mr. [REDACTED] by phone and the call was recorded. Mr. [REDACTED] advised he loaned the vehicle to an acquaintance named "Juan". Your affiant located a record of the suspect vehicle involved in a DUI in Gilpin County on 12/13/19 in which the suspect arrested was identified as Juan Sanchez (01/01/80). I obtained a mugshot photo of Sanchez from Gilpin County. Your affiant sent the photo to Mr. [REDACTED] via text message and [REDACTED] confirmed that Juan Sanchez (01/01/80) was the person to whom he loaned the vehicle and provided a phone number of [REDACTED] for Sanchez.

A driver's check is negative for any information on Juan Sanchez (01/01/80). An NCIC check was negative for warrants.

Your affiant attempted to contact Sanchez by phone with no answer and the voicemail was not set up. I sent a text message to Sanchez requesting contact. On 12/18/19 at 1525 hours, Juan Sanchez contacted this detective by phone and the call was recorded. Mr. Sanchez stated he was driving at the time of the crash and stated the pedestrians ran out in front of him and he did not have time to react. Mr. Sanchez agreed to respond to the Traffic Investigation Unit within the hour to speak to this detective.

Mr. Sanchez failed to respond to TIU as agreed or contact your affiant and would not answer any further attempts to contact him by phone or text.

Your affiant respectfully request that a warrant is issued for the arrest of Juan Sanchez (01/01/80) for the following violations as amended: CRS 18-3-106(1)(a) - Vehicular Homicide - F4; CRS 42-4-1601(1)(2)(c) - Leaving the Scene of an Accident Involving Death - F3.
