I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 06/16/2017 at 4:23 am at or near the location of 2400 BLK CURTIS ST in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:  
[On 06-16-2017 at approximately 0404 hours officers responded to 25th St / Curtis St on the report of an assault in progress. This location is within the City and County of Denver.

Upon arrival at 25th St / Curtis St officers contacted two assault victims, later identified as [REDACTED]-99 and [REDACTED]-98, who both had been assaulted in an apparent random attack. Officers observed [REDACTED] to have significant facial injuries. An unknown witness then directed officers to the 2400 blk of Curtis St where the suspect fled following the assault.

Officers observed an unknown victim, lying in the middle of the street, mid-block of the 2400 blk of Curtis St. The suspect, later identified as Stamps, Dejuan 09-01-88, was standing next to the victim, and was continually striking the victim in the chest with force. Officers heard the suspect shouting "I did it, I did it," as he continued to strike the victim.

Officers challenged Stamps, who rushed the officers. Officers were able to subdue Stamps following a struggle where an officer was injured.

DHMC ambulances responded to the scene, where [REDACTED] and [REDACTED] were transported to DHMC for evaluation. DHMC amb 67 responded to the 2400 blk of Curtis St where they evaluated the unidentified victim, who was pronounced deceased at 0420 by Dr. Broderick.

Stamps was transported by ambulance to DHMC where he was placed on an investigative hold for 1st degree murder.]
