Statement of Probable Cause                       Affidavit for Arrest Warrant

On Wednesday, October 23, 2019 at approximately 5:55pm Denver Police Officers responded to the Yogurtland located at 550 N. Grant St., regarding a Robbery in progress. The address is located in the City and County of Denver, State of Colorado.

The report indicated the following: The male walked to back of the register and said "[REDACTED]". He put his hand in his pocket and grabbed what looked like a hand knife.

Upon the Officers arrival, the unidentified suspect was not present or located at the time of the report.

The suspect was described as a young male, approximately 19 years old, wearing a [REDACTED] hoodie, with no facial hair, [REDACTED] tennis shoes.

Officer Callee Heitz #17080 completed a General Offense Report for Business Robbery-case #679135.

This Aggravated Robbery is consistent with a pattern robbery suspect including the physical description of the suspect and the manner of operation, the suspect was named the "Sweet Tooth Bandit". This pattern of robberies continued after this incident and below is the list of robberies committed by the Sweet Tooth Bandit.

On Wednesday, January 8, 2020 Detective Mudloff responded to the area after Dispatch aired a Robbery had just occurred it was dispatched at 200 N Quebec St. Detective Mudloff responded, canvassed the area, including the leasing office. He provided a copy of the Crime Stoppers Bulletin with photographs of the Sweet Tooth Bandit. The Apartment Complex employees printed copies of the bulletin to post.

On Thursday, January 9, 2020 a male named [REDACTED] who lives at [REDACTED] Rampart Way, called the Robbery Unit to inform Detectives that the Officers in the area on 01/08/2020 looking for the robbery suspect, showed him a surveillance photo and he believed the suspect lives on the 3<sup>rd</sup> floor of [REDACTED] Rampart Way.

Detective Mudloff and Detective Erickson met with [REDACTED] who lives at [REDACTED] Rampart Way and he took them to the leasing office of the location. [REDACTED] lives in apartment # [REDACTED] and related that the male lives on the 3<sup>rd</sup> floor near him with a female and [REDACTED] described the male and female as young. [REDACTED] related the male and female drive a [REDACTED] VW [REDACTED].

The leasing office looked through the tenant's files and there was one young female listed in the area. The staff related to the Detectives that there is a female that lives in # [REDACTED] and her name is [REDACTED] ([REDACTED]-[REDACTED]-[REDACTED]) and showed Detectives a copy of a driver's license on file and [REDACTED] confirmed that it is the female that stays with the possible suspect.

Detective Mudloff conducted a computer check for [REDACTED] ([REDACTED]-[REDACTED]-[REDACTED]) and found she drives a [REDACTED] Volkswagen [REDACTED] bearing Colorado plate [REDACTED]. He completed a check of the [REDACTED] and found it was involved in a traffic stop on 09/25/2019 at 4<sup>th</sup> and Syracuse St., and the driver was an Emanuel Martinez (11-25-1997).

Detective Mudloff found a DMV photo of Emanuel Martinez (11-25-1997) which matched the appearance and physical description of the Sweet Tooth Pattern (5'6, 135lbs, brown hair, brown eyes).

Based on the information received, on Monday, January 13, 2020 I Detective Raquel Lopez contacted victim [REDACTED] and set up day and time to have photo lineup completed.

Based on the positive identifications made, I Detective Raquel Lopez utilized the photo array completed by Detective Brian Mudloff and re-assembled the Photographic Lineup placing Emanuel Martinez 11-25-1997 in position #2. On Tuesday, January 14, 2020 I Detective Raquel Lopez met with victim [REDACTED] at [REDACTED]. The Photographic Lineup Admonition was read to her, she signed it stating she understood. After reviewing the lineup she was unable to make ID, she stated "I don't recognize any of the suspects, the person I seen had a more narrow face". This lineup was scanned and added into this case file, with originals placed into the Denver Police Property Bureau. No identification was made.

Based on the clothing description, and video surveillance provided, the suspect appears to be wearing a [REDACTED] jacket with some sort of [REDACTED] or [REDACTED], and that evidence was located

inside the residence, I Detective Raquel Lopez completed a Statement of Probable Cause for Emanuel Martinez, H/M,

11-25-1997 charging Mr. Martinez with Aggravated Robbery. The Statement of Probable Cause was forwarded to the Identification Bureau.

Throughout this pattern, the suspect has used a knife, described in this case as a razor blade by victim.

**Probable Cause:**

On 08/24/19, at about 1044 hours, Officer Allen responded to 1200 E 8th ave on a robbery. Upon arrival, Officer Allen met with the victim, \_\_\_\_\_ who reported that a Hispanic male entered the store, jumped on the counter, pointed a knife at him and demanded the money. \_\_\_\_\_ refused and the suspect took the cash drawer and fled on foot. \_\_\_\_\_ described the suspect as a Hispanic male, late teens early twenties, wearing a \_\_\_\_\_ hoodie, jeans and gloves. The suspect dropped the knife and left it at the scene and that was collected.

This was the first case of the pattern dubbed "Sweet Tooth":


Through further investigation, a suspect named Emanuel Martinez 11/25/97 was developed, he was identified in a photo array in several of the robberies. Emanuel was arrested on 01/10/20 for Aggravated Robbery.

Detectives executed a search warrant for his home at [redacted] Rampart Way # [redacted] and recovered a [redacted] hoodie with [redacted] on the [redacted] with the words [redacted] on it, [redacted] jeans and a [redacted] knife.

After reviewing the video surveillance from this case, it appears to be the same coat worn in the robbery as the coat found in Emanuel home.

Please add the charge of Aggravated Robbery on Emanuel Martinez for this case.
