Statement of Probable Cause Affidavit for Arrest Warrant

On February 9, 2020 at 8:10 p.m. the Denver Combined Communications Center received a phone call from the suspect, Charlene KING dob: 03/09/1967, who reported that the victim, [REDACTED] dob: 04/[REDACTED]/1952, was deceased in their residence at 49 N. Clay St.; Denver, CO 80221. She further advised that she found a gun on the floor.

Detective Brian HUSUM 07049 responded to the scene and interviewed the suspect during the preliminary investigation. She related that she [REDACTED] [REDACTED] he gave written consent to search and process the scene.

Detective HUSUM observed the victim with a single gunshot wound under the eye. The wound did not appear to be a close contact type wound.

During the scene investigation, Detective HUSUM discovered voicemails on the victim's phone. The suspect called the victim and left a voicemail in which she tells the suspect [REDACTED] [REDACTED] The suspect leaves a second voicemail in which she tells the victim [REDACTED] Detective HUSUM asked the suspect if she called the victim prior to arriving at the house. The suspect [REDACTED] [REDACTED]

The suspect was detained and transported to Denver Police Headquarters for a follow-up interview. Detective HUFFINE attempted to interview the suspect and she declined to be interviewed.
