| I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 12/01/2018 at 11:30 pm at or near the location of 1500 N FILBERT CT in the City and County of Denver, State of Colorado. | | | | | |

The probable cause of the arrest of the above-named individual is as follows:
[On 12-1-18 Responding Officers in full uniform and marked patrol vehicle responded to 1500 block N Filbert Ct on a call of shots heard. This location is within the City and County of Denver.

On arrival in the area, Responding Officers heard several rapid fire gun shots and responded to the area of the gunshots. Officers identified the location of the apartment complex by the posted street sign of 1500 N Filbert Ct on the South facing door. Officers entered the location and announced themselves.

A black male in a dark sweat jacket and gray sweatpants surrendered himself at the second floor landing of the stairs; yelling "thank you for coming, I got him, I shot him and he is right there in my apartment room." This same male was detained immediately without incident by officers as other officers assisted with clearing the location and locating the victim.

The victim was transported to Denver Health Medical Center (DHMC) with a poor prognosis and was subsequently pronounced deceased by DHMC personnel. At this time the victim has not been positively identified.

The suspect identified himself as PIKES, MICHAEL 1-1-87 which was confirmed via CO I.D. PIN [REDACTED]. Denver 911 dispatch records revealed that Mr. Pikes was the initial 911 caller.

Defendant Pikes, Michael 1-1-87 was placed into custody on an Investigative Hold for First Degree Murder. During subsequent interview with detectives Defendant Pikes related he shot the victim several times because he thought the victim was armed.]
