I, Detective Mark A. Duran #99013, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person(s), are the following:

On 09-03-18, at approximately 1650 hours, Officers Mardie Perez #00042 responded to [REDACTED] N Raleigh Street, in the City and County of Denver on the report of a Burglary. Officer Perez met with the victim [REDACTED] who related the burglary occurred between Sunday, 09-02-18, at 2230 hours, and Monday, 09-03-18, at 0800 hours. The suspect cut the flaps on the doggy door attached to the rear door. The victim related the suspect took Bose Head Phones and a box of hardware, valued at \$360.00. The suspect fled through the point of entry.

The report related LP-1 (1A, 3A) were entered in to the Automatic Fingerprint Identification Sysytem where LP-1(1A) resulted in an AFIS hit to SID [REDACTED]. The latent print LP-1 (1A) was compared to the exemplars attached to SID [REDACTED]. This Colorado SID [REDACTED] is assigned to Agustin Guerrero (10-26-84).

Your Affiant obtained a DPD Police Photo #685391, who is the same person in the door ringer video.

Your Affiant called [REDACTED] who related she did want to follow through with charges.


