



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT  
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

I, Detective Rachel Eid P14001, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person, are the following:

On 03/23/19 at 9:43 a.m., Denver Police Officers were dispatched on a report of an assault that just occurred at W 33<sup>rd</sup> Ave and N Tennyson St, City and County of Denver, Colorado. Officer M. PEREZ 00024 completed a General Offense Report for an attempted sexual assault.

You Affiant was working in the Sex Crimes Unit and immediately assigned the follow up investigation. Your Affiant conducted and interview with the victim, [REDACTED] on 03/23/19 at 10:51 a.m. She started shaking and crying while talking about the incident. The victim reported she was walking north bound in the 3200 block of N Tennyson St. She noticed the suspect male behind her and motioned for him to pass but he would not. He continued to closely follow her from behind to W 33<sup>rd</sup> Ave. The victim became very uneasy and went east across the street on W 33<sup>rd</sup> Ave to get away from the male. As she approached the mouth of the alley on W 33<sup>rd</sup> Ave between Tennyson and Stuart St, she heard footsteps "running up" on her. She turned just as the same male grabbed her by her upper body. The victim had the distinct feeling of him trying to pull her towards the alley. During the struggle, the suspect made a "deliberate" grope on her right buttocks with his hand. He did not attempt to take the cell phone, purse or any other items that she had visibly on her person. She screamed and fought, and the suspect fled on foot southbound in the alley. The victim felt strongly that the suspect's intent was to sexually assault her. She called 911 immediately.

The victim had never seen the suspect before. She described him as a Hispanic male in his late 20s or early 30s with darker skin, "stubble" or short facial hair and a round face, less than 5'10" tall, medium build – a "little pudgy but not fat" or muscular. The victim said the suspect was wearing a dark colored, "charcoal or black" long-sleeved sweatshirt, brown or orange plaid "pajama" pants and possibly a black hat, unknown type.

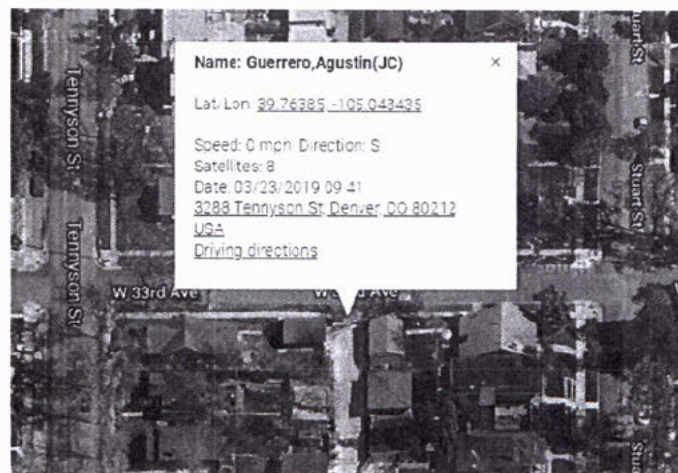
## AFFIDAVIT AND APPLICATION FOR ARREST WARRANT

Responding Officers conducted a neighborhood survey and located a private residence at [REDACTED] N Stuart St that had surveillance cameras in the alley. The cameras captured a struggle at the mouth of the alley and then the suspect's flight on foot, southbound. The Denver Crime lab responded and downloaded video of the incident. The time stamp was one hour ahead of current time. The video showed the incident occurred at 9:41 a.m. The video captured the suspect's image as he fled southbound in the alley.



Detective EID created a Denver Police Department Special Bulletin with the suspect's image and it was disseminated department wide. Detective EID was contacted by Crime Analyst Melissa OHLHORST, who stated she recognized the suspect as Agustin GUERRERO, from a previous case in 2018. Detective EID was also contacted by Detective Mark DURAN from District 1 investigations. Detective DURAN recognized GUERRERO as well from a 2018 case (2018-602449). Detective DURAN believed GUERRERO was on pre-trial supervision.

Detective EID contacted Denver County Probation Officer Lindsey DIXON. DIXON advised Agustin GUERRERO dob 10/26/84 was on pretrial supervision and currently wearing a GPS ankle monitor. DIXON advised that on 10/23/19 at 9:41 a.m., GPS put GUERRERO at the mouth of the alley on W 33<sup>rd</sup> Ave between N Tennyson St and N Stuart St.
