This listed defendant, Agustin Guerrero, d.o.b: 10/26/1984 did knowingly attempt to take items of value from the victim, [REDACTED], an adult female, and did use force when attempting to deprive the victim of her belongings, in violation of C.R.S 18-2-101 & 18-4-301, Criminal Attempt to commit Robbery, to wit:

Victim [REDACTED] reported that she was running north on the runners path, in Berkley Park, when an unidentified male suspect approached her from behind, grabbed her, and attempted to force Victim- [REDACTED] to the ground. Victim- [REDACTED] screamed at the assailant, that she is pregnant, and pushed the suspect away. Victim- [REDACTED] stated that she saw the suspect's face and later participated in providing descriptive details of the suspect, which resulted in a composite sketch being completed. Detective Duran positively identified the defendant as being involved a burglary case that he was assigned. The defendant was arrested and resembles the suspect that Victim- [REDACTED] described in her composite sketch. This Affiant interviewed the defendant and he admitted that he ran up behind Victim- [REDACTED] and grabbed her for the purpose of obtaining property or money from the victim. The defendant fled after Victim- [REDACTED] yelled at the defendant advising that she was pregnant. The defendant and Victim- [REDACTED] both advised that the defendant did not obtain any of her property before fleeing.
