



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**



Travondus Maurice Estes (07/07/88), a Black Male, 6'02" Tall, 249 Pounds, Blk Hair, Brn Eyes
Social Security # [REDACTED], Colorado Pin # [REDACTED]

For, C.R.S. § 18-3-302(3)(a), Second Degree Kidnapping, a Class 2 Felony, 18-3-402(4)(a), Sex
Assault by Force, a Class 3 Felony, 18-4-302(1)(a), Aggravated Robbery, a Class 3 Felony.

I, Detective Loretta Beauvais, #05120, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person, are the following:

On 11/09/20 at approximately 1015 hours, your Affiant was notified by District 1 Officer Manual Gomez 07080, via the Sex Crimes Hotline that a Sex Assault just occurred at [REDACTED] N. Federal Boulevard, Denver, Colorado. Officer Gomez stated that the victim, [REDACTED] was sexually assaulted by an unknown black male at gunpoint. The victim is [REDACTED] which is located at [REDACTED] N. Federal Boulevard. The victim also resides at that address with her husband. Your Affiant was told that the victim was being transported to Denver Health Medical Center (DHMC) located at 777 Bannock Street, Denver, Colorado to complete a SANE exam. Your Affiant responded to DHMC to interview the victim. The victim related the following:

- That the suspect entered the business on 11/09/20 at approximately 0950 hours. He was asking about a massage. The victim took his body temperature. The suspect pulled out his gun. The victim stated that she had just opened for business and did not have any cash on the premises. The suspect asked the victim for money and the victim gave the suspect \$40. The suspect continued to point his gun at the victim and asked the victim to kneel down and put her hands on her back.
- The suspect asked the victim to go into Room [REDACTED]. The suspect took off all the victim's clothes and raped her at gunpoint.
- The victim was asked if the suspect was a previous client and if she knew this person, or if he is a new client. The victim stated that the suspect was someone she did not know and had not seen him before.
- The victim was asked if the suspect was alone and if there was anyone else who saw what happened. The victim stated that the suspect was alone and, she was there by herself. The victim and suspect were the only two at the business on the [REDACTED]

- The victim was asked if she gave the suspect consent to have sex with her; if she wanted this to happen to her; was she ok with having sex with the suspect. The victim stated no. That the suspect was using his gun and pointing it at the victim's head, as he was trying to rip off the victim's clothes. The victim stated that she resisted as best she could, but the suspect pointed the gun at her head and pushed her against the wall. The victim was adamant that she did not give consent to be sexually assaulted.
- The victim signed the Consent to Search form to allow DPD to collect the evidence left by the suspect in [REDACTED] N. Federal Boulevard.
- The victim [REDACTED]
- The items that were left behind at the scene at [REDACTED] N. Federal Boulevard were confirmed by the victim - Jacket, gray sock, bed sheets and white towel.
- The suspect and victim went into the massage room and the suspect pushed the victim to the wall, held a gun to her head and told her to take off her clothes. The victim removed her jacket, and most of her clothing items. The suspect took off the victim's pants and penetrated the victim's vagina orally, digitally and penile penetration. No objects were used.
- The suspect did not wear a condom. The suspect ejaculated on the massage bed and used a white towel to clean himself off. The suspect left the towel on the massage bed. The victim told police that a jacket, a sock and towel were left on the massage bed. The jacket and sock belong to the victim, the towel was used by the suspect to clean himself after the sex assault.
- The victim stated that she did not want to make the suspect mad because he had a gun and was a big man. The victim described the gun as being black and held her hands to indicate the length of the gun (approximately 6" in length). The victim stated that the suspect showed the victim there were bullets in his gun.
- That the suspect is described by victim as follows: Black male, "fat" 1.8 meters high (approximately 5'11" tall), black hat, blue jacket, sweat pants, beard, 40-50 years old.

On 11/10/20, your Affiant received the SANE kit and clothing items from the victim's SANE exam on 11/09/20. Your Affiant placed those items in the DPD Property Bureau. The DNA request was completed to the DPD Crime Lab and the analysis was expedited for the following items:

- The victim's SANE kit
- The towel left on the bed with suspected semen.
- A tissue with suspected semen.

On 11/13/20, the DPD Crime Lab notified your Affiant that the male DNA profile that was obtained from the towel stain sperm fraction resulted in a CODIS hit to Colorado offender Travondus Estes, dob: 07/07/88. Your Affiant conducted a DQ search of the National Crime Information Center for possible identification of Estes and the search revealed that the suspect possesses a valid driver's license with Colorado Pin # [REDACTED] issued on 09/23/20. The DL photo was that of a black male with a beard and physical descriptors that show that Estes is 6'02 tall and 240 pounds.

Your Affiant presented the victim with a 6-photo array. The victim did not pick the suspect but did pick a black male in the array with 85% confidence that strongly resembled the suspect.

AFFIDAVIT AND APPLICATION FOR ARREST WARRANT

Based on the aforementioned information, your Affiant respectfully requests that a probable cause arrest warrant be approved for the suspect, Travondus Estes (07/07/88), for Second Degree Kidnapping, a class 2 Felony, Sex Assault by Force, a class 3 Felony and Aggravated Robbery, a class 3 Felony.
