The probable cause of the arrest of the above-named individual is as follows:

[Investigation disclosed that on 1-6-2021 at approximately 1702 hrs, while the victim peace officer- on duty, wearing full department uniform- was conducting official police business at 620 N Federal Blvd- within the City and County of Denver, State of Colorado- the defendant: Esquibel, Alicia 9-9-1982 approached the officer from behind, produced a knife and stabbed the officer upon his chest/torso multiple times resulting in serious bodily injury. The defendant was taken into custody on scene with the use of non-lethal force. Defendant was identified on scene by use of mobile fingerprint analysis.]
