



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

Eric Patrick Brandt D.O.B. 11/19/1971 Described as a white male, 5'09", 220 lbs, brown hair and brown eyes. Colorado PIN# [REDACTED], S.S.N. [REDACTED], FBI# [REDACTED], CO SID# [REDACTED]. Last known address: 1315 Estes St #18 Lakewood, CO

**For: Retaliation against a judge, C.R.S. 18-8-615 Class 4 Felony
Harassment, C.R.S. 18-9-111 Class 3 Misdemeanor**

I, Detective Brian Marshall P06084, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

On 12/18/2019 at approximately 11:00 AM, the Honorable Judge [REDACTED] was the judge at courtroom [REDACTED] at the Lindsey Flannigan Court House located at 520 W Colfax Ave in the City and County of Denver. On the docket was a defendant who is a member of "Extinction Rebellion" which is an environmental group that participates in non-violent civil disobedience. Another protest group known as "Occupy Denver" was also present outside of courtroom [REDACTED]. The courtroom was in session and the court was in the process of jury selection. Members of Occupy Denver were causing a disturbance that was described by Officer [REDACTED] statement as "Yell, intimidate, and scream at jurors walking into the courtroom and exiting the courtroom."

Upon learning of the incidents, Judge [REDACTED] ordered the Denver Sheriffs remove all of the parties involved. Two members of Occupy Denver identified as [REDACTED] ([REDACTED]) and [REDACTED], [REDACTED] ([REDACTED]) were eventually arrested for trespass after refusing to leave. Both [REDACTED] and [REDACTED] are close associates of Eric Brandt (11/19/1971). Brandt has been and is currently living at [REDACTED] house. [REDACTED] and Brandt have been documented together in previous protests and criminal cases.

On 12/18/2019 at approximately 12:12 PM, [REDACTED] received a phone call that identified the caller on the phone display as Eric Brandt ([REDACTED]). [REDACTED] is the Judicial Assistant for Judge [REDACTED] courtroom, [REDACTED]. Brandt is a member of Occupy Denver and is known for making calls for lawlessness in the form of the random shooting of judges and police officers through videos on his Youtube.com channels. The following is a dictation of the conversation that occurred:

Brandt: Hi, this is Judge [REDACTED] court room, right?

[REDACTED]: That's correct

Brandt: Yeah I wanted to share my thoughts and prayers for Judge [REDACTED]. It's my thought that Judge [REDACTED] should be violently murdered and have brains blown through his head and it's my prayer that someone actually does it. Would you be sure to share that thought and prayer with the judge.

[REDACTED]: And who is this calling?

Brandt: I'm one of the people. Do you need to know any more than that? Do you need to know any more than that? I'm one of the people. And all my calls are recorded for my safety. So...

█: I'm sorry you still haven't given me your name
Brandt: Oh I'm sorry, am I required to give you my name for you to pass that message along?
█: Well I'd like to let him know who called
Brandt: Oh you would? Tell him Occupy Denver called
█: Is that who you are?
Brandt: No, but you can tell him that anyway. So it is my thought that Judge █ should be violently murdered and have his brains splattered all over the face of his children. And it's my prayer that some mother fucker actually does it. Do you have any more questions? Kill kill kill, all judges should die. Kill kill kill kill kill kill kill. Do you have any questions? I'm asking you a question. Do you have any questions?
█: No, if you'd like to repeat that, please do.
Brandt: Oh yes, I wanted to share my thoughts and prayers for Judge █. My thoughts are that Judge █ should be violently murdered and my prayers that some mother fucker actually does it.
█: Okay. Is there anything else?
Brandt: No no I think that pretty much says it all.
█: Okay, Mr. Brandt is there anything else I can do for you today?
Brandt: I never identified myself
█: I know your voice you've come into our court room before
Brandt: Hmm, yeah well what are you going to do about it? Not a damn thing, huh?
█: I don't have to do anything about it
Brandt: Nope, you don't. You don't. I get to share my thoughts and prayers
█: Sir is there anything else you want me to tell him?
Brandt: No, I think that pretty much..yeah yeah I do. I think he could save the world a lot of trouble by just shooting himself. How about that? You can share that with him. I think that's about it.
█: Okay, have a good day.
Brandt: bye

█ recorded the conversation and notified Judge █ who listened to the message. The message caused Judge █ alarm for his personal safety and that of his family. Judge █ called his wife to notify her and the message caused her alarm and distress.

On 12/19/2019, Your Affiant was made aware of another Youtube video that Brandt posted on his channel "The real Mr. Brandt". The video was titled "Planned Protest for Judge █ Residence" Brandt discusses the arrest of █ the previous day and at approximately 2:55, the video skips and says "His home address and Judge █ home address".

On 12/20/2019, Your Affiant was notified by █ of another video on a Youtube Channel called "Munkay83" that is operated by a Brandt associate, █. The video is titled "Call from █ in jail". Your Affiant watched the video and noted several points of the video.

- At approximately minute mark 7:13, Your Affiant observes the same recorded conversation of Brandt's phone call to █ is played over a phone.
- At minute mark 7:29, Your Affiant observes the name "Chilled Speaker" on the phone screen. Your Affiant knows that Brandt uses the pseudonym "Chilled Speaker" on his email account █@gmail.com.

- At approximately minute mark 16:10, [REDACTED] states "Judge [REDACTED] needs more than BAR complaints, unless those BAR complaints are made with a Browning Automatic Rifle.
- At approximately minute mark 16:20, [REDACTED] ([REDACTED]) states "Him and his daughters and his fancy wife living in Stapleton" to which [REDACTED] replies "and you can't fucking pay for any of that with a fucking Browning Automatic Rifle pointed at you.
- Your Affiant noticed that one of the chat log participants was Brandt from his channel name "The real Mr. Brandt"

On 12/21/2019, Your Affiant was contacted by Lieutenant Ed Hall who was notified that Judge [REDACTED] was aware of another video that Brandt had posted titled "The sophisticated palette of Rusty Roo-and the next protest". At approximately minute mark 6:54, Brandt states "We're going to come down through Torrington and Lusk and hit Cheyenne (WY) where Judge [REDACTED] parents live. So, um, I'm going to stop by and have a little chat see with, with huh [REDACTED]."

Your Affiant spoke with Judge [REDACTED] over the phone and he told Your Affiant that Brandt has made a previous video on his Youtube channel in which Brandt states that Judge [REDACTED] should "kill himself" and that Judge [REDACTED] would "look best hanging from a tree". Those statements were never directly made to Judge [REDACTED] but Judge [REDACTED] did learn of them and they too caused him and his family alarm. Brandt made that video in response to Judge [REDACTED] sentencing of another member of Occupy Denver and associate of Brandt, [REDACTED] ([REDACTED]) to 30 days jail time for contempt of court on 09/27/2019.

Your Affiant asked Judge [REDACTED] if he felt harassed by the comments and he stated "Yes". Judge [REDACTED] told Your Affiant that Brandt's statements caused him to immediately notify Denver Police District 5 officers for extra patrol around his house and to call his wife. Judge [REDACTED] stated in his written statement "I can't even begin to tell you how this made me and my family feel".

Summary:

Your Affiant has reason to believe that probable cause exists for the arrest of Eric Brandt. Brandt has intentionally harassed, annoyed, and caused alarm to Judge [REDACTED] with his direct and indirect communications through telephone and computer network in a manner intended to harass and threaten bodily injury. Brandt is conveying these messages to Judge [REDACTED] in retaliation to Judge [REDACTED] serving in a legal manner of Brandt's associates, [REDACTED] and [REDACTED] in the Lindsey Flannigan Courthouse at 520 W Colfax Ave, Denver, CO 80204.
