EMS responded and the adult female was pronounced dead at the scene at 4:39 pm by Denver Health Medical Center (DHMC) Doctor McVaney. Officers also found a still asleep and unharmed in the apartment. All were transported to the hospital for examination and treatment. The victim was tentatively identified as dob: 6/2019. Your Affiant, Detective Jami Sisneros and Detective John Meoni 94005 of the Denver Police Homicide Unit were called out to begin the investigation. Your Affiant and Detective Meoni arrived at the scene and from the front door area your Affiant could see the body of the victim and a black colored shotgun lying on the front living room floor. Officers who cleared the apartment informed Your Affiant they saw a knife in the family room and a case for rifle or shotgun in an upstairs bedroom.
