Statement of Probable Cause       Affidavit for Arrest Warrant

On 09/22/20 Denver Police received a call to the location of E. 7<sup>th</sup> Avenue and York St. in Denver Colorado on a report of a Threats and Weapon complaint. Officers arrived on scene and located several victims. The victim #1 ID as [REDACTED] said he was standing at the corner of E. 7<sup>th</sup> Avenue and York St. holding up sign in support of candidate Joe Biden for president. The victim [REDACTED] said a white male suspect in a black Porsch stopped where he was standing and began arguing with him about his political affiliation.

The victim [REDACTED] said the suspect remained in a lane of traffic and would not drive when the light turned green. The suspect continued to argue and honk his horn at other motorists. The victim [REDACTED] said that another victim ID as [REDACTED] saw what was happening with him, and came up and began arguing with the suspect asking him to drive away. The victim [REDACTED] said at one point, [REDACTED] kicked the suspects car.

The victims said the suspect drove away in his Porsche and parked. At this time another victim #3 ID as [REDACTED] said she was roller blading and saw the suspect park his black Porsch. The victim [REDACTED] said she took a picture of the Porsche and got the license plate attached. The license plate is Colorado Temp Tag# [REDACTED]

The suspect then walked up to where the victims were standing and began arguing with them again. The victim [REDACTED] said the suspect argued with her again and spit on her and called her a [REDACTED].

The victim [REDACTED] said that the suspect then said he was going to get his AR15 and would be back and [REDACTED]

All the victims said as they continued standing at the location, the suspect returned in a different vehicle described as a black Land Rover. The victims said the same suspect drove by them and from the front passenger side of the vehicle, pointed at them out the window what is described as a "long gun" or "machine gun".

The victims said they were in fear for their lives. The victims said the suspect drove away and they called the police. Officers also contacted a witness ID as [REDACTED] [REDACTED] said she was out walking his dog when he saw the black SUV pull up to where the victims were standing and point what he called a "machine gun" out of the window and towards the victims.

Your affiant was assigned this case for follow up investigation. Your affiant checked the Temporary plate registration for the suspect vehicle (Porsche). The plate is registered to a Shahir Ahmed who lives at 800 N. York St. in Denver Colorado.

Your affiant prepared a photographic array containing suspect Shahir Ahmed. The suspect Ahmed ws randomly placed in position #5.

Your affiant arranged for the victims [REDACTED] and [REDACTED] to come to Denver Police District Two to view the arrays. The victim [REDACTED] responded to view the photographic array. The array was shown by Detective Robert Salazar. The victim [REDACTED] identified position #5 as the suspect in this case.

The victim [REDACTED] also responded and viewed the photographic array. The array was shown by Detective Tevonnon Jones. The victim [REDACTED] identified position #5 as the suspect in this case.

Based on the above information your affiant respectfully requests that this arrest warrant be approved for the suspect ID as Shahir Anwar Ahmed (09/07/80) for the charges of Felony Menacing with a Gun and Harassment.
