



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

Madeline Ann Cramer (02/26/1995)

Described as a White female, 5'05", 175 lbs, black hair, hazel eyes.

LKA: 1269 N Ogden St, Denver, CO 80218

- For Criminal Mischief, C.R.S. (18-4-501 (4)(c) (Class 5 Felony)
- Bias Motivated Crime, C.R.S. (18-9-121) (Class 1 Misdemeanor)

I, Detective Brian Marshall P06084, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

On 10/10/2021 at approximately 7:40 AM, an unknown suspect drove the suspect vehicle bearing CO# [REDACTED] and parked in front of 406 E Colfax Ave on the South curb line. The suspect exited the vehicle and walked across the street to 1535 N Logan St (Cathedral Basilica of the Immaculate Conception). The suspect the proceeded to spray red spray paint on the building and statutes of the church grounds. The following are what was spray painted:

- Upside down cross
- Wording "Child rapists faggots"
- Wording "Suck my dick"
- Wording on statute "Small dick" and "Satan" "Love wins"
- Swastika (maybe) on the door
- Wording "White supremacists"
- Working "KKK"
- Illuminati and an eye symbol
- Wording "Jesus was here"
- Wording "Let my children free"
- Wording "Satan Lives Here".

While the suspect was committing the crime, she was confronted by a church goer, [REDACTED] ([REDACTED]) who questioned her motivation. Eventually the suspect ceased her actions and then walked back to her vehicle with the spray paint can and left in the car going East bound on E Colfax Ave.

The suspect was wearing a black brimmed hat, black shirt, black skirt and black shoes.

The specific messages and symbols are consistent with anti-Christian bias and caused the church to believe they were targeted because they are of the catholic faith.

Officer Stephen Marino located a fire extinguisher at the scene which the suspect was reported to have handled and Officer Marino took custody of the fire extinguisher and placed it into evidence.

██████████ estimates the damage to be approximately \$10,000 but won't have the accurate number until they are billed for the clean up.

Your Affiant was assigned DPD GO#2021-581125 for following up investigation.

Your Affiant viewed DPD HALO video of the incident and noted that the car was a white or silver Kia Soul with black hood, front driver fender, and tail gate. Your Affiant noted that there were several stickers on the back window. Due to the distance of the video quality, Your Affiant was unable to read the license plate.

On 10/10/2021 at approximately 11:05 AM, Your Affiant went into the business at ██████████ (██████████) and inquired about their surveillance cameras. Your Affiant spoke with ██████████ (██████████) over the phone and he was able to remotely observe the surveillance cameras. ██████████ provided Your Affiant with two screen shots of the suspect vehicle and eventually of the actual surveillance footage. Your Affiant was able to read the license plate and notice that it was a Colorado passenger plate bearing # ██████████.

Your Affiant queried the plate in the Colorado DMV database and found the plate listed to Cramer, Madeline with an address at 6920 W Princeton Ave, Denver, CO 80235.

Your Affiant made contact with the witness ██████████ who agreed to come to the Police Administration Building to view a photo line-up. ██████████ stated he was confident on his selection of one of the filler photos and not of the suspect.

Your Affiant queried Cramer in a metro wide law enforcement database and noticed an address listed for her at 1269 N Ogden St, Denver, CO as a possible location that Cramer and the vehicle might be at. At approximately 3:00 PM, Your Affiant drove by the address and noticed the car was parked on the West curb line. Your Affiant noted that the car was unoccupied. Your Affiant called for uniform patrol officers to assist and while waiting, Cramer, Madeline (02/26/1995) entered the vehicle and attempted to drive away. Cramer was contacted and briefly arrested for an outstanding felony warrant from Fremont County, CO. Due to COVID-19, Fremont County denied extradition. During the arrest, Cramer called one of the arresting officers '██████████' Your Affiant removed Cramer's purse, phone, and cigarettes from the vehicle and transferred the custody to Cramer. The remainder of the car was not disturbed. She was released from the scene and the vehicle was impounded in anticipation for a search warrant.

Your Affiant authored a search warrant for the vehicle which was approved by the Honorable Judge Tanja Wheeler on 10/12/2021 at 11:56 AM.

On 10/13/2021 at approximately 8:14 AM, Your Affiant executed the search warrant for the Kia Soul at the Denver Police Impound Facility at 5160 N York St. The vehicle was located in row 7 space 15. During the search the following evidentiary items were located:

Based on the facts that Cramer's car was observed arriving and leaving the scene with no other occupant entering or exiting, the description of the suspect matches Cramer's description, and the evidentiary items were located during the search warrant, Your Affiant believes that probable cause exist to issue an arrest warrant for Cramer, Madeline (02/26/1995) for felony criminal mischief and bias motivated crimes.
