I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 11/20/2022 at 12:30 am at or near the location of 7525 E HAMPDEN AVE in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:

On 11/20/2022 at appr 0054 hrs I was working as car 363B in a fully marked Denver PD cruiser and uniform. I was dispatched to 7525 E Hampden Ave, Hotel Embassy Suites DTC on a sex assault call that was called in by hotel staff. This location was and is in the City & County of Denver, State of Colorado.

I contacted the victim in room [REDACTED] and identified her as [REDACTED] (DOB [REDACTED]). She stated that [REDACTED], identified as Begay, Stevenson (DOB 12/16/1975), was the suspect. She stated that [REDACTED] stayed in her room after her [REDACTED] came to her room for drinks. She stated that she told Begay on several instances that she was uncomfortable with him being in her room and that at one point he removed his shirt and she messaged two coworkers that she was uncomfortable and to come help her.

The coworkers, [REDACTED], [REDACTED] and [REDACTED] stated that they knocked on her door at room [REDACTED] and that Begay answered, shirtless and intoxicated, and told them that he would leave, that everything was fine and that he then shut the door. [REDACTED] said that he then grabbed her by the shoulder and pushed her into the bedroom, taking off his clothes and then undressing her. [REDACTED] stated that she told him she was uncomfortable and that she didn't want to do this and that Begay told her that [REDACTED] and that he pulled her onto his bed, grabbing her by the breasts and kissing her face, neck and breasts against her will.

[REDACTED] stated that the [REDACTED] came into the room with the [REDACTED] as Begay was rubbing his genitals against her thigh and that they grabbed her from the bed and helped her leave the room.

Witness statements were collected from the [REDACTED] and the [REDACTED] and [REDACTED] was transported to DHMC for a SANE Exam. Begay was taken into custody without incident and transported by DHMC 75, Cebina, to DHMC on an investigative hold.
