AFFIDAVIT AND APPLICATION FOR ARREST WARRANT AND THE ARREST WARRANT FOR THE PERSON(S) OF:

Jaycin Diamante ROBINSON (03/29/2005), for C.R.S. 18-3-102, Attempt Murder in the First Degree, Class 2 Felony.

I, Detective Rigoberto Gomez #00120, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person(s), are the following:

On March 27, 2023, Your Affiant received a case for Aggravated Assault – Shooting (Denver Police Department Case #2023-157728. Your Affiant is currently assigned to the Denver Police Firearm Assault Shoot Team (F.A.S.T.).

On March 27, 2023, at approximately 7:07 a.m., Denver 911 received a call of a shooting at E 56th Avenue, Suite in the City and County of Denver, State of Colorado. This address is located near the intersection of E. 56th Avenue and N. Dallas Street. A warehouse business building called is located at this address, and the victim is a suffering from a gunshot wound to the left side of her head. The victim was transported to University Hospital by ambulance.

Officers quickly learned through surveillance footage provided by management that the suspect drove a Silver Honda CR-V with temporary Colorado and stopped at the intersection of E. 56th Avenue and N. Dallas Street, facing eastbound on E. 56th Avenue. The suspect is seen getting out of this vehicle leaving it at the intersection and ran across the street towards the warehouse (management).

Footage shows that about the same time, the victim pulled up to the warehouse on the north side of the building facing E 56th Avenue. The victim got out of her vehicle and started walking toward the back door where employees come in and out for breaks. The footage shows the suspect walking up behind the victim as she is about to enter the building. The suspect confronted the victim at gun point and fired two shots, striking the victim once on the left side of her head. The suspect then ran eastbound through the parking lot.

Several witnesses in the building heard two gunshots, looked outside the window and the saw the suspect drop his gun as he was running. The suspect then came back to pick up his gun and continued running. The witnesses described the suspect as a young Black male with a red face mask, wearing a black jacket over a grey hoodie, black pants. and black shoes.

Officers learned that the vehicle the suspect was driving and left abandoned at the intersection of E. 56th Avenue and N. Dallas Street, a 2020 Silver Honda CR-V, bearing temporary Colorado was a reported stolen out of Colorado Springs, Colorado on March 22, 2023. The vehicle was seized as evidence towed to the Denver Police District One Substation for processing.

Officers recovered a black jacket hidden behind a trashcan by the front doors of E 56th Avenue which is the building east of E 56th Avenue. Officers were able to obtain surveillance footage from E. 56th Ave and observed the suspect taking his jacket off, hiding it behind the trashcan and then continued walking eastbound through the parking lot. The surveillance footage captured the suspect's likeness.

The Denver Police Department Crime Scene Unit (CSU) responded to the scene where they located two 9mm shell casings and a fired bullet near where the victim fell to the ground. The two shell casings that were located corroborates the statements from several witnesses hearing two gunshots. CSU personnel also process the jacket found at E 56th Avenue and found a "Honda" key fob in the front left jacket pocket.

Your Affiant responded to the hospital and briefly interviewed the victim. The victim stated that as she was trying to get into the building, she was approached by a guy with a gun. The suspect pointed the gun at her face and told her to give her all her things. The victim told the suspect she did not have anything. The suspect then grabbed her backpack and shot her. The victim heard a loud bang and she screamed and fell to the ground.

The victim remembered the suspect as being dark complected but did not remember what he was wearing. The victim was scared as the suspect put a gun to her face.

The victim could not remember anything else at this time.

On March 27, 2023, Your Affiant issued a Crime Stoppers Bulletin picturing the suspect as seen on surveillance footage after the shooting.

On March 28, 2023, Your Affiant responded to the Denver Police District One Substation, 1311 W. 46th Avenue along with CSU personnel to process the 2020 Silver Honda CR-V.

A 9mm shell casing was recovered from under the front passenger seat. An empty bag of chips located on the front driver's seat and a cup with a lid and straw located in the front driver cupholder.

Your Affiant requested that the empty bag of chips and the cup be tested for fingerprint analysis by the Denver Police Crime Lab.

On March 29, 2023, Your Affiant received the fingerprint results from the Crime Lab identifying the prints to a Jaycin Diamante ROBINSON, d.o.b. (03/29/2005), State Identification Number (SID)

AFFIDAVIT AND APPLICATION FOR ARREST WARRANT

Your Affiant searched the above name and d.o.b. on several Denver Police Department databases and located a facial photo of a young Black male under the name Jaycin Diamante ROBINSON, d.o.b. (03/29/2005). The photo resembles the facial physical description of the Black male suspect seen on surveillance footage the day of the shooting.

Your Affiant also ran Jaycin Diamante ROBINSON, d.o.b. (03/29/2005) through the National Crime Information Center (NCIC) database and found an active felony arrest warrant for Mr. ROBINSON for "Escape from Custody Menacing" out of Colorado Division of Youth Services, Warrant #: OCA/23DYS0033, Date of Entry (DOE), March 29, 2023, Date of Violation (DOV), March 26, 2023.
