



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT  
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

Karl SANCHEZ 09/19/197018-6.5-203(6)(a) caretaker neglect resulting in Bodily injury  
Class Six Felony

I, Detective Ken KLAUS 85015, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

On December 25 2021, in the early morning hours, elder victim [REDACTED] (76 years old) was transported to Denver Health Medical Center 777 Bannock Street Denver Colorado by her new caretaker [REDACTED].

The victim was seen by Doctor [REDACTED] described the following injuries of the victim. The victim is suffering from [REDACTED]. Doctor BLOEMAN stated there were several injuries that were observed on the victim which were documented.

On December 25 2021 at 1350 hours Officer Katherine URBINA 13022 responded to Denver Health Medical Center for an adult report called in by Doctor [REDACTED] for the elder victim, [REDACTED]. Officer URBINA saw [REDACTED]. Doctor [REDACTED] called the bruise suspicious for abuse. The victim was extremely thin from malnutrition.

On December 28 2021 Detective KLAUS received a call from Doctor [REDACTED] geriatric specialist. Doctor [REDACTED] stated she was interviewing the new caretaker, [REDACTED]. [REDACTED] shared texts sent to her by [REDACTED] and POA, Karl SANCHEZ. The emails were threatening towards Doctor and Nurses at Denver Health.

Your Affiant scheduled an interview with [REDACTED]. During the interview [REDACTED] described how she first met the elder victim, [REDACTED] on December 18 2021. [REDACTED] stated KARL was uncomfortable giving [REDACTED] a bath and [REDACTED] volunteered to give the bath. Karl said [REDACTED] was intentionally soiling herself and wetting the bed on purpose. Karl would get agitated when the conversation came to [REDACTED] soiling herself. [REDACTED] responded to the house, [REDACTED] West 1<sup>st</sup> Avenue. It was her first time in the house. The house was clean except for the room where [REDACTED] was. There was the overpowering smell of urine and defecation coming from the bed where [REDACTED] was. The rug below [REDACTED] was also full of crusted waste. [REDACTED] was laying in a bed full of crusted waste. [REDACTED] stated she moved [REDACTED] to the bathroom and helped [REDACTED] take her clothes off. [REDACTED] washed [REDACTED] except for her genital area which [REDACTED] cleaned. [REDACTED] said that [REDACTED] was yelling out in pain as [REDACTED] had her arms around [REDACTED] midsection.

On December 23 2021, in the early morning hours [REDACTED] came over to [REDACTED] house. She brought sheets for [REDACTED] bed. [REDACTED] found [REDACTED] laying on her back with her head trapped under the

box springs (VIDEO RECORDED ) After bathing [REDACTED] and cleaning up again [REDACTED] placed an adult diaper on [REDACTED] [REDACTED] found a large bruise on [REDACTED] right arm around the elbow which looked like a hand print.

On December 24 2021 [REDACTED] showed Your affiant text messages between her and Karl. Karl is becoming more and more agitated with [REDACTED] and drives over to see [REDACTED] [REDACTED] is able to convince Karl that [REDACTED] can take [REDACTED] to the hospital. [REDACTED] found that the same diaper was on from Thursday morning.

[REDACTED] related that she texted with Karl while in the hospital. Karl complained about being left alone on Christmas eve. HE was told to come to the hospital and be with [REDACTED]. Karl ignored that request.

On December 25 2021 at 230 am [REDACTED] informed Karl that [REDACTED] had [REDACTED]. Karl became very angry in his texts to [REDACTED] saying that doctor and nurses at Denver Health had killed [REDACTED]. Karl said that he wanted the names of the doctors and nurses and would be going the hospital to take care of business. Karl said that he had 250 rounds and would take as many with him as possible.

[REDACTED] said that he knows that Karl has at least one gun, a Ruger 380 she sold to him about two months ago. Karl keeps the gun on his desk next to his meth pipes that he smokes. [REDACTED] stated that Karl does not work and is always at the house. He is the victims Power of Attorney.

On December 29 2021 Detective KLAUS took an image only of Karl SANCHEZ 09/19/1970 to [REDACTED] for her to view. She said that is Karl.

Based on the above facts Your affiant is requesting that an arrest warrant be issued for Karl SANCHEZ 09/19/1970 for caretaker neglect resulting in bodily injury, a class six felony.
