**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT

I, Detective Levert C. White (72098), the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

On March 2, 2000 the Denver Police were called to the location of 3000 E. 1st Ave on a Aggravated Robbery. Which is located in the City and County of Denver Colorado. The reporting officers contacted [REDACTED] who related the defendant approach the victim and displayed a handgun, had her get in the driver's seat of her vehicle. The suspect got into the passenger seat. The suspect then had [REDACTED] drive to a nearby bank, where she was ordered to write a check for \$1000. [REDACTED] related that after giving him the money she was instructed to drive him to a stripmall shopping center, where the defendant got out of the vehicle and fled on foot taking the victim's money.

Your affiant received information from Arapahoe County Sheriff Dept, that they had a party who fits the description of the suspect. A photo line-up was prepared by Arapahoe County, with the defendant's photo in position #3. [REDACTED] was contacted and requested to come to the Robbery Unit to view the line-up. On 03/11/00 [REDACTED] read the admonition and was shown the line-up where she picked number 3 as being the party who pointed a silver automatic handgun at her and demanded that she take him to the bank to give him money.

03/11/00 your affiant interviewed the victim who verified the facts of the Robbery, she stated she was not armed at the time of the robbery. Det White verified the identification of the defendant who was identified as JASON HOGAN through the photo line-up.

This case was presented to the complaint DA K. O'Brien of the District Attorney's Office, who after reviewing the facts of the case the case was accepted for the Filing of Aggravated Robbery and Kidnapping.

Due to the nature of the Robbery and the fact that a weapon was use your affiant requests a warrant be issued for the Defendant Jason Hogan.
