 I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 9/29/21 at 12:09  am  pm at or near the location of 2285 S. Marion Street in the City and County of Denver, State of Colorado.

Statement of Probable Cause       Affidavit for Arrest Warrant

On September 29, 2021 at approximately 12:09 a.m. the Denver Combined Communication Center received a phone call regarding a domestic violence situation. The complainant stated that his neighbors, Katie and Matt, who live [REDACTED] to the [REDACTED] of him are having a domestic. The complainant stated that he could hear Katie yelling "get out, get out" and then it stopped. He stated that he believes Matt hurt her because he doesn't hear Katie anymore. The complainant stated that he thought he heard Matt say "I'm a murderer". The complainant stated that the couple is estranged. The complainant described Matt as a bigger White male from South Africa and he drives a white PT Cruiser. The complainant stated that there are two children that live in the home but he hasn't heard them.

The Denver Combined Communication Center received another call regarding 2085 S. Marion Street. The caller, Matthew Madden, dob: 02/17/1985 stated that "I killed my wife and the neighbor". When Mr. Madden was asked when that happened, he stated that he killed them right now and he used a knife. He stated that the knife was still in his hand. Mr. Madden stated that he smoked an adderal and had 3 bottles of wine tonight and that he's bi-polar. He described himself as a 36 year old White male with a heavy build and has a beard and mustache. He stated that he's wearing slacks and a tee-shirt. Mr. Madden stated that his wife is Katherine Pivoda and she was born on April 18, 1988. He stated that he doesn't know the neighbors name. Mr. Madden stated that he wants to get the Police there so they can take care of his kids. He described his Last Will and Testament and stated that he wants the kids to go to his sister and brother in law. Mr. Madden stated that there are two kids in the home that are 10 months old and 4 years old. Mr. Madden stated that he doesn't want to go to prison and that he'd prefer to end his life. He stated multiple times to take care of his children. Mr. Madden stated "I'm a murderer" and eventually hangs up the phone.

Denver Police Officers arrive at 2085 S. Marion street at approximately 12:19 a.m. They are confronted with a male that is holding a knife and is bloody. The male, later identified as Matthew Madden, dob: 02/17/1985 was given commands to drop the knife but he refused. He was tased and once under control, transported to Denver Health Medical Center for treatment. Mr. Madden appeared to have lacerations to his neck, chest and arms. Once at the hospital, Mr. Madden was taken into surgery and said to be in critical condition.

Officers searched the home for possible victims and located two females in the backyard suffering from what appear to be multiple stab wounds. Both women were pronounced deceased at 12:30 a.m. by Dr. [REDACTED]. Officers also located two children sleeping inside the house.

Detective Sisneros interviewed [REDACTED], the 911 caller. [REDACTED] confirmed the information that he provided to the dispatcher. In addition, he stated that he heard Katie yelling for about 20 seconds to a minute. He put on some shorts to go over to their house but then he could no longer hear Katie. He went to the other bedroom which is closer to Matt and Katie's house and opened the window. He heard Matt crying and sobing and thought he heard Matt say "I'm a murderer". [REDACTED] stated that Matt and Katie moved into that house within this last year. He stated that Matt hasn't been living there and moved out sometime around July of this year. [REDACTED] described Matt as a bigger guy, 6', 200 pounds with facial hair. He stated that Matt is from South Africa and has a distinct accent. [REDACTED] stated that he knew it was Matt talking because of his accent. He also stated that Matt drives a PT Cruiser.

Detective Sisneros interviewed [REDACTED], the [REDACTED] [REDACTED] stated that she woke up to someone screaming and saying "get out". She believed this person to be Katie, her neighbor from next door. She stated that she thought the screaming was coming from outside. She then heard Matt sobbing. She said she could tell it was Matt because of his South African accent. [REDACTED] stated that Matt and Katie moved into their house in Spring of 2021. She stated that Matt moved out around the beginning of summer. She stated that when she got home from work today around 3 or 3:30, Matt was at the house.

Based on the above stated information Detective Sisneros believes that probable cause exists for the charge of: (2) counts of 18-3-102 (1)(a), 1st Degree Murder, a class 1 Felony.
