



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**



Jamal Yassin Gamal, 10/08/1993, 6-01, 185 lbs.

For: C.R.S.18-18-405(1), (2)(c)(V), (2)(a)(III) Distribution of a Controlled Substance – Fentanyl – less than four grams – Resulting in Death, DF1.

Your Affiant Detective R. Jason Brest, #98034, currently employed by the Denver Police Department and assigned to the Denver Police Department Fentanyl Investigations Team and as a Task Force Officer (TFO) with the Federal Drug Enforcement Administration (DEA), state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person(s), are the following:

November 19, 2023

On November 19, 2023, at about 8:56 PM, Denver Police Officer Leon #19101 and Officer Beauchamp #18042 responded to [REDACTED] Denver, CO, in reference to an apparent drug overdose.

Upon arrival, the officers contacted the complainant [REDACTED] who stated at approximately 5:00 PM, he arrived home with his girlfriend [REDACTED] and started making dinner. [REDACTED] stated the victim's (WALKER, COLLIN CAIN 060595) door was slightly open and he could hear his TV on, but that is normally how he goes to bed. Davis stated he got up from the living room couch to use the restroom and that is when he noticed something wrong

with the victim's face. [REDACTED] entered Walkers room and noticed discolored foam coming out of the victim's mouth and that is when he called 911.

Denver General EMS #61, (Schnabel and Clary) arrived on scene and pronounced the victim dead at 9:10 PM.

[REDACTED] told officers that he last talked with the Walker at work on Thursday, November 16, 2023, around 6:00 PM. [REDACTED] stated Walker did not look well and suspected Walker was using drugs again. [REDACTED] stated he knew Walker to use Xanax and Oxycodone.

Medical Examiner #40 (Erin Bush) arrived on scene and located two unlabeled medicine bottles. One bottle had 13 suspected blue Fentanyl pills (Exhibit #1); the other bottle had 14 suspected white Xanax pills (Exhibit #2). Walker was taken by the ME to the Denver City Coroner's Office.

Officer Beauchamp collected the two unlabeled medicine bottles and Walker's phone and transported the items to the Denver Police Property Bureau as evidence. Photos were taken at the scene.

November 27, 2023

On November 27, 2023, Task Force Officer (TFO), Detective R. Jason Brest #98034 was assigned the follow up investigation in this case.

November 28, 2023

On November 28, 2023, Your affiant checked out the victim's cell phone from the Denver Police Department Property Bureau for examination. Your affiant noted that the cell phone was locked with an unknown lock code. Your affiant attempted to unlock the phone with victim's date of birth with no success. Your affiant checked the victim's phone back into the Denver Police Property Bureau on December 7, 2023.

Your affiant requested an initial toxicology report from Erin Bush of the Denver Medical Examiner's Office.

December 27, 2023

On December 27, 2023, Your affiant received a voicemail from a male who identified himself as [REDACTED] stated that he had information regarding the death of Collin Walker.

January 2, 2024

On January 2, 2024, at about 11:24 AM, Your affiant received a phone call from [REDACTED] [REDACTED] identified herself to Your affiant as Collin Walker's mother. [REDACTED] told Your affiant that she had been given information from a friend of Collin in regard to where Collin was getting his drugs from. [REDACTED] stated that this friend goes by the nickname "[REDACTED]" but that his name was [REDACTED]. [REDACTED] then forwarded the information she had been given to Your affiant vis email. Your affiant received this information in the form of a picture.

The information stated:

Dealers Information

NAME: Jamal Gamal

Number: [REDACTED]

[REDACTED] (burner phone)

Info: lives in the Bay Area, CU boulder alumni.

Extra information:

- Dealer reached out to Collin after OD in Hawaii and Collin told him he OD and that the drugs were laced, and he was going to rehab

[REDACTED] reached out to dealer and yelled at him after Collin died

[REDACTED] the Denver Detective on Collins case and told him he has information

[REDACTED] said the dealer would send pictures of the tracking information so Collin might have that on his phone.

Your affiant went to the Denver Police Department Property Bureau and checked out Collin Walker's cell phone. Your affiant gave the phone to Detective Coleman to attempt to crack the lock code via Cellebrite.

January 3, 2023

[REDACTED] agreed to come to the Denver Police Headquarters and meet with Your affiant and Detective Coleman. During this meeting, [REDACTED] told Your affiant and Detective Coleman that he had introduced Collin to Jamal Gamal as his drug dealer that would mail him Fentanyl and Xanax via USPS and FedEx. Eric told Detective Brest and Detective Coleman that he had previously met Jamal Gamal in person and knew him and could identify him.. [REDACTED] provided a screenshot of a shipment that he received from Gamal.

█ sent Your affiant the pictures of the tracking information screenshots that he had received from Jamal Gamal when he sent the narcotics via USPS and FedEx. █ also sent pictures of Jamal Gamal's Venmo and Instagram accounts along with Collin Walker's Venmo account.

█ advised that after he found out that Collin had died, █ called Jamal Gamal and cussed him out and told him that he had killed Collin. █ advised that after that call, Gamal didn't seem to care and that he is continuing to sell Fentanyl through the mail.

█ stated that after he gave Collin Jamal Gamal's contact information, Collin then reached out to Jamal Gamal and began getting Fentanyl and Xanax from Gamal.

Detective Coleman discovered that Cellebrite was able to unlock Collin Walkers phone with code "000000". Detective Coleman then ran a cellphone extraction on Walker's phone.

Information discovered from Collin Walker's cell phone extraction:

Your affiant and Detective Coleman began reviewing the information extracted from Collin Walkers cell phone. The following information was discovered.

February 28, 2023:

Collin texted Jamal Gamal's cell phone █

Collin - "Yo man this is Collin, █ sent me your number"

Gamal - █ (Gamal) replied: "Yoooo █
"Hit that #"

Collin then texted the number Jamal gave him █ This number is labeled "Jamal" in Collin's phone.

Collin - "Ay it's Collin"

Gamal - "Was good bro your toad n lord friend?"

Collin - "Yee man good friend and old roommate."

Collin - "He said you could send me some bars?"

Gamal - " Yeah it's good they're homies"

Gamal - "Ya my friend runs the plays now but I coordinate with the homies"

**This is the last documented communication between Jamal Gamal and the victim Collin Walker.

Summary:

On Sunday, November 19, 2023, at about 8:56 PM Denver Police Officers responded to [REDACTED] in reference to the apparent overdose of Collin Walker Medical Examiner #40 arrived on scene and located two unlabeled medicine bottles. One bottle had 13 suspected blue Fentanyl pills, the other bottle had 14 suspected white Xanax pills.

This evidence found at the scene was submitted to the Denver Police Department Crime Lab for presumptive testing. The tests were conducted by Forensic Scientist Nicole Almeter with the following results:

Item #1 on Invoice #1379042 (suspected Fentanyl Pills) tested **POSITIVE for Fentanyl.**

Item #2 on Invoice #1379042 (suspected Xanax Pills) tested **POSITIVE for BROMAZOLAM.**

TFO known from his training and experience that currently illicit drug dealers are using BROMAZOLAM in place of XANAX/ALPRAZOLAM and selling/marketing it as real XANAX pills/bars.

The number of recovered Fentanyl and Bromazolam (Xanax) pills is consistent with the communication between Collin Walker and Jamal Gamal. Collin Walker had purchased and received 20 Fentanyl (blues) pills and 20 Xanax (bars) pills from Jamal Gamal. Jamal Gamal mailed the pills to Collin Walker on November 9, 2023. Collin Walker received this package on November 13, 2023. Six days had passed since Collin Walker had received the 20 Fentanyl pills and 20 Xanax pills. The number of pills recovered at the scene is consistent with Collin Walker having used some of each Fentanyl and Xanax each day since he received them.

Upon examination of the phone records of the victim Collin Walker, there is no evidence or indication that Collin Walker obtained any Fentanyl or Xanax pills from anyone other than Jamal Gamal.

Based on the communications between Jamal Gamal and the witness (Eric Toedt) information, Your affiant believes that Jamal Gamal is actively sending illegal narcotics including Fentanyl, Xanax, and Adderall to many other locations across the United States.

Follow up Investigation

During a review of the text message conversations between the victim in this case and the target, Jamal GAMAL, it was discovered that GAMAL told the victim to pass his phone number to others to bring him more business. GAMAL told the victim to tell others that, "Mal's friend" referred them.

Using this information Your affiant made contact with GAMAL via text in an attempt to introduce himself to GAMAL and begin purchasing narcotics from him.

Summary of 1st Undercover Buy from GAMAL:

On Tuesday, January 23, 2023, Your affiant successfully introduced himself to GAMAL using this language. This text conversation was captured on the [REDACTED] system.

Your affiant ordered 100 Xanax pills from GAMAL. GAMAL told Your affiant it would be \$375.00 with shipping.

TFO contacted [REDACTED] with the United States Postal Inspectors and arranged for an undercover Post Office Box in Higley, AZ.

GAMAL agreed to ship the pills to this address and requested Your affiant to send the money via CashApp. GAMAL initially told Your affiant to send the money to [https://cash.app/\\$JamalGamal](https://cash.app/$JamalGamal) and then changed it to CashApp account "\$nictowner".

Your affiant reached out to [REDACTED] with HSI and arranged for an undercover CashApp account to send the money to. Due to this taking an extended time to get set up and send the funds, Your affiant told GAMAL they would send a little extra for his time.

[REDACTED] then arranged to have \$400.00 send to GAMAL via the UC CashApp account.

At about 3:33PM [REDACTED] advised that the funds had been sent. Your affiant sent GAMAL a screenshot of the payment and advised him that it had been sent.

At about 5:58 PM, GAMAL sent Your affiant a picture of a USPS tracking number and receipt showing that the package had been sent. The USPS tracking number was #9505-5136-0416-4023-5038-44.

Your affiant alert USPS Postal Inspector [REDACTED] that the package was on the way.

On Friday, January 26, 2023, TFO was advised by USPS Postal Inspector [REDACTED] that

the package had been received in Arizona. [REDACTED] advised Your affiant that the package was being forwarded to the Postal Inspector Office in Denver.

Your affiant then texted Gamal to let him know that Your affiant had received the package in the mail. During this text exchange, Gamal advised Your affiant that he could sell Your affiant 500 Xanax pills for \$1000.00 and that he could sell 100 "Percs" (Percocet pills) for \$8.00 each. Gamal told Your affiant that he also had "Addys" (Aderall) also for \$6.00 each, 30mg orange.

On Monday, January 29, 2023, Your affiant was advised by Postal Inspector [REDACTED] that the package had arrived at their Office. Your affiant and Detective Phillip Coleman responded to the USPS Office to recover the evidence. Once there, Inspector [REDACTED] turned over the package to Your affiant and Detective Coleman. Your affiant and Inspector [REDACTED] documented the package with photos and observed that the package contained several white pills in the shape of Xanax bars.

Your affiant took custody of the evidence and transported it and all packaging to the Denver Police Department and placed it into evidence under GO#23-424434, Invoice #1392333.

Your affiant requested presumptive screening on the evidence and fingerprint/DNA analysis of the packaging.

Presumptive Lab Test from UC Buy #1:

On March 7, 2024, Your affiant received the presumptive lab test results on the suspected Xanax pills bought from Gamal by Your affiant. This test was conducted by Denver Police Department Forensic Scientist Nicole Almeter. Item #1 on Property Invoice #139233 tested **POSITIVE for BROMAZOLAM at 38.763 grams.**

Your affiant noted that the suspected Xanax pills found at the scene/apartment of the victim in this case, that were suspected to have been purchased from Gamal by Collin Walker shortly before his death, also tested **POSITIVE for BROMAZOLAM.**

Your affiant also received the results of the fingerprint analysis on the inner packaging.

Items 1392333-2 and 1396742-2 were examined and processed for friction ridge detail of evidentiary value. Eight latent prints were marked and preserved from the USPS Flat Rate Envelope contained within item 1392333-2 as LP-1(1A, 1B, 1C, 1D, 1E, 1F, 1G, 1H). Four latent prints were marked and preserved from the USPS Flat Rate Envelope contained within item 1396742-2 as LP-1(2A, 2B, 2C, 2D).

AFFIDAVIT AND APPLICATION FOR ARREST WARRANT

The requested item 1392333-3 (outer packaging) was not processed due to the item being handled through the mail delivery system.

RESULTS: Latent prints LP-1(1A, 1C, 1F, 1H, 2A, 2B, 2C) were entered into the Automated Fingerprint Identification System with negative results.

Additionally, latent prints LP-1(1C, 2B) were entered into the Federal Next Generation Identification (NGI) System with negative results.

In the event of a reverse AFIS hit, Your affiant will be notified.

DISPOSITION OF ARTICLES: Items 1392333-2 and 1396742-2 were returned to the Evidence and Property Section. Item LP-1 is retained in the Latent Print Unit storage.

Evidence images are retained in the Digital Information Management System.

Second Undercover Buy from Gamal

Summary of 2nd UC Buy from GAMAL:

On Thursday February 1, 2024, Your affiant arranged for GAMAL to sell 100 "Blues" previously discussed as "Percs" for \$8.00 each.

Your affiant ordered 100 "Blues" from GAMAL. GAMAL told Your affiant it would be \$800.00 with shipping.

Gamal asked Your affiant for the address to mail them to and Your affiant gave Gamal the address to the Post Office Box provided by the USPS [REDACTED] in Higley Arizona.

On Friday, February 2, 2024, GAMAL agreed to ship the pills to this address and requested Your affiant to send the money via CashApp. GAMAL told Your affiant to send the money to CashApp account "\$nictowner".

Your affiant reached out to Special Agent [REDACTED] with HSI and arranged for an undercover CashApp account to send the money (\$800) to CashApp account "\$nictowner".

At about 5:41 PM Gamal sent Your affiant a picture of the package that he was sending to Your affiant.

At 5:54 PM, Your affiant advised Gamal that he had sent the money.

Gamal advised Your affiant that he would be sending it via UPS ground. Gamal then told Your affiant "Soon as I send delete the conv".

Gamal sent Your affiant a picture of the UPS tracking information showing tracking #1Z6R214RO346694582.

Your affiant alerted USPIS Postal Inspector [REDACTED] that the package was on the way.

On February 6, 2024, Your affiant received notice from UPS that the package had been delivered. Your affiant advised Inspector [REDACTED] at that time. Inspector [REDACTED] advised that he would have the package forwarded to the Denver USPIS Office.

On Tuesday, February 13, 2024, Inspector [REDACTED] sent Your affiant a picture of the package and advised that it had arrived in Denver.

On Thursday, February 22, 2024, Your affiant and Detective Coleman #04119 responded to the USPIS Office and met with Inspector [REDACTED] to collect the evidence. Your affiant and Detective Coleman observed as the package was opened and took pictures of the evidence. The package appeared to contain several blue pills.

Your affiant took custody of the evidence and transported it to the Denver Police Department Property Bureau and placed it into evidence under Invoice #1396742. Your affiant separated the inner and outer packaging and placed them in under separate item numbers. The pills were item #1. The inner packaging was item #2. The outer packaging was item #3.

Your affiant also requested presumptive screening test on item #1 and fingerprint analysis on item #2.

Presumptive Screening test results on UC buy #2:

On March 7, 2024, Your affiant received the results of the presumptive test conducted by Forensic Scientist Nicole Almeter. Item #1 tested **POSITIVE for FENTANYL** at 10.276 grams (100 pills).

Since last undercover purchase by Detective Brest from Gamal, Gamal has reached out to Detective Brest several times to ask if he needed any more.

AFFIDAVIT AND APPLICATION FOR ARREST WARRANT

On August 7, 2024, Your Affiant presented this case to Denver Chief Deputy District Attorney Thain Bell for consideration of criminal charges against GAMAL. This case has been tentatively accepted for both distribution of fentanyl and distribution of fentanyl resulting in death.

Based on the aforementioned facts, Your Affiant respectfully requests that an arrest warrant be issued so this investigation can continue.
