



**AFFIDAVIT AND APPLICATION FOR ARREST WARRANT
AND THE ARREST WARRANT FOR THE PERSON(S) OF:**

Dion Neal, DOB 01/28/1979, Black, Male, 5'8 Height, 180 Weight, Brown Eyes, Black Hair

18-3-405.3 Sex assault on a child (POT) Class 3 Felony

I, Detective Curtis M. Johnson #97037, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person(s), are the following:

July 14, 2022 Your Affiant Detective Johnson was assigned the follow investigation for case number 22-365563, sex assault on a child. Your Affiant reviewed the referral submitted by Denver Department of Human Services which stated the victim [REDACTED] disclosed that her stepdad Dion Neal 01/28/78 has been touching her and having sexual intercourse with her over the past two years.

July 14, 2022 the victim [REDACTED] underwent a forensic interview at the Denver Safe Center. [REDACTED] disclosed that the following acts of sex assaults took place at her home located at [REDACTED] in the City and County of Denver. The victim disclosed that abuse started in December 2018 with fondling and the introduction of sex toys and progressed to vaginal intercourse (penis in vagina) and oral sex with (mouth on penis) with the most recent incident taking place in June 2022.

The victim [REDACTED] disclosed the following acts of sex abuse, and timeline during her forensic interview.

Age 8 to Age 10

- [REDACTED] stated she remembers being 8 years old, and her stepdad Dion was touching her on her vagina with his hand. The victim remembers her underwear being pushed to the side and her leggings being pulled down. The victim stated that Dion she showed her his mom's sex toys (silver and purple vibrator)

Age 10 to Age 12

- [REDACTED] stated the first time Dion had intercourse with her she was age 10. [REDACTED] stated that she was in his bedroom, and he put his penis inside of her vagina. [REDACTED] stated that he was persistent, to have sex with her. [REDACTED] stated that Dion took off her clothes and got on top of her and put his


penis inside of her [REDACTED] stated it hurt when he put his penis inside of her and he asked her to stop, and he kept going. [REDACTED] stated that Dion ejaculated on her stomach.

- [REDACTED] stated she recalls another time Dion had sexual intercourse with her was in the kitchen. The victim stated that Dion came up behind her and pulled her pants down and put his penis inside of her vagina and ejaculated into a washcloth.
- [REDACTED] stated Dion bent her over the living room couch and her sister saw her. [REDACTED] stated they were in the living room, and he had her bent over the couch and put his penis inside of her. [REDACTED] stated her sister was downstairs and she came up and saw her, and she pulled her pants up right away, and he ran towards the stairs.
- [REDACTED] stated that Dion took her to the downstairs living room, and her siblings were outside playing fire. [REDACTED] stated in this time Dion used a condom when he was having sex with her and ejaculated into the condom.
- [REDACTED] stated the most recent incident was in June 2022. Dion took her in the upstairs bathroom and had her perform oral sex on him, putting his penis in her mouth. [REDACTED] stated Dion forced her to suck his penis until he ejaculated into her mouth and told her to swallow it. [REDACTED] stated Dion had her perform oral sex on his anus, and he masturbated to pornography on his iPhone. [REDACTED] described the phone as a black iPhone 13.

July 14, 2022 Your Affiant Detective Johnson presented the victim [REDACTED] a single photograph of the listed suspect, and she positively identified **Dion Neal, DOB 01/28/1979** as the person who sexually abused her.

Based on the above stated information, Your Affiant Detective Johnson respectfully request that this probable cause arrest warrant for **Dion Neal, DOB 01/28/1979** the suspect be granted.

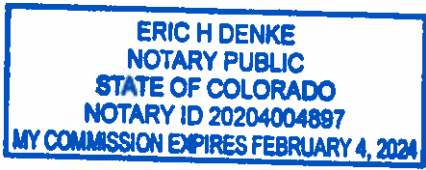
