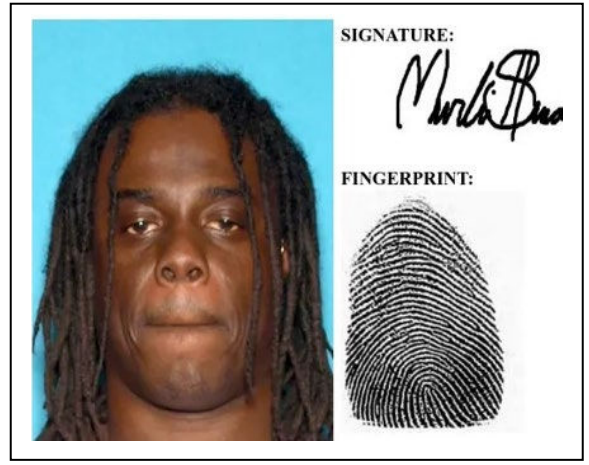
**Preamble**

39 Your Affiant, Investigator Joseph M. DeAngelo (hereafter referred to in the first person), has been a sworn peace  
40 officer for over 30 years. I currently serve in the capacity of a senior criminal investigator for the Second Judicial  
41 District - Denver County District Attorney’s Office (Denver DA) in the Human Trafficking Unit (HTU). Over  
42 20 years of my tenure has been in the capacity of a criminal investigator which included assignments with the  
43 Colorado Attorney General, chief investigator with the 14th Judicial District Attorney’s Office (Colorado),  
44 detached service with the FBI and county prosecutor/grand jury when employed as a detective with the Fort  
45 Wayne, Indiana Police Department. Additionally, I have two master’s degrees: Psychology - Criminal  
46 Investigations, and Human Development from Regis University and Fielding Graduate University, respectively.  
47 Furthermore, I have a graduate certificate in Child Sex Offender Behavioral Characteristics from Regis  
48 University. Also, I was an adjunct professor at Regis University in the graduate psychology program where I  
49 instructed numerous graduate level college courses generally related to criminal psychology and criminal  
50 investigations.

89 He's systematically contacting us one by one. Be aware of this individual please.

90  
91 The case was initially assigned to Investigator Adam String of the Denver DA HTU. Commencing 06/20/2024  
92 through to and including 06/23/2024, Investigator String had the below email exchanges with the reporting party  
93 who went and currently goes by the name [REDACTED]. Through investigation I later determined that the  
94 individual using the name [REDACTED] is, in fact, a commercial sex worker in the Denver area (discussed later in  
95 the affidavit) and the name [REDACTED] was/is a pseudonym used to post sex ads (hereafter she will be referred  
96 to as [REDACTED]).

97  
98 Investigator String emailed [REDACTED] at the listed email address: [REDACTED]. The  
99 screenshots [REDACTED] included in the emails to Investigator String, which were screenshots of text exchanges  
100 between [REDACTED] and the suspected pimp propositioning her, are attached to this affidavit – Attachment A):

104 Investigator String

105  
106 Good afternoon. I was sent the tip below from our DATA tipline. I recognize that it appears you would  
107 like to remain anonymous, but I was hoping for the opportunity to ask you a few questions about the  
108 information surrounding this pimp. It would be really helpful to my investigative efforts, and I'm happy  
109 to chat with you before you provide additional info to let you know how these types of cases come  
110 together. My direct contact information is listed below, and I can answer any questions you have first, if  
111 that would be more comfortable. Thank you for your time, and I hope to talk with you soon!

132 This Pimp has been contacting and harassing several of my friends and myself. Within our community  
133 of shared information he's been at this for quite some time. He tried to make himself appear legitimate by  
134 having a website and IG. I really wanted to bring this to your attention so he doesn't go after any children  
135 (IG is notorious for child trafficking).  
136

137 I can tell you that he's using a cell phone that's traceable and registered. So he's not using a voip or burner  
138 phone. I think he's based out of Cali since the pictures in his IG account show him associating with crip  
139 gang members and he's making gang signs with his hands. I'm hoping by passing this information onto  
140 you, you're able to prevent him from going after any vulnerable women and children.

141 I have the texts that he's sent me if you want to see the screen shots.

142 Investigator String

143  
144 Thanks [REDACTED], and thank you for the information. I would appreciate any screenshots or texts that you  
145 have with this person. Would you mind me asking why you are calling him a pimp? Would any of your  
146 friends be willing to speak with me?  
147

148 Ms. [REDACTED]

150 Hey there Adam!

151  
152 I'll include my screenshots of my exchange with him, forgive me I'm very sassy and not very nice  
153 towards him, but I'm never nice to predators.  
154

155 Investigator String

156  
157 No judgment here. I was more trying to understand what made you choose that word when referring to  
158 him. In reading the text messages, I no longer have any doubt about your choice of terminology. Have  
159 you met him in real life, or only through text/social media?  
160

161 Ms. [REDACTED]

163 He has only contacted me through my phone by text but he has contacted several other of my friends by  
164 phone and text as well

165  
166 Investigator String

167  
168 Would your friends be willing to share their screenshots or forward them to you, to forward to me?

169  
170 If we were in person, it would be easier to ask this without it coming off in an off-putting way, but do you  
171 know what prompted him to reach out to you and your friends? Is he blasting social media in hopes that  
172 someone responds, or is he looking for specific profiles online?

173  
174 I'm not asking to say that it's your fault he's contacting you. Just trying to understand what prompted his  
175 attention in your direction. Not sure how to ask that without it coming off like I'm saying it's your fault.  
176 Not my intention at all. Sometimes, there is no answer to this, but it helps me to know if someone referred  
177 him to you or something like that, so I can start piecing his profile together and coming up with a way for  
178 him to contact me or vice versa on one of my under-cover profiles. Does that make sense? Or if you know  
179 how he got your phone number or anything like that, it would help me.

180  
181 Ms. [REDACTED]

183 I believe this pimp is going after girls just in the area randomly.

184  
185 I think he probably contacts every profile on every site he's visiting or he could be looking through  
186 social media websites to find girls.

188 I would definitely look into

191 Privatedelights.ch  
192 Megapersonals.eu

193  
194 These sires are more susceptible for vulnerable providers,

195  
196 Otherwise he's more then likely using IG, snapchat, or review boards.

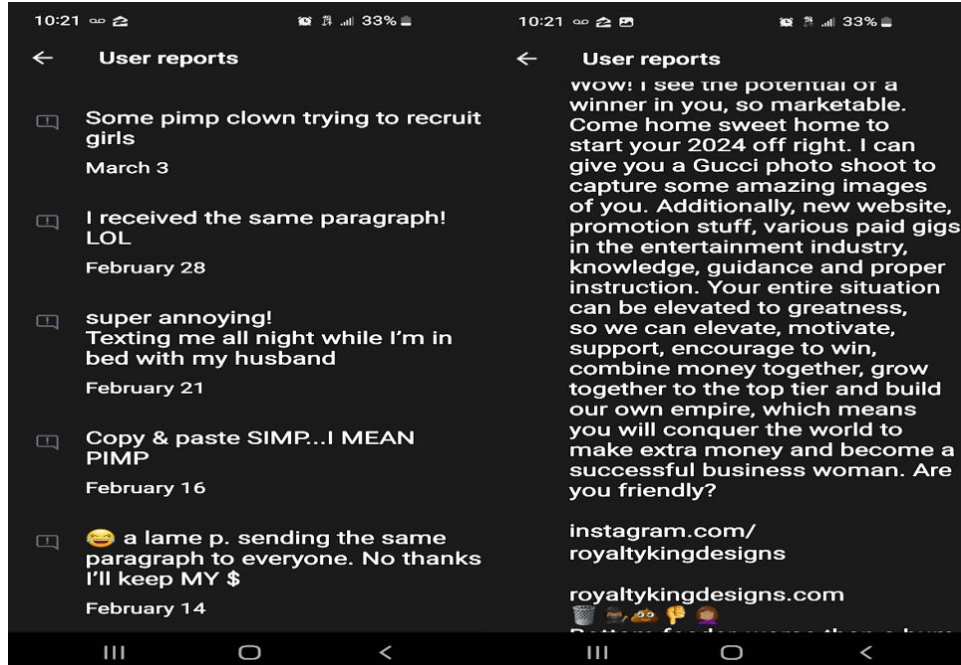

198 I'm not really sure where he contacted me, I'm not currently posting and I don't have an active website or  
199 online presence, so with me, he may have looked through old postings of me or scraper sites

200  
201 If he's in California, more then likely he's using Privatedelights.ch as they are based in California

202  
203 I do have a question unrelated, and I know you may not be able to help me but I wanted to know how I  
204 can help a separate situation I keep hearing is going on

209 **Posting in Telegram (Included in Attachment A)**

210  
211 In addition to screenshots of text communication Ms. [REDACTED] had with the suspected pimp,<sup>3</sup> Ms. [REDACTED] also  
212 provided Investigator String a screenshot of electronic discussions commercial sex workers had via Telegram<sup>4</sup>  
213 about the suspected pimp propositioning them with the same general sales pitch (see below screenshot – dating  
214 back to February 14, 2024):

218 **DeAngelo Assumed Investigation – Contact with Ms. [REDACTED]**

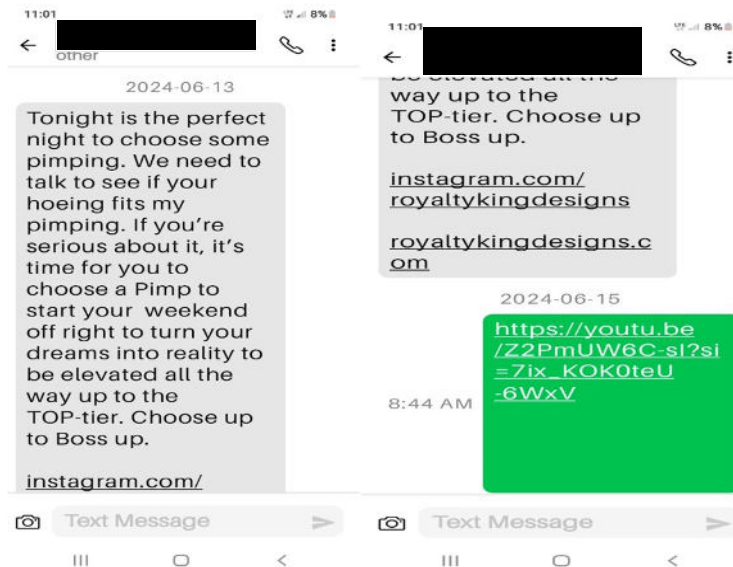

220 On 07/11/2024, I assumed the investigation of this case and emailed Ms. [REDACTED] to inquire if she would be willing  
221 to speak with me via a telephone call and eventually in-person. Via a return email Ms. [REDACTED] agreed to a phone  
222 call and provided me with her cell phone number of [REDACTED] Prior to the call and after the call I reviewed  
223 and conducted extensive follow-up investigation on: 1. all the screenshots Ms. [REDACTED] provided to Investigator  
224 String, 2. the cellphone number [REDACTED] received the text messages from, to include the probable identity of  
225 the account holder of same, 3. the cell phone numbers associated with Ms. [REDACTED] 4. the Instagram account as  
226 listed in the text message Ms. [REDACTED] received from the prospective pimp and the data posted from the account,  
227 and 5. [REDACTED] commercial sex ads which were posted online along with the data contained in those ads.  
228 Through that process I tentatively identified the likely sources of the text messages sent to Ms. [REDACTED] as Mr.  
229 Swanston (identification detailed later in the affidavit):

231 **Mr. Swanston’s Instagram Account**

232  
233 The initial text message sent to Ms. [REDACTED] which is included in Attachment A, included a link to the following  
234 Instagram account: <https://www.instagram.com/royaltykingdesigns/?hl=en> (see below initial text message sent to  
235 Ms. [REDACTED] – contained in Attachment A):

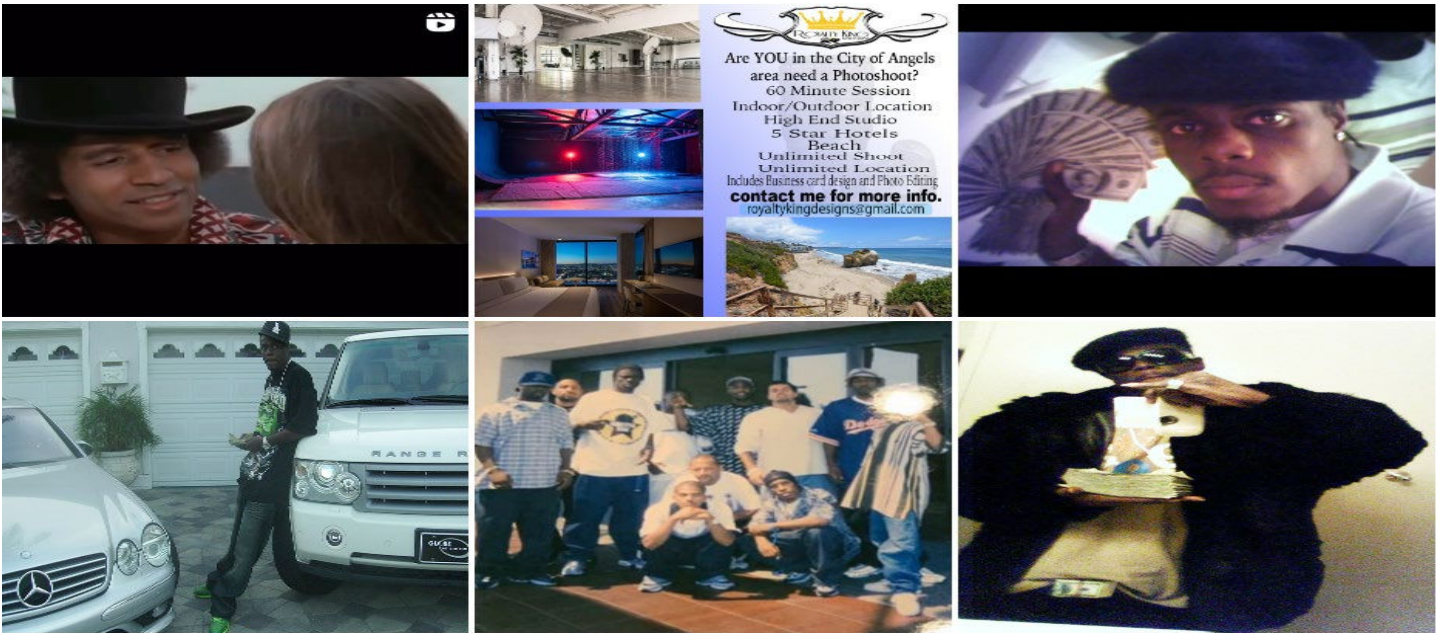
239 Upon reviewing the account, I noted that the account was associated with a business called *Royalty King Designs*.  
 240 There was no phone number for Royalty King Design posted on the account. There was a website link  
 241 ([royaltykingdesigns.com](http://royaltykingdesigns.com)) posted on the account; however, the website was not active at the time I initially  
 242 checked, however, at the time of this arrest affidavit the site is active. In a recent post on the Instagram account  
 243 (05/15/2024) there was an email for prospective customers to contact Royalty King Designs as:  
 244 [royaltykingdesigns@gmail.com](mailto:royaltykingdesigns@gmail.com). The email is associated with a modeling business for female clients with a  
 245 caption that reads in part: “various paid gigs in the entertainment industry, which means you will conquer the  
 246 world to make extra money and become a successful business woman. Let’s win together ...”<sup>5</sup> (see below  
 247 screenshot of the post).  
 248



249  
250

251 The other images and videos open to the public on Mr. Swanston’s Instagram account included an assortment of  
 252 topics that range from: 1. references to commercial sex (numerous references to pimping), 2. rap music, 3. Royalty  
 253 King Design (tee-shirt design), 4. advertising photoshoots for women in the industry, 5. Mr. Swanston engaging  
 254 in weightlifting, 6. Mr. Swanston flashing large sums of US currency, 7. breeding of pit bulls, and 8. adult men  
 255 standing together flashing gang signs. However, most of the recent postings are associated with the commercial  
 256 sex trade. Based upon my experience and knowledge of the commercial sex trade, of the latest six posts, five are  
 257 directly or indirectly associated with pimping (see below screenshot of the latest six posts):

<sup>5</sup> Through my experience and training, I understand this is a common type of reference pimps make to prospective commercial sex workers.



258

259 The videos and images posted related to prostitution included numerous colloquial references to the commercial  
 260 sex industry, specifically pimping. For example, the first video/image, which was posted on 06/11/2024, is a  
 261 movie clip from the movie *The Mack*. I am personally aware this is a 1973 cult classic related to the commercial  
 262 sex industry and the term *Mack* is routinely referenced by pimps. Colloquially, the term *Mack* means someone  
 263 who can manipulate others into prostitution, keep all proceeds, control the commercial sex workers' minds  
 264 through psychological and/or physical abuse, and be proud about it. Snippets of the movie are often quoted in rap  
 265 and hip-hop lyrics (see below posted screenshot image – *The Mack* and one of his commercial sex workers).



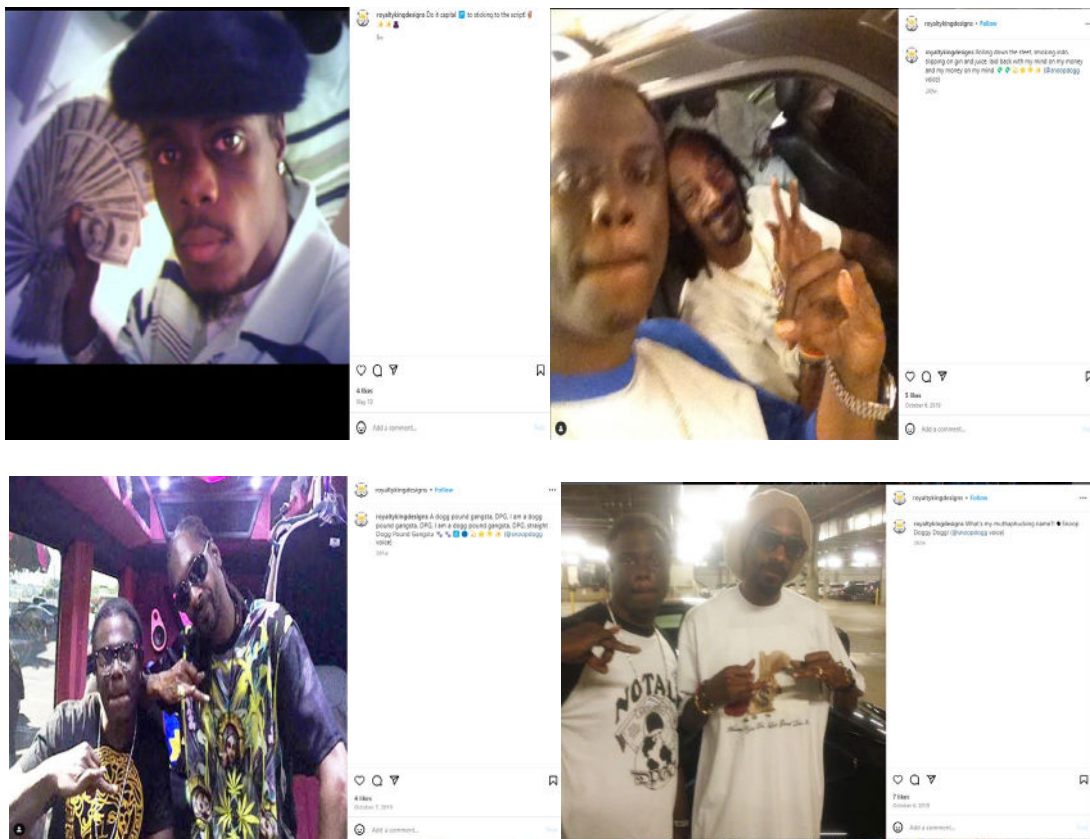

267 Additionally, there were posts such as below “Boss up or get Bossed around,” which I am aware, is a colloquial  
 268 metaphor used by pimps to solicit commercial sex workers, as was generally used by Mr. Swanston in the initial  
 269 text with Ms. [REDACTED]. The post was made over 334 weeks ago, which is over 6 years. This is the first clear  
 270 reference on the Instagram account related to commercial sex work (see below screenshot).



271

272 Further, there were numerous depictions of Mr. Swanston in the posted images where he is handling large amounts  
 273 of cash and several images of Mr. Swanston, in different settings over extended time, in the company of Snoop  
 274 Dogg displaying gang signs (see below screenshots of such examples):

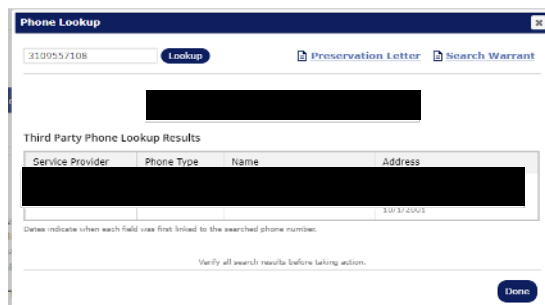
One post, posted over 25 weeks prior to this affidavit, which is associated with a picture of Mr. Swanston holding a large sum of US currency reads verbatim:

283 Now accepting applications for Models, Vixens, Pole Dancers, Money Makers and Upscale  
284 Companions wanna make extra money, elevate, traveling, and having fun simultaneously Get @  
285 the Boss A.S.A.P.

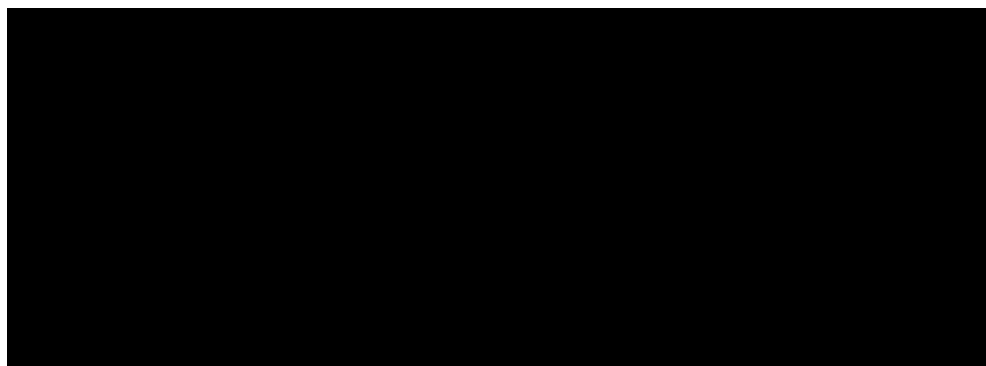
288 **Cell Phone Number [REDACTED] - Associated with Text Messages**

290 I ran the above cell phone number through vetted subscription law enforcement databases along with a vetted  
291 open-source database and determined that the cell phone account holder was: Mr. Swanston out of Inglewood  
292 (Los Angeles County), CA, dating back to at least to 2012 (see below screenshots):



293  
294 **Cell Phone Number [REDACTED] – Associated with Sex Ads**

296 Through my position as a HT investigator, I have access to HT databases which scrape commercial sex sites and  
297 preserved the data. I ran the above cell phone number through that database and located five commercial sex ads  
298 in 2015 which had the above phone number as points of contact for the commercial sex buyer (see below  
299 screenshot of one of the ads which contains two numbers to include the current [REDACTED]  
300



301  
302  
303 **Identification of Mr. Swanston (DOB: 10/24/1976)**

305 Through an extensive open source and law enforcement database searches, with the assistance of an analyst from  
306 RISS<sup>6</sup>, I was able to identify Mr. Swanston (see below screenshot of CA driver's license and booking photo):

<sup>6</sup> RISS is composed of six regional centers and the RISS Technology Support Center (RTSC). RISS works regionally and on a nationwide basis to respond to the unique crime problems of each region while strengthening the country's information sharing environment. 308 The above two government ID images of Mr. Swanston were visually similar to the person depicted in the above  
309 detailed Instagram account. In fact, it is probable the above government images of Mr. Swanston and the  
310 Instagram images depict the same person (Mr. Swanston).

311 Additionally, numerous databases and email correspondence within Mr. Swanston’s Google account (discussed  
312 later in the affidavit) indicated that he currently resides at: 805 Industrial Ave Apt 22, Inglewood, CA 90302-  
313 3321. This would include numerous deliveries to the residence, bills/utilities, and official government  
314 correspondence from the State of California (see below screenshot on State of California header):

318 **Criminal History of Mr. Swanston**






325 **Phone Conversation with** 

326

327 Senior Deputy DA Morgan of the Denver DA HTU and I had a lengthy telephone conversation with Ms.   
328 on 07/12/2024. Ms.  was cordial throughout, and confirmed she was a commercial sex worker in the

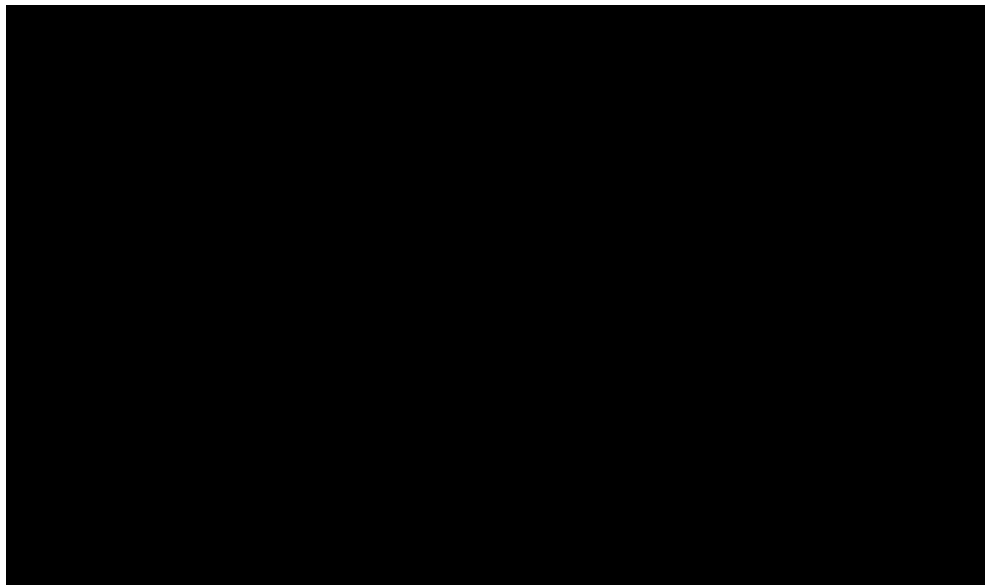
<sup>7</sup> I am unclear on the disposition of the arrest based upon the criminal history. The court expunged the case due to age of offense. I have ordered the police reports on the arrest. Those reports are pending.

329 Denver Metro area but was not currently posting commercial sex ads. Further, she currently had a standard 9 to  
330 5 job and now only occasionally engaged in commercial sex work. Ms. [REDACTED] indicated she did not have any  
331 other contact with Mr. Swanston beyond the attached text messages. Ms. [REDACTED] stated she would consider  
332 providing her legal name at a later time. We scheduled a time for a follow-up phone interview, but Ms. [REDACTED]  
333 failed to respond and failed to engage with me any further until I obtained her identity.

### 334 **Investigation to Identify [REDACTED]**

335  
336  
337 It was material to this investigation to identify Ms. [REDACTED]. As part of that process, I ran the cell phone number  
338 and email address Ms. [REDACTED] provided: [REDACTED] and [REDACTED] through the  
339 previously described HT commercial sex database. I located numerous commercial sex ads associated with both.

340  
341 The first ad Ms. [REDACTED] posted using the email address of [REDACTED] was on 02/01/2020. In  
342 the early ads she posted payments for service could be made via Cash app at [REDACTED] (see below  
343 screenshot for one such ad).



### 345 346 **Material Evidence (First Round of Search Warrants)**

347  
348  
349 Based upon all the above, I obtained search warrants for: 1. Mr. Swanston's call data records (CDRs) for his  
350 AT&T cell phone account, 2. Ms. [REDACTED] CDRs for her Verizon account, 3. Mr. Swanston's Instagram account,  
351 4. Ms. [REDACTED] Cash App account, 5. Mr. Swanston's Google email account, and 6. Ms. [REDACTED] Google email  
352 account. As detailed below, I identified Ms. [REDACTED] via the return on her Cash App account. As such, I did not  
353 substantively review her Google email account nor her CDRs.

### 354 355 **Part II (Summary of Search Warrant Returns from Part I and Follow-up Investigation)**

#### 356 357 **Cash App Search Warrant Results - Ms. [REDACTED]**

358  
359 On 08/15/2024, I received the Cash App result from Block, Inc. From the data provided, which included a DMV  
360 photograph of the account holder, I was able to identify Ms. [REDACTED] as [REDACTED]. I located  
361 Ms. [REDACTED] CO DMV Dossier (see below screenshot):

On 08/27/2024, after I learned the identity of [REDACTED] I made telephone contact with her. [REDACTED] ) confirmed to me in that conversation that she was, in fact, [REDACTED]

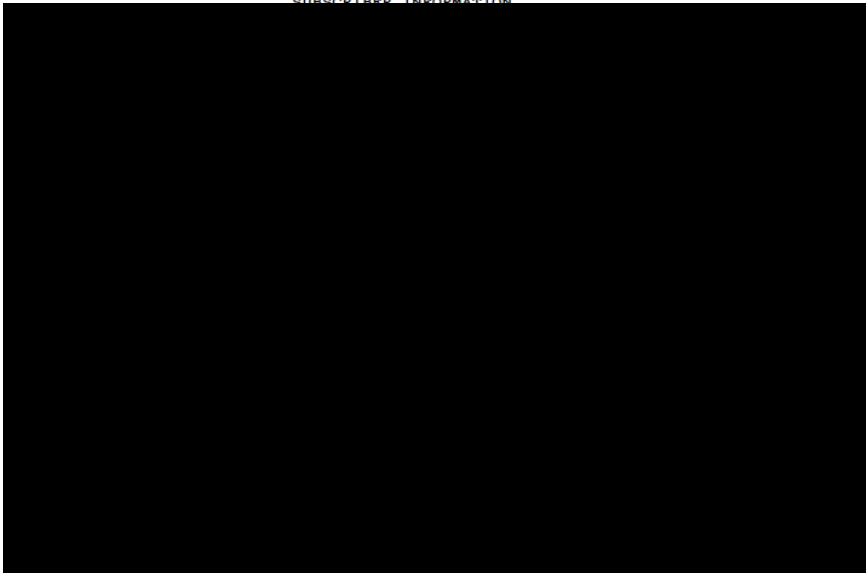
[REDACTED] is the first listed victim in this case. Date of offense commenced 06/13/2024 when Mr. Swanston initiated contact with [REDACTED] via text message and ended 06/15/2024, the date they had their final communication via text message.

**AT&T CDR Search Warrant Results – Mr. Swanston**

On 08/05/2024, AT&T complied with the CDR warrant for Mr. Swanston. A Denver DA digital analyst – Analyst Chris Gray, a Denver DA intern and I have reviewed the CDRs after Analyst Gray converted the data into a readable format with vetted software.

AT&T confirmed that the cell phone was registered to Mr. Swanston since 2009 (see below screenshot of subscriber information).

Through our analysis we determined that over the five-month period provided (the time requested in the search warrant), Mr. Swanston had just shy of 30,000 text messages and voice calls (attempted and completed) and had exchanges with over 7,000 different phone numbers. Most of the contacts were text messages, but there were over 900 calls and attempted voice calls.

I initially conducted a random sample of over a dozen of the cell phone numbers Mr. Swanston sent text messages to and ran those cell numbers through the above-described HT database. Every single cell number in the random sample was associated with a commercial sex ad.

The Denver DA intern and I ran the 720 and 303 numbers (prefix numbers for the Denver metro area) and located over 80 different numbers and each of the 80 were associated with commercial sex ads. Most of the sex ads were for females promoting themselves for prostitution in Denver metro area; however, a few were outside the state of Colorado. All were texts; however, two of the 80 also attempted incoming phone calls to Mr. Swanston's cell.

Although the content of the texts is unknown (AT&T does not provide text content), based upon the evidence presented in Part I of this affidavit and Attachment A (screenshots of text exchanges ██████████ had with Mr. Swanston and the Telegram postings), and the fact that every number searched was associated with a commercial sex advertisement, at this point in the investigation I determined it was probable Mr. Swanston had propositioned the women in the Denver metro area to work for him (pimp/commercial sex worker relationship).

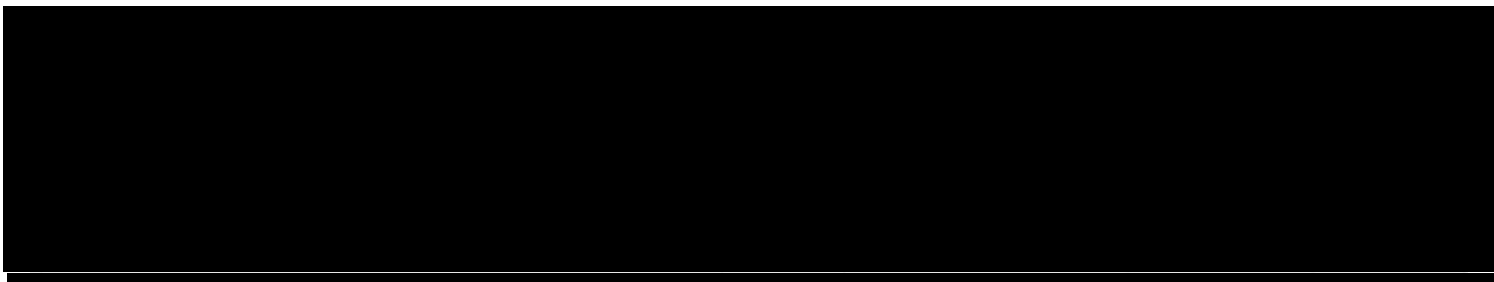
I also ran a small random sample of the phone numbers associated with the voice calls. In that sample approximately half the calls (incoming and outgoing) were associated with commercial sex ads.

### **Instagram Search Warrant Results – Mr. Swanston**

Upon receipt of the data from Meta (Instagram parent company) I had Analyst Gray convert the data into a readable Excel spreadsheet format via vetted software. Analyst Gray, a Denver DA intern, and I reviewed the volume of data within Mr. Swanston's Instagram account. Like the CDRs, Mr. Swanston was contacting scores of females via private messenger (person to person messages) who were presenting in a manner consistent with commercial sex workers on their Instagram account. The initial refrain Mr. Swanston sent to the females was (which slightly changed over time – first message sent 07/22/2021):

Hello luv. I like how you look and your style. I can help you get yourself brand better to gain exposure and visibility, giving your model/talent career a bit of boost to make serious cash daily..  
Let me know if you need anything, let's work?

Below is a screenshot which represents the general repetitive nature of his private messages to the suspected commercial sex workers. There were 549 excel cells which started messages off with "Hello luv. I like how you look" (see below screenshot).



Below is an example of one of Mr. Swanston's responses to a suspected commercial sex workers who engaged with him in the private messages (see below screenshot).<sup>8</sup>

<sup>8</sup> Related to the below response, through my training and experience I am aware that: 1. the term *Gorilla P* is a colloquialism in the industry which means violent pimp, 2. *304* means hoe (prostitute), and 3. *wrong T* in this context probably means a *trick* (customer) who did not pay and/or beat the commercial sex worker.

In March 2024, Mr. Swanston had the below terse private message exchange with who appeared to be a relative of his (possibly uncle – referred to Mr. Swanston as nephew [sic]). The tone of the conversation is that Mr. Swanston wanted his uncle to send commercial sex workers to him (Mr. Swanston), as Mr. Swanston had done for his uncle in the past, so Mr. Swanston could pimp the commercial sex workers. The uncle indicated he was retired from pimping and admonished Mr. Swanston for texting such incriminating requests, “You are a walking indictment ...”<sup>9</sup> (see below screenshot - Mr. Swanston’s comments are in the dark grey).

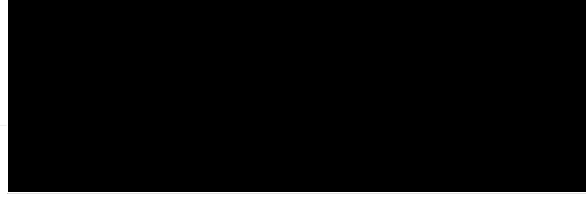

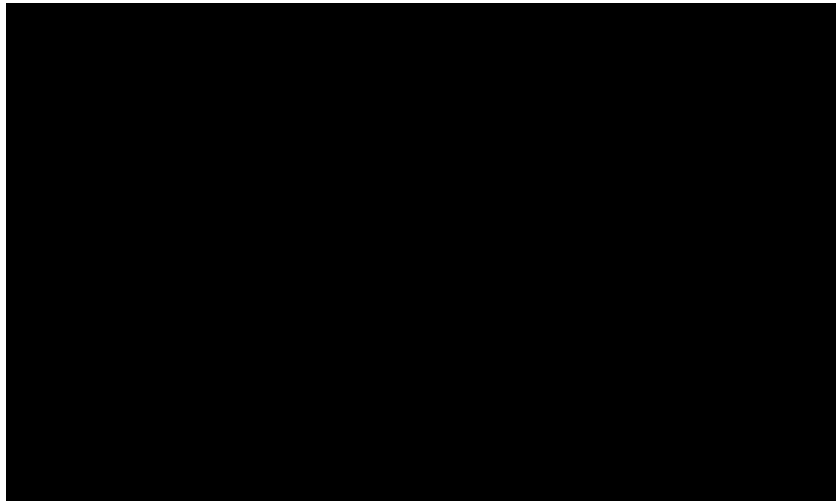

468 I ran the IP addresses through a vetted open-source IP address locator and determined all three addresses were  
469 AT&T IP addresses in Inglewood, CA (see below screenshot):

472 **Google Search Warrant Results – Mr. Swanston**

473  
474  
475 Upon receipt of the data from Google, I had Analyst Gray convert the data into a readable format with vetted  
476 software. Analyst Gray noted that there were email exchanges Mr. Swanston had with an attorney which would  
477 be considered privileged information. As such, prior to me viewing any of the data, other members of the Denver  
478 DA had the entire Google account reviewed by an outside third-party entity which removed all privileged

479 communications prior to me viewing the account data (I was purposely not involved in any part of the process,  
480 and I am unaware of who the outside entity was that removed the communications). This process took several  
481 weeks. As such, I just recently have been able to start to review the Google account. Due to the volume of data  
482 (over 54,000 emails, many thousands of Google searches etcetera), I have only been able to review a small portion  
483 of the total data. However, in my initial review I noted the following:  
484

- 485 1. Mr. Swanston's account is full of material which indicated Mr. Swanston is the sole owner/operator of  
486 the account such as: Mr. Swanston's resume, numerous bills addressed to Mr. Swanston, numerous  
487 correspondence addressed to Mr. Swanston, training diets and routines specific to Mr. Swanston, videos  
488 of Mr. Swanston engaged in online communications (Mr. Swanston is hard of hearing but can read lips  
489 and engaged online via video chats which were preserved with his images), etcetera. I found no evidence  
490 that anyone else was associated with the account.
- 491 2. Mr. Swanston's Gmail was used on several occasions to reset password to the above discussed Instagram  
492 account. Indicating the same individual is operating both accounts.
- 493 3. Mr. Swanston had numerous exchanges with commercial sex workers via texting (I was only able to view  
494 the commercial sex workers part of the conversation). From what was visible, it was clear Mr. Swanston  
495 paid for sex with commercial sex workers on numerous occasions.<sup>11</sup>
- 496 4. Mr. Swanston routinely searched sites identified as human trafficking sites; sites where commercial sex  
497 workers post ads (i.e. Erotic Monkey, USA Escorts, etc.). In fact, he had 492 such searches. Many of the  
498 searches correspond to dates when Mr. Swanston was contacting commercial sex workers identified in  
499 this investigation. It appeared to me, from these searches, is where Mr. Swanston initiated the process to  
500 locate the commercial sex workers he contacted.
- 501 5. Mr. Swanston had a chain email he continually sent to himself and added to each with the subject line:  
502 "The Game God." The content was something like a diary or ongoing blog of sorts, where he narrated  
503 some of his conversations with prospective commercial sex workers along with all manner and variety of  
504 similar commentary related to his pimping career. The narration, when converted to a word document,  
505 was 116 pages and dated back to when he had a Myspace Blog. Due to the length, I have not read the  
506 entire narrative. I did word searches and discovered Mr. Swanston used the word "pimp" 272 times, "hoe"  
507 266 times. Below is verbatim page #2 of the narrative:

546 **Part III (IP Address & Instagram Account for [REDACTED] – Search Warrant/Follow-up Investigation)**

548 **IP Address Search Warrant Results – Mr. Swanston**

550 It was material to this investigation to identify the account holder of the AT&T IP addresses which were used to  
551 recently log into Mr. Swanston's Instagram account on the dates/times listed. For if the IP address was in the  
552 name of Mr. Swanston, that would be additional evidence that Mr. Swanston was the individual sending/posting  
553 the above-described content. As such, I obtained a search warrant for the above IP address through AT&T. On  
554 08/15/2024, AT&T responded and identified the account holder as Murlin Swanston with the same Google email  
555 address detailed in section I of this affidavit (see below screenshot):

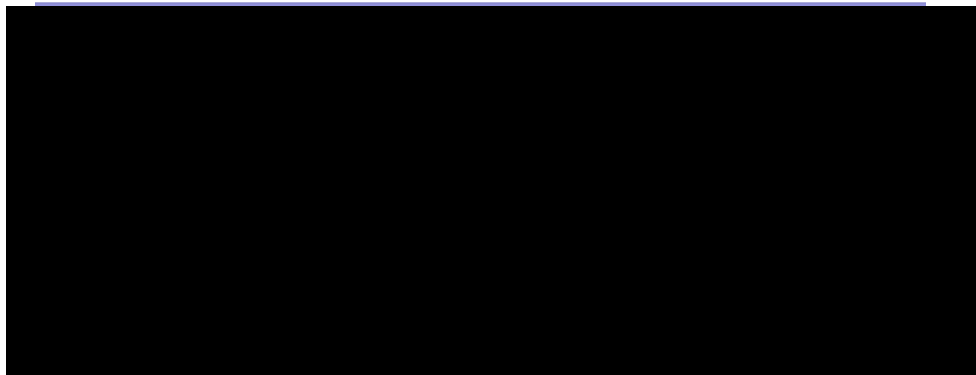

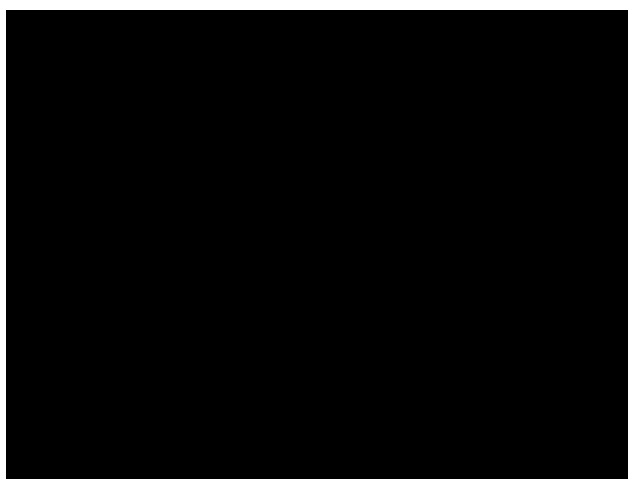

560 It was material to this ongoing investigation to obtain the identity of the Instagram account holder in the name of  
561 [REDACTED] because the account holder of [REDACTED] indicated a personal knowledge  
562 of the violent nature of Mr. Swanston's activities related to his alleged pimping/human trafficking. To collect the  
563 firsthand account of [REDACTED], and preserve any evidence, I had to first identify her through the  
564 Instagram account.

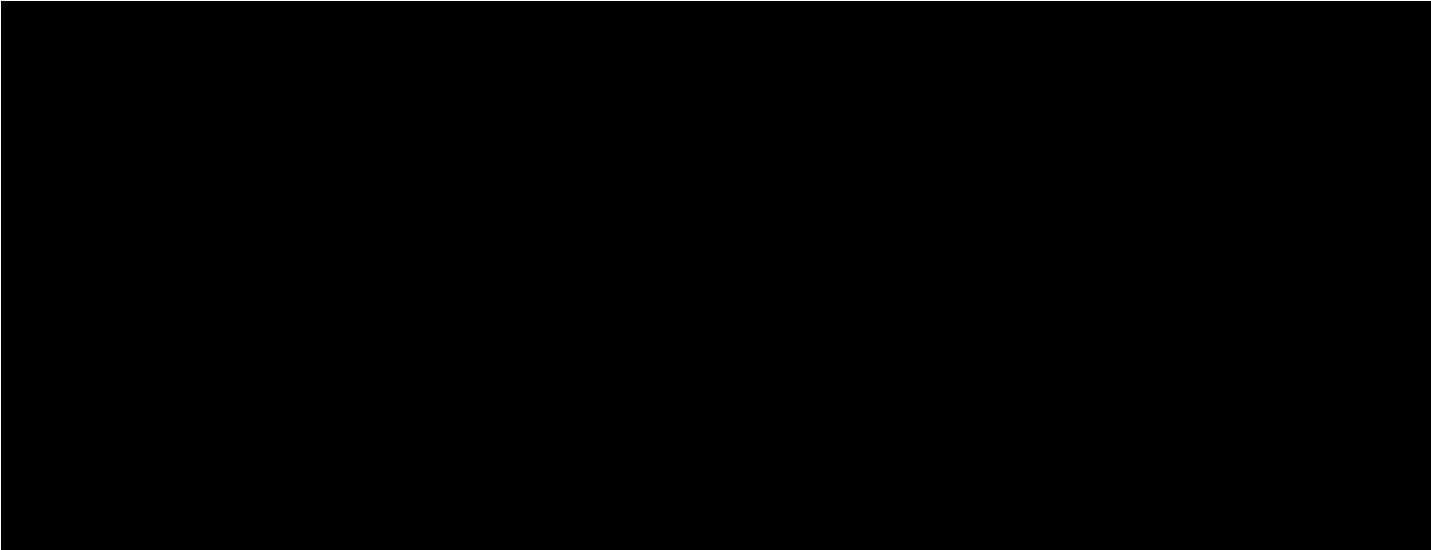

572 On 09/02/2024, I conducted a recorded telephone interview with [REDACTED] confirmed that  
573 she was a commercial sex worker in the Tulsa, Oklahoma area. [REDACTED] was contacted by Mr. Swanston  
574 via text message, which she assumed he obtained through her posted commercial sex ads. Mr. Swanston  
575 propositioned her for commercial sex work/pimp relationship. They had several terse exchanges. As a result, Ms.  
576 [REDACTED] posted the above discussed comments on Mr. Swanston's Instagram account. [REDACTED] provided  
577 me with the preserved screenshots of her exchanges with Mr. Swanston. A representative example of the  
578 exchanges is below (see below screenshot – [REDACTED] the blue bubble on right, Mr. Swanston black bubble  
579 on left):



580  
581 While in the process of authoring this affidavit, on Sunday 10/13/2024, [REDACTED] sent me the below text  
582 messages indicating a commercial sex worker posted the following on 10/12/2024 to Facebook on a private group  
583 for commercial sex workers (recent attempt by Mr. Swanston to recruit a commercial sex worker):

**Part IV – Identification of Second Commercial Sex Worker in Denver**

It was material to this investigation to identify additional commercial sex workers in the Denver area that were contacted by Mr. Swanston and if possible, obtain and preserve the digital communications between the two of them. The process of identifying commercial sex workers is difficult due to the fact the commercial sex workers most often use pseudonyms in the sex ads and further often heavily filter their posted images. Additionally, most of the commercial sex workers use VOIP cell phone numbers (broadband Internet connection instead of a regular or analog phone line) or similar type computer applications such as TextNow, which have limited or no available subscriber information, to conceal their real identity from law enforcement and others.

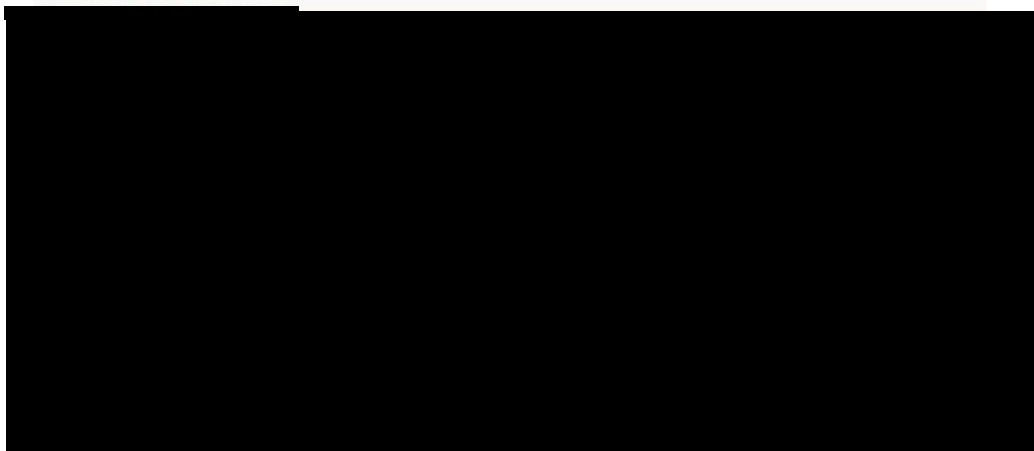

As such, I concentrated my efforts on commercial sex workers who had significant interaction with Mr. Swanston, as previously detailed by Mr. Swanston’s CDRs. As detailed below, on 06/13/2024, the individual with cell phone number [REDACTED] had over 40 text exchanges with Mr. Swanston (see below screenshot of spreadsheet detailing the calls):

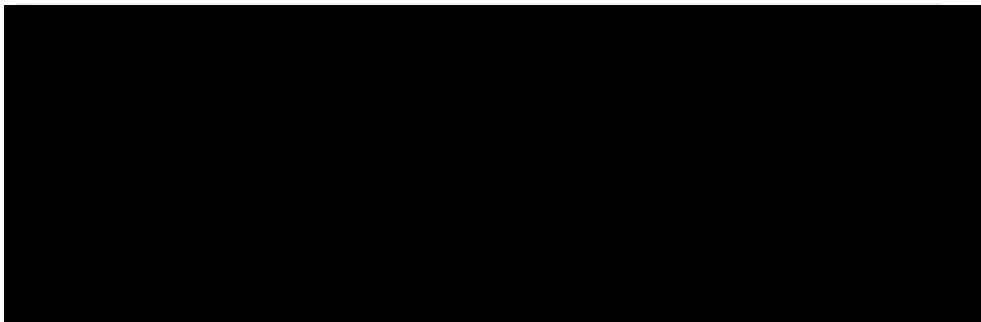

600 I ran the above cell phone number through the HT database and located numerous commercial sex ads for an  
601 individual identifying as [REDACTED] - see below screenshots of ad and  
602 Cash App payment method):

606 I had my Denver DA HTU investigator colleague, Investigator Adam String, attempt to set up a commercial sex  
607 date with [REDACTED] with his undercover (UC) credentials. In that effort Investigator String and [REDACTED]  
608 exchanged numerous text messages associated with the attempted commercial sex transaction, to include Ms.  
609 [REDACTED] quoting Investigator String prices for various sexual services. As a routine part of online commercial sex  
610 transaction, [REDACTED] required Investigator String provided her with a photo ID (this is a common practice of  
611 commercial sex workers to protect themselves and avoid law enforcement). Investigator String sent [REDACTED]  
612 a picture of his UC Colorado driver's license. [REDACTED] ran a Google search on the address listed on the license  
613 and determined same was not a legitimate address. [REDACTED] subsequently abandoned the transaction and  
614 advised Investigator String of same.

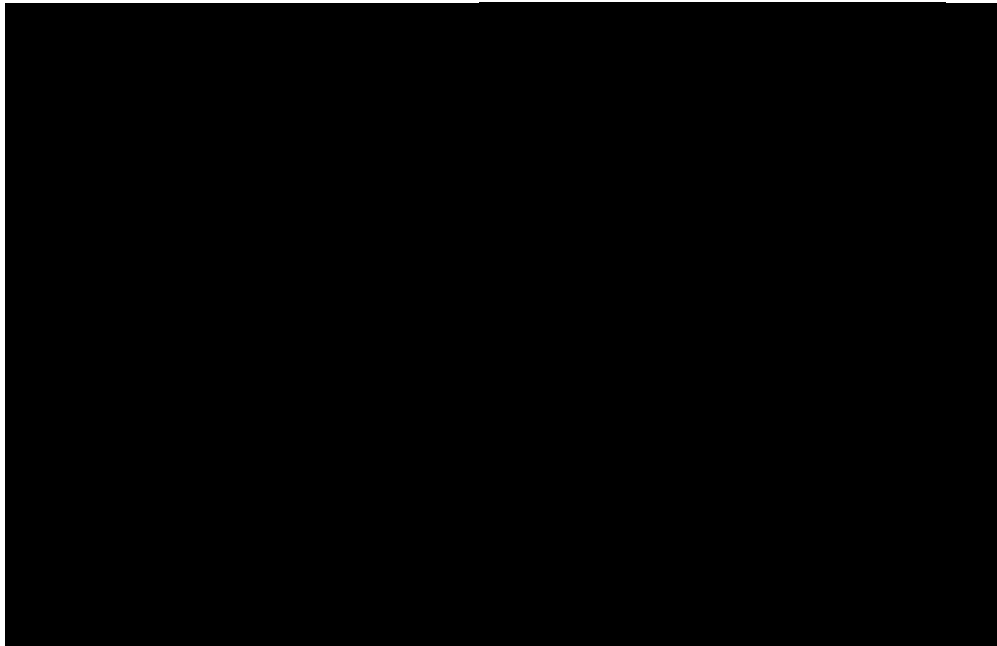
616 After the above failed transaction, I obtained a search warrant for [REDACTED] above Cash App account. Block,  
617 Inc., complied with the warrant and from the data I was able to identify [REDACTED]

622 From there I obtained a search warrant to seize [REDACTED] physical cell phone to collect and preserve the  
623 electronic communications she had with Mr. Swanston. On 09/30/2024, I located [REDACTED] in the evening hours  
624 at her residence in the city of Aurora. [REDACTED] was cooperative but nervous. After explaining the purpose of the  
625 contact [REDACTED] indicated she had specific memory of her exchanges with Mr. Swanston, and she agreed to let  
626 me take screenshots of the text communications she had with Mr. Swanston in exchange for me not seizing her  
627 cell phone. After taking the screenshots I provided [REDACTED] with the search warrant and return.

628  
629 While on scene with [REDACTED] she further explained to me that she used TextNow app, and as such the text  
630 message disappear in sequential order after a period of time (a feature with TextNow app). As such, a few of the  
631 initial text exchanges she had with Mr. Swanston had already disappeared, but [REDACTED] explained that Mr.  
632 Swanston introduced himself to [REDACTED] in the same general manner he introduced himself to the scores of other  
633 commercial sex workers, as discussed earlier in this affidavit.

634  
635 [REDACTED] further explained to me that in the text exchanges she had with Mr. Swanston, she told Mr. Swanston  
636 she had a 16-year-old sister and would need to bring the 16-year-old sister along with her to Los Angeles. Ms.  
637 [REDACTED] explained to me that text message to Mr. Swanston was a false statement (she did not actually have a 16-  
638 year-old sister); she was just playing Mr. Swanston (that exchange was preserved in the text message). However,  
639 Mr. Swanston seemed to buy into the 16-year-old sister idea and responded to [REDACTED], "is she gonna hoe up  
640 for me?" From there they had a series of very terse exchanges with Mr. Swanston ending the conversation by  
641 stating, "You just waste my time you ain't no real hoe because real hoes submit to a Pimp because they submit to  
642 the GAME that been an established since the beginning of time!! Don't hate the players learn the GAME before  
643 you making moves. I didn't write the scriptures I read that mf and live by them!" Below are the screenshots of  
644 the two discussed exchanges as preserved on [REDACTED] communication are in blue  
645 bubble).

648  
649 [REDACTED] is the second listed victim in this case. Date of offense commenced 06/13/2024 when Mr. Swanston  
650 initiated contact with [REDACTED] via text message and ended on 06/13/2024 with Mr. Swanston's final message.

Part V Summation/Conclusion<sup>12</sup>

Summation

1. In June 2024, an anonymous commercial sex worker in the Denver metro area reported to the Denver DA, “A pimp is harassing myself and my friends. I want you to be aware of him His number. [REDACTED] He's systematically contacting us one by one. Be aware of this individual please.”
2. Through investigation, which included numerous search warrants, that pimp was identified as: Mr. Murlin Swanston (DOB: 10/14/1976), who resides at [REDACTED] Mr. Swanston’s cell phone number was/is [REDACTED]. The cell phone was/is registered to AT&T in Mr. Swanston’s name since 2009.
3. The cell phone number [REDACTED] had been listed as a point of contact on commercial sex ads during the time the cell phone was in Mr. Swanston’s name.
4. Mr. Swanston used that cell number to contact thousands of commercial sex workers via text messages throughout the United States to recruit them to work for him in a pimp/commercial sex worker relationship. The electronic trails of the text messages are preserved and part of the case file. Through this investigation I identified and interviewed three such commercial sex workers. Two of those commercials sex workers [REDACTED] at the time of offense (06/13-15/2024) had a direct nexus to the City and County of Denver. Mr. Swanston’s communications with [REDACTED] [REDACTED] (along with the third commercial sex worker in Oklahoma) are preserved and part of the casefile. All three commercial sex workers were interviewed and confirmed the attempted pimping on the part of Mr. Swanston. Through the investigation [REDACTED] was determined to be the anonymous reporting party.
5. Mr. Swanston operated the Instagram account royaltykingsdesigns. The Instagram account was, and still is at the time of this affidavit, filled with direct and indirect references to commercial sex work, specifically pimping and Mr. Swanston’s role as a pimp. Mr. Swanston used the account, via person-to-person communications (messenger), to contact thousands of suspected commercial sex workers throughout the United States in an effort to recruit them to work for him in a pimp/commercial sex worker relationship. Those communications are preserved and part of this case file. Mr. Swanston also had communications with a suspected relative/pimp in which Mr. Swanston detailed his history as a pimp and had requested his relative/pimp provide him (Mr. Swanston) with commercial sex workers so Mr. Swanston could pimp the workers. Mr. Swanston added that he had done the same in the past for the relative/pimp and wanted the relative/pimp to reciprocate. Mr. Swanston’s relative/pimp responded that he was retired from pimping and told Mr. Swanston he (Mr. Swanston) was “a walking indictment” regarding all the online recruiting activity.
6. Mr. Swanston operates a Google account with the email royaltykingdesigns@gmail.com. Within that account Mr. Swanston maintained a diary/blog of his pimping history that is over 100 pages in a Microsoft Word document. That diary/blog is preserved and part of the case file, along with all the content in the Google account.
7. The totality of all the data within the Google, Instagram and AT&T cell phone accounts indicated that Mr. Swanston was the sole operator of all three accounts.
8. Mr. Swanston had an arrest for supervising prostitution in 2005.

695 9. On Sunday, 10/13/2024, screenshots were provided to me of communications from Mr. Swanston's cell  
696 phone to a yet to be identified commercial sex worker. That yet to be identified commercial sex worker  
697 posted those communications on Facebook on a private group chat for commercial sex workers. The  
698 communications by Mr. Swanston, to the yet to be identified commercial sex worker, was initiated by Mr.  
699 Swanston on 10/12/2024. The screenshots were provided to me by one of the commercial sex workers  
700 interviewed in this case, who is a member of the private chat group. Hence, the evidence indicated that  
701 Mr. Swanston is still actively recruiting commercial sex workers at the time I was drafting this affidavit.  
702

### 703 **Conclusion**

704  
705 Based upon all the above I pray the Honorable Court finds probable cause to believe that Mr. Swanston has  
706 committed two counts of attempted Pimping - C.R.S. §18-7-206 (F4), (one for each victim, [REDACTED]  
707 and [REDACTED]) that occurred on 06/13/2024 through to 06/15/2024, with a direct nexus to the City of  
708 Denver, State of Colorado. Further, I pray the Honorable Court grants the requested for the At Large Arrest  
709 Warrant for Mr. Swanston.  
710

711 I state under penalty of perjury that the foregoing is true and correct to the best my knowledge and belief, and that  
712 this declaration was executed on the date listed below.
