

On March 30, 2004, Denver Police Officer Jode Sprague, 95052, received a call to on a report of a Burglary/Sexual Assault. Upon arrival, Officer Sprague made contact with and the following account of events was reported.						
On March 30, 2004, left work early due to a migraine headache and subsequently went to her residence, which is located at took all of her clothes off and put on a robe then fell asleep within her bedroom, but was later awoken at 5:58 p.m., by the sound of her dog aggressively barking. It was at this point that noticed the suspect within her bedroom that was dressed all in black, including a black mask over his face and a pair of black gloves further noticed that this suspect had a pair of handcuffs attached to his belt area and was also armed with a small silver barreled handgun, that was mostly black in color.						
Alarmed at the suspects presence, told the suspect to leave and offered her television and other possessions in exchange for his departure. The suspect declined her offer and stated he was staying as he pulled the bedcovers off						



On April 1, 2004, Detective Parisi sent a Lab Request to the DPD Crime Lab, requesting that the sexual assault examination kit be analyzed for the presence of semen. The request also included the suction cup, which contained an unknown fluid. Testing was also requested for the bathrobe that
On April 7, 2004, Detective Parisi received the Crime Lab results of victim sexual assault examination, as well as the analysis that was conducted on the unknown fluid within the suction cup and recovered bathrobe. According to (now deceased) Forensic Scientist Ted Davelis, semen and spermatozoa were detected on victim vaginal swabs and vaginal smear slides, respectively. Blood and semen were also present within the recovered suction cup and on victim bathrobe. The Crime Lab report indicates a DNA extraction and analysis would be conducted on the semen stains for submission to CBI and entry into the national CODIS database to determine if a match exists.
The DNA profile that was extracted from the above-mentioned evidence, was uploaded into the CODIS database. There was no match identified.
On May 18, 2004, this case was carried as Inactive, not cleared.
On October 18, 2006, Cold Case Detective Barb Wimer, badge no 96004, reviewed this case.
The case was accepted for ring as a John Doe case, with the specific DNA profile of the suspect listed as the named defendant. The case was assigned case number 06 CR 6594.
On Friday, March 18, 2022, Your Affiant, Detective Smith was assigned this case for a follow-up investigation. Detective Smith met with members of the DPD Crime Lab on Monday March 21, 2022, at 10:00 a.m., to be breifed on the current status of this case.
The case remained unsolved from 2004 until 2022 when Jason Groshart, dob: 10/17/1972, was identified as a possible suspect using forensic genetic genealogy techniques.
On Thursday, March 24, 2022, at 1:20 p.m., Your Affiant spoke with victim on the phone. said she would respond to DPD Headquarters on Monday, March 28, 2022, at 11:00 a.m. for a video recorded interview.
Your Affiant learned that Jason Groshart, dob: 10/17/1972, was arrested by Adams County on October 7, 2007, for carrying a concealed weapon. Your Affiant sent Adams County Records a request asking for the book-in photo from that arrest.
On Monday, March 28, 2022, at 11:00 a.m., arrived at DPD Headquarters. At 11:10 a.m., Your Affiant began a video recorded interview with a Your Affiant presented a book-in photo dated October 7, 2007, of the suspect, Jason Groshart, dob: 10/17/1972 to indicated she did not know that person, and she was certain she never had consensual

sex with that person. also said she has never known anyone named Jason Groshart.						
On September 24, 2022, three surreptitious DNA samples were collected from Jason Groshart, dob: 10/17/1972. The samples were placed into the DPD Property Bureau. Those samples were submitted to the Denver Crime Lab for DNA analysis.						
On September 27, 2022, Forensic Scientist Eric Duvall advised Your Affiant that the DNA profile developed from the surreptitious collection, belonging to Jason Groshart, matches the DNA profile which was developed from evidence collected from this sexual assault investigation.						
Your Affiant is requesting that this arrest warrant for Jason Groshart, dob: 10/17/1972, be approved and issued, so that this investigation can continue.						
Based on the foregoing, your affiant respectfully requests that an At Large Warrant be issued for the arrest of Jason Keith Groshart, DOB: 10/17/1972 for: FIRST DEGREE BURGLARY, in violation of 18-4-202(1) CRIME OF VIOLENCE, in violation of 18-1.3-406(2)(a)(I)(A) SEXUAL ASSAULT, in violation of 18-3-402(1)(a),(5) SECOND DEGREE KIDNAPPING, in violation of 18-3-302(1),(3)
