I, Detective Michael James 08047, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

On 11/13/2023, the Denver Police Department's Human Trafficking Unit (HTU) received a tip of a potential human sex trafficking situation occurring in Denver. The tip related that [REDACTED] [REDACTED] is being drugged and held against her will by her sex trafficker, identified as Stefon Flowers, DOB 06/21/1986, and [REDACTED] [REDACTED]. The complainant further provided information that [REDACTED] [REDACTED].

On 11/13/2023, your Affiant conducted a search of [REDACTED] through Denver Police Department's Record Management System (RMS). Your Affiant located an entity listed in RMS for [REDACTED] [REDACTED]. Your Affiant was able to conduct a search through Department of Motor Vehicles (DMV) database and obtain [REDACTED]'s Colorado Driver's License and dossier photo.

Through RMS, your Affiant observed that between the dates of 10/21/2023 – 11/11/2023, Denver Police Department patrol officers responded to numerous calls for service regarding [REDACTED] located within the City and County of Denver, State of Colorado. Through reviewing Denver Officer's reports, your Affiant was able to determine that [REDACTED] provided information to officer's that she was living with her children at [REDACTED] [REDACTED] was found to be living at the apartment with [REDACTED] Stefon Flowers, DOB 06/21/1986. Through reviewing the reports, your Affiant found that [REDACTED] reportedly felt harassed and scared of Flowers.

On 11/13/2023, your Affiant conducted a search of RMS/DMV records for Stefon Flowers, DOB 06/21/1986. Your Affiant located Flowers Colorado Driver's License record and dossier photo and recent webmug arrest photo.

On 11/13/2023, your Affiant utilized [REDACTED] Colorado Driver's License dossier photo to conduct a search through an escort advertisement aggregation system to locate any escort advertisements posted for [REDACTED]. Your Affiant was able to locate multiple escort advertisements, utilizing multiple photos later confirmed to be [REDACTED]. The escort advertisements utilizing [REDACTED] photos were posted in Denver on commercial escort prostitution website Mega Personals beginning on 09/10/2023 through 11/11/2023. Your Affiant observed that numerous posting telephone numbers were listed in the escort advertisements associated with [REDACTED] between 09/10/2023 through 11/11/2023. Your Affiant found that many of the posting telephone numbers utilized in [REDACTED] escort advertisements were shared in escort advertisements posted of other potential female victims. One of the shared posting telephone numbers was also utilized in an escort advertisement depicting photos of a male party, later identified by [REDACTED] to be photos of Flowers.

Through the search of the escort aggregation system, your Affiant was able to locate an associated post for a female victim posting under the name [REDACTED]. Your Affiant was able to identify [REDACTED] as [REDACTED]. Your Affiant found that [REDACTED] had an active warrant for her arrest in NCIC/CCIC.

Your Affiant knows through training and experience that [REDACTED] escort advertisement posts are consistent with a service provider offering prostitution services. Your Affiant observed that [REDACTED] and the other females sharing [REDACTED] escort advertisement posting telephone numbers, utilized common escort acronyms of sexual acts provided such as bj (escort acronym for blow job, which means oral sex), bbbj (escort acronym for bareback blow job, meaning oral sex without a condom), and that the escort advertisements openly referenced "Head" (term meaning oral sex), "clean tight pussy and asshole," and anal, fetishes, best bj you ever had." Your Affiant knows through training and experience that a sex trafficker/pimp involved in the human sex trafficking of victims will utilize a phone number to post multiple victims working under their control.

During the course of the investigation, your Affiant was able to conduct multiple interviews with [REDACTED]. During your Affiant's Interviews with [REDACTED] she confirmed the following facts as they relate to C.R.S. 18-3-504 (1)(a) Human Trafficking for Sexual Servitude, and C.R.S. 18-7-206 Pimping:

[REDACTED] related that prior to meeting Flowers, she worked for [REDACTED] in Colorado Springs, CO. [REDACTED] related that a co-worker introduced her to Flowers sister, identified as [REDACTED]. While hanging out with [REDACTED] near the end of September 2023, [REDACTED] expressed how she was tired of working the regular nine to five work life and would like to make more money. [REDACTED] to her brother, Stefon Flowers, after relating that Flowers could help her make a thousand dollars in one night. [REDACTED] spoke with Flowers and [REDACTED] over the phone, and they told [REDACTED] that she could make more money if she were in Denver. [REDACTED], Flowers, and a female only known to [REDACTED] drove from Denver to Colorado Springs to pick [REDACTED] and her three children up. [REDACTED] and her three children were transported back to Denver to live at [REDACTED] and Flowers residence at [REDACTED]. During the drive to Denver, [REDACTED] and Flowers demanded [REDACTED] give her cell phone and cell phone password to them. [REDACTED] complied, but immediately felt that she had made a mistake by meeting Flowers and [REDACTED]. Flower identified himself to [REDACTED] as a manager and elaborated by relating that he manages women. [REDACTED] related that Flowers told her at first that she would be doing escort work, which [REDACTED]

thought was going on dates. [REDACTED] related that she made it very clear to Flowers that she would not be providing sex work. [REDACTED] related that when she arrived in Denver it was the complete opposite. [REDACTED] related that Flowers would scream at her and threaten to hit her. [REDACTED] related that Flowers threatened her by saying that if she didn't make him his money it won't be good for her and her kids. [REDACTED] related that he would make that threat multiple times. [REDACTED] related that she only complied for her safety and the safety of her kids. [REDACTED] related that Flowers would not allow her to leave due to fear that she would tell on him. [REDACTED] related when she first got to Denver, it was like a full blown prostitution ring in that there were multiple females in the apartment. [REDACTED] related that once in Denver and after figuring out what Flowers wanted her doing, she went to her room to order an Uber to return home to Colorado Springs. [REDACTED] related that Flowers came into the room and told her that once she was there she could not leave. [REDACTED] related that he continued to tell her that he should have made that clear, but she could not leave.

[REDACTED] identified Flowers as her "pimp" in this prostitution ring and [REDACTED] as the "madam." [REDACTED] confirmed that she had never met [REDACTED] or Flowers prior to being introduced to them in September 2023. [REDACTED] confirmed that she had never worked as a prostitution escort prior to meeting Flowers and [REDACTED] related the only drug she ever used prior to meeting Flowers and [REDACTED] was marijuana. [REDACTED] related that Flowers and [REDACTED] were in control of posting escort advertisements and all communication with customers. [REDACTED] related that Flowers and [REDACTED] would post escort advertisements utilizing Flowers cell phone with a contact number of [REDACTED] but related that Flowers also had a second cell phone he would utilize with a number [REDACTED]. [REDACTED] further related that Flowers utilized Text Free apps on his phone to communicate with customers. Flowers had [REDACTED] text her photos of herself to be used in escort advertisements to his cell phones. Using his cell phones, Flowers arranged incall and outcall escort prostitution appointments for [REDACTED]. Flowers [REDACTED] would transport [REDACTED] to the customers location for outcall utilizing [REDACTED] Jeep Grand Cherokee. For incall, customers would park on the street in front of [REDACTED]. Flowers would advise [REDACTED] when customers would arrive for incall and [REDACTED] would respond to the customers car to conduct prostitution. Flowers would wait in the vehicle while [REDACTED] conducted outcall service. Flowers would remain on his balcony with a gun during incall service. [REDACTED] related that Flowers would wait to prevent [REDACTED] escape if she decided to escape. [REDACTED] related that she knew Flowers had been to prison but was unsure why. [REDACTED] [REDACTED] related that Flowers bragged that he had shot his sons with the shotgun. Flowers would tell [REDACTED] that he shot his own sons, so what makes her think that he wouldn't shoot a bitch. By telling [REDACTED] this, she felt Flowers was crazy. [REDACTED] related that her and her children lived full time at [REDACTED], and that she was not allowed to leave without Flowers or [REDACTED] related that she had tried to leave before and explained on one occasion that she tried to take her children to a hotel. [REDACTED] related that she didn't make it out of the parking lot before Flowers caught up to her and dragged her back inside the apartment. [REDACTED] related that she had told Flowers a few times that she and her children were going to leave due to not feeling safe around him. [REDACTED] related that after the first incident where she tried to leave, Flowers was paranoid that she would report him. [REDACTED] related that Flowers is the person that would abuse her, but [REDACTED] condoned a lot of it. [REDACTED] would scream at her and pull her hair as a punishment. Flowers blocked personal contacts in [REDACTED] cell phone so that she was unable to contact them. Flowers further related that due to having access to her phone, he could see all the texts and calls she made. This made [REDACTED] hesitant to reach out to people that could help her.

█████ provided her escort prostitution rates as \$300 for one hour, \$250 for a half hour, \$160 for a quick visit. █████ confirmed that sex would be provided to the customer during the hour and half hour appointments. █████ related that oral sex would be provided to the customer during the quick visits. █████ would typically be forced by Flowers to work seven days a week from 8pm until 6am and see approximately thirty to forty customers in one night. Flowers would hold a gun to █████ head and force her to take large quantities of ecstasy in pill form or powdered molly to keep her up all night. It was common for █████ to be awake for two or three days at a time. █████ would work until Flowers told her she could stop. █████ related that she initially had arranged with Flowers to provide him with fifty percent of the money she procured from prostitution. However, due to █████ being kept high on drugs that made it difficult for her to keep track of the money. In addition, Flowers and █████ would have her consistently make many purchases with the money she earned. Given this, she provided Flowers and █████ with nearly all the money she procured from prostitution. █████ was provided a cell phone by Flowers with the phone number (██████████). Flowers had access to the phone he provided her and access to all of █████ financial applications, such as Cashapp and Venmo. Flowers had access to █████ cell phone, as well as her Cashapp application that were on her cell phone. █████ related customers paid for prostitution services in cash and by transferring money to █████ Cashapp account tag \$██████████. █████ related that she created the Cashapp account prior to meeting Flowers but utilized her Cashapp account primarily to handle electronic transfers of money made from prostitution during the time she was working under Flowers. █████ related that once she received money from the customer for acts of prostitution, Flowers, having the password to █████ phone, would log into her phone and transfer the money himself to his Cashapp account. █████ knows that Flowers and █████ sole income is derived from money earned from prostitution by █████ and a female known to █████ by the name █████. █████ related that █████ escaped from Flowers and █████ residence after consistently being abused by Flowers early on when █████ first arrived at their residence. Due to █████ related that she made most of the money for Flowers and █████.

On 11/21/2023, your Affiant conducted a search of Colorado Department of Labor and Employment for Flowers and █████ Employment and Wage history. Your Affiant found that Flowers and █████ had no reported source of legitimate income during the period of September 2023 through November of 2023 when this sex trafficking incident involving █████ reported to have occurred.

On 11/29/2023, your Affiant drafted/authored search warrants and affidavits in support of a search warrants for █████ Cashapp Account █████. The search warrants were reviewed/approved by the Honorable Judge Robbins.

On 12/13/2023, During a search of NCIC/CCIC for █████ your Affiant observed that █████ Denver arrest warrant was removed from NCIC/CCIC. Your Affiant conducted an inmate search through the Denver Jail Database and found that █████ currently in custody at the DDC. Your Affiant responded to the DDC where he was able to contact █████ agreed to provide an interview.

█████ related that she first met Stefon Flowers in approximately mid November of 2023. █████ related that she remembers that it was after her birthday █████ related that she was homeless, living in stolen cars near a truck stop, when Stefon Flowers approached her. █████ related that she exchanged phone numbers with Flowers, and that he kept hitting her up on her cell phone. █████

related that shortly after she met Flowers, he transported her to his apartment at [REDACTED] where she lived. [REDACTED] related that she loved [REDACTED] children, so she didn't want to leave. [REDACTED] related that she was approached by [REDACTED] while Stefon wasn't home. [REDACTED] how Flowers doesn't go anywhere all day but makes his money from girls selling pussy for him. [REDACTED] related that she didn't really expect [REDACTED] to tell her this, but apparently Flowers assaults [REDACTED] as well. [REDACTED] related that she observed Flowers physically abuse [REDACTED], but he has never put his hands of [REDACTED] thought that Flowers didn't abuse her due to her light skin and thinking that maybe Flowers liked her. [REDACTED] related that Flowers was worried about being caught and that bruises would show up easier on her light skin. [REDACTED] related that she never had an intimate relationship with Flowers. [REDACTED] related that she wouldn't do that due to knowing [REDACTED] is his wife. [REDACTED] related that she has never worked in prostitution before meeting Flowers. [REDACTED] related that even with everything in her life, she had standards and didn't think she would ever work as a prostitute until Flowers. [REDACTED] related that she only worked as a prostitute under Flowers on two occasions. [REDACTED] related that the first time she was transported to a hotel in Denver. [REDACTED] related the second occasion was a car date on the street in front of Flowers apartment, confirmed as [REDACTED] related that on both occasions, she only provided the customer with head (oral sex) due to being on her menstrual cycle. [REDACTED] related this all happened in a short period of time. [REDACTED] related that she stopped doing calls for Flowers due to her expressing to Flowers that she didn't want to be set up with a white man, and then Flowers arranging for her to meet with a white man anyways. [REDACTED] related that after that she mostly boosted (stole) stuff for Flowers. She related that she boosted stuff so that she wouldn't have to take calls. [REDACTED] related that as long as she was boosting for them they weren't mad, but she noticed that [REDACTED] and another girl, identified as [REDACTED], were still working for Flowers. [REDACTED] related that Diamond was only there for the first three days she was with them. [REDACTED] related that Flowers arranged the appointments with the customers by phone. [REDACTED] related that Flowers posted her pictures on Megapersonals. [REDACTED] related that when the customers would text his phone, he would respond to the customer as the female the customer was trying to reach. [REDACTED] related that they had no access to the account, and that Flowers would post all the pictures and tell them where they had to go. [REDACTED] related that if she expressed that she didn't want to do prostitution, for example if the customer was a white male, that Flowers would make her feel bad by telling her that she was a stupid bitch or that she was dumb, but he never assaulted her. [REDACTED] related that he would tell her that to coerce her into it. [REDACTED] related that customers were not allowed to come into the house. [REDACTED] related that she knew car dates in front of the apartment on Albion to be outcalls. [REDACTED] related that she arranged to provide half of the earning she procured from prostitution to Flowers. [REDACTED] related that she saw a message that Flowers posted in which a quick visit was listed as costing approximately \$120, which would include her providing oral sex. [REDACTED] related that she had no say in the rates Flowers charged. White related that she made \$140 from the first customer, and \$120 from the second customer. Both customers paid with cash. [REDACTED] related that she provided oral sex to both customer and that there was no protection used. [REDACTED] related she made approximately \$140 the entire time she provided prostitution excluding the half she paid to Flowers, which [REDACTED] stated was approximately \$130. White related that She had no part in setting up the escort advertisements. [REDACTED] related that Flowers had her shop lifting items for him too. White related that Flowers would enter a store and fill up a shopping cart with items he wanted. [REDACTED] related that Flowers would then let her know and he would exit the store. [REDACTED] would then enter the store and steal the items for Flowers. [REDACTED] related that she only knew of [REDACTED] herself, and a female named [REDACTED] who she had never met, as females that have worked under Flowers. [REDACTED] related that she does not know Flowers to have a job, and this is a one man operation. When asked what Flowers got from this, [REDACTED] related

"money" from the girls. During the interview, your Affiant showed a photo (Photo was only of Flowers Colorado Drivers License dossier photo with no information identifying him) to [REDACTED] for identification. [REDACTED] was advised that she may or may not know the party in the photo. Once [REDACTED] observed the photo, she was able to identify Flowers from the dossier photo.

Your Affiant observed from reviewing [REDACTED] Peer to Peer Payment History that [REDACTED] received large payment from numerous male parties between 10/14/2023 through 11/10/2023. The payment amounts were observed to be consistent with the price list [REDACTED] provided your Affiant as the prices she charged her customers to conduct acts of prostitution. [REDACTED] previously related she primarily used her Cashapp account after meeting Flowers for the purpose of accepting electronic payments from customers for commercial sex acts. Your Affiant found the large payments to [REDACTED] Cashapp account to be consistent with customers providing electronic payment for prostitution services to [REDACTED]. Between 10/14/2023 through 11/10/2023, [REDACTED] received payment electronically to her Cashapp account from multiple male parties in the total amount of approximately \$5,140. Following many of the electronic payments that [REDACTED] would then transfer payments electronically to a party listed in her Cashapp account by the recipient display name of "I'm Poor." Your Affiant knows [REDACTED] payment activity to "I'm Poor" to be consistent with an escort prostitution service provider transferring money procured from prostitution service to her sex trafficker/pimp. [REDACTED] electronically paid recipient "I'm Poor," approximately \$3,530.

Through reviewing the Cashapp sender/receiver account file, located within the [REDACTED] account file return, your Affiant found that "I'm Poor" is a Cashapp Display Name for the verified Cashapp account Sineedcss, which is registered to Stefon Flowers, DOB 06/21/1986.

Your Affiant respectfully requests that an arrest warrant be issued for Stefon Flowers, Date of Birth: 06/21/1986, Black male, 6'04", 275 pounds, black hair and brown eyes [REDACTED] for;


